## FORENSIC LAND AUDIT

## Motion

## (Resumed Debate)

**MR SPEAKER:** Order! Honourable Members the debate on this Motion is resuming. When the House adjourned on Friday 21<sup>st</sup> November, 2025, Honourable Letlhogonolo Barongwang was on the floor presenting. He was left with a minute and 33 seconds. Honourable Barongwang, please conclude your debate. Honourable Mathoothe *ke ene* Acting Minister.

**MR BARONGWANG (MOGODITSHANE EAST):** Mma ke go dumedise Motsamaisa Dipuisanyo tsa Palamente. Tota nakonyana e e setseng ga se ya sepe fela, gongwe ke *to summarise* se ke neng ke se bua maloba. Ke kopa gore Ntlo e e nkeme nokeng mo go kopeng gore go dirwe *a forensic audit* e dirwa mo kabong lefatsheng la Mogoditshane. Mo go tlaa batlisisang gore tota dingongora tse di leng teng tse dintsi tse di kwa Mogoditshane di tlaa nna le boammaaruri, e bile *they will quantify* gore fa gotwe go nnile le tshenyetso-setshaba, re raya tshenyetso-setshaba ya bokete jo bo kana ka eng. Fa re re lefatshe ga le yo, re raya lefatshe tota le le mo go bomang, ba tshotse lefatshe le le kana ka eng. Fa re re ngwana wa Mogoditshane ga a na lefatshe, mme Mogoditshane o setse a pitlane ga gona kwa a golelang teng, re a bo re buisiwa ke gore lefatshe le ile kwa kae, mo go bo mang.

Motho a tswale ka gore, kana go na le bangwe ba gotweng ba a akarediwa mo teng, e tlaa ba fa sebaka sa gore ba itlhatswe maina. Ka a le kalo Mtsamaisa Dipuisanyo tsa Palamente, *I therefore move that this Honourable House requests Government to consider instituting a Forensic Land Audit in Mogoditshane covering all land allocation in the past 15 years covering land board*

*officials and employees; Councillors, Members of Parliament and Tribal Administration Senior staff. I so move, thank you.*

**MR SPEAKER:** Order! Honourable Members, the floor is open. Honourable Mathoothe, Honourable Assistant Minister of Entrepreneurship.

**ACTING MINISTER OF LANDS AND AGRICULTURE (MR MATHOOTHE):** *Mr Speaker, ke emetse Minister Dikoloti. Jaanong e ne e le gore ke fe response before they can start to debate, fa o ntetla Mr Speaker.*

**MR SPEAKER:** Tswelela.

**MR MATHOOTHE:** Mr Speaker, let me start by confirming that the Mogoditshane Sub-Land Board area jurisdiction land allocation has been a source of pain and frustration in the land administration space for a while. This August House will recall the infamous Kgabo Commission of the year 1991 which culminated in the Government Paper No.1 of 1992 on land problems in Mogoditshane and other peri-urban villages. The commission's mandate was to review the extent of illegal and other unauthorised allocations in Mogoditshane and other peri-urban areas. The commission unearthed illegal and corrupt practices in the land transitions. Fast forward to the year 2021, about 38 employees of the sub-land board were dismissed from their employ on account of fraudulent dealings and inside trading, an indication that the historical problem has not been addressed. There may have been a change in the boards and officers, but the real problem has not gone away.

Following the Kgabo Commission, efforts were made to address the mal-administration and related corruption. In part, the underlying problems resulted in the formation of Directorate on Corruption and Economic Crime (DCEC) and Directorate on Intelligence and Security (DIS). The Land Tribunal is among those institutions that are seized with fighting this malice, and providing platforms from the recourse.

The data management has been a key issue in looking for solutions, hence the advent of a programme on the construction of records centres has resulted in Mogoditshane being prioritised. Furthermore, the Kweneng Land Board has two posts of Deputy Land Board Secretary. This is intended to assist with dealing with the problem. Mr Speaker, the efforts as I have outlined were meant to address the land administration and governance issues in Mogoditshane. However, its

allocation problems continue to persist, our ministry has received representations from individuals and groups registering complaints against the land board.

Allegations on involvement of the mentioned parties in this Motion do exist. Internal audits have revealed issues of plots with no evidence of allocations. Double allocations and abandoned plots or those that remained undeveloped for many years as well as encroachments. I therefore support this Motion as the Minister responsible for Lands. More than 30 years, post the Presidential Commission of Enquiry into land board problems in Mogoditshane and other peri-urban villages, a need for independent objective examination of land transitions in Mogoditshane cannot be overemphasised. Mr Speaker, I support this Motion with full understanding that the ongoing forensic audit commissioned by the President of the Republic of Botswana Advocate Duma Gideon Boko has covered some land boards including Kweneng, under which Mogoditshane falls.

However, this audit covers a period of 10 years, while the Motion calls for a period of 15 years and it is specific in its terms and reference. Mr Speaker, a forensic audit dating back 15 years will take the audit to the year 2010, covering at least five tenures of the past land board officials, three political terms. It is my considered view that whatever happened and who overdid it and how it happened and whether it was illegal will be unearthed by the forensic audit. The audit is expected to further address the impact or lack thereof, the land administration reforms instituted in an effort to address these challenges. I rest my case. Thank you Mr Speaker.

**MR HIKUAMA (MAUN WEST):** Ke a leboga Honourable Speaker. Ke a leboga Honourable Barongwang, matshwenyego a gago a a utlwala. E bile ke ema jaana ke ema nokeng Tshutiso e o e beileng Ntlo e pele. Fa re dumalana, ke ne ke ka dumalana le se se buiwang ke Tona, gore e ka atolosiwa mo motseng le *land boards* tse di farafarilweng ke tshenyoka kana ke matswakabele a kabo ditsha. Tawana Land Board e le mo teng. Fa re ka tsenya tsone tseo, tse dingwe tse re boneng go nna le tlhakatlhakano, go nna le kabo ya ditsha fa gongwe di abiwa ga *four*. O bona setsha se le sengwe fela, se abiwa ga *four* ke *land board*. Dilo tse ke diemo tse di supang gore go ne go na le sengwe se se sa tsamayeng sentle.

Ga re ka ke ra bona ka go abelela, re ka bona mo go siameng le mo go tseneletseng fa re ka nna le tlhodumelo e e tseneletseng ya bo maitseanape. Yone e o e bitsang

*Forensic Land Audit.* Gongwe fa e ka nna teng, mme ra e atolosa ra se ka ra e kganelela fa Mogoditshane Land Board e le nosi ka gore dithoto tsa lefatshe la Botswana di senyegile mo lefatsheng ka bophara. Gongwe fa re ka bo re dumalana re bo re nna le Tshutiso ya gore re se ka ra itebaganya le Mogoditshane Sub-Land Board fela, re nopole dingwe tse re bonang gongwe go ne go na le matswakabele a mantsi mo go abiweng ga ditsha mo mafelong ao.

Maun a sa tlogelwe kwa ntle, ba bangwe ba tlaa supa gore tse dingwe tse bone ba di bonang go ne go na le tshenyoka kana e ba e belaelang e ne e le tshenyoka. Kana re santse re belaela, gongwe fa go ka nna le tshekatsheko e e tseletseng eo, e ka tla ya re tswela ka boammaaruri le bosupi jwa gore a mme e nnile teng kana e ne e le go tlhoka kebelelo fela go sena sepe se se maswe se se diragatseng. Dilo tse tsotlhe di tshwanetse gore di senoge. *Mr Speaker*, kgang e re e beilweng pele ke *Honourable Barongwang* wa Mogoditshane, e tshwentse setšhaba sotlhe sa lefatshe la Botswana. Kana e amile batho ka bokete, bangwe ba ne ba amogiwa ditsabone, bangwe ba latlhegelwa ke lefatshe, bangwe ba latlhegelwa ke madi tota. Ba ne ba leka gore ba tlhabolola fa ba tlhabolotseng teng, go felela e le gore fa ba tlhabolola jaana, jaaka ke setse ke buile go abetswe ba sele, ba bo ba tla ba latlhegelwa ke ditsompelo le matshelo a bone. Ka mantswe a a kalo fela ke sa batle go ya kgakala le yone, ke ema nokeng Tshutiso e, mme kopo ya me ke gore a re e bue ka maikaelelo a go atolosa *scope* sa yone e se ka ya felela fa Mogoditshane fela a le nosi.

Ga ke batle go tsaya nako e ntsi *Mr Speaker*, ka gore ke kgang e e tlhamaletseng, le Tona o a dumalana le yone gore e tshwanetse e dirwe, mme se ke se kopang fa re ntse re lebelela gore re tlaa bona gore a mme re ka se ke re fetole, mogopolo fa re tsamaya mo tseleng gore o akaretse mafelo mangwe a re belaelang go ne ga nna le kabo ditsha e e matswakabele e e sa tlhologanyesegeng sentle. Ka mafoko a a kalo, ke *support* mogopolo wa ga Rre Barongwang. Ke a leboga *Mr Speaker*.

**MINISTER OF WATER AND HUMAN SETTLEMENT (MR RAMOGAPI):** Ke a go leboga *Mr Speaker*. Mma ke tseye sebaka se ke amogele, ke boe gape ke *support* mogopolo o o fa, o o tsisitsweng ke mokalengwe Rraetsho Barongwang. Mogopolo o *Mr Speaker*, o tsile ka nako e e siameng. Re tshwanetse gore re itse selo se le sengwe fela se se tona, fa re buisanya ka mogopolo o, gore lefatshe ga le gole, mme *population* yone e gola ka tsela e e gagamatsang. Re tshwanetse ra itse ra ba ra gakologelwa ditiragalo tse di neng di ntse

di tlhola di diragala kwa Mogoditshane. Ra ikgakolola gore go kile ga ba ga nna le *reports* tsa bo Englishman Kgabo. *Reports* tse di neng di supa gore lefatshe la Mogoditshane ke mathata. Le fa go ne go ntse jalo, e ne e re fa *reports* tse dingwe di tshwanetse gore di tswe, di bo di nne mo mpepeneng, di bo di thuse setšhaba, batho bangwe ba tlaabo ba dirisa bokete jwa mmele wa bone, ba dirisa ditsompelo tsa bone, ba kgona gore ba re *report* eo e se ka ya ba ya tswa ba itsheka, ba dirisa *technicalities* gore *report* eo gongwe e bile ga e a ka ya re *commission* eo e tshwanetse ke gore e ikanisiwe, e bo e sa ikanisiwe. Gone moo fela go bo go dira gore *reports* dingwe di felele mo phefong. Ke ka moo ke reng *Motion* o fa o ka tswa, wa diriwa sentle o tlaa re thusa madubadube a Mogoditshane. O a gakologelwa *Mr Speaker* gore batho ba Mogoditshane ba kile ba bo ba thubelwa ka sengwe sebaka. Ke gakologelwa Tautona wa pele e le gore batho ba Mogoditshane ga ba molato, bone jaanong ba setse ba fela pelo ba ipha lefatshe. Fa ba ipha lefatshe jaana, ke gakologelwa ka lengwe letsatsi, Tona wa pele e ne e le tsala ya me e tona, ke tlaa mmua fela le gompiano ke tsala ya me e tona, go ne gotwe Jacob Nkate, o ne a re, “batho ba Modimo, se ipheng lefatshe,” mme batho ba Mogoditshane ba re, “nnyaa, ga go na sepe se o se buang.”

La bofelo, ke gakologelwa Tautona wa pele gape Rraetsho Mogae, le ene fa a tsena kwa mme ba ne ba mo raya ba re, “Tautona, re tlaa mo katisa fela jaaka re ne ra katisa Nkate.” Ke leka go supa ditso gore dikgang tse ga di tswe fano. Tautona wa pele a tla ka bogale a re, “ke tsile go le kabolola ditshoka batho ba Mogoditshane.” Dikgang tse bagaetsho, re leka go supa gore re a di itse, ga di tswe fano. Le tharabololo ya tsone, ga e motlhofo. Jaaka re itse, go kile ga lekwa go thubela bangwe mme e se gone.

Dikgang tse dingwe tsa Mogoditshane tse di botlhoko tse go kileng ga tliwa ka tsone, le *formulas* fela tse go neng go tsiwa ka tsone, o ne o ipotsa gore a di boammaaruri. Ke gore o fitlhela e le gore gatwe re fe tshimo, fa o re fa tshimo jaana, re tlaa go fa *plots* tse dintsi.

*Land board Chairman* wa pele e kile ya re fa ke mmotsa gore la re le ne le dirile jang, a bo a re kana *land board* e ne e sa bone sepe. E ne e le gore jaanong se se diragalang ke gore gatwe re fe tshimo, fa go sena go nna gotwe re fe tshimo, go tsweng foo, o fiwa *plots* tse dintsi tse di gagamatsang. E bo go raya gore *land board* tota yone fa o re o a lebelela, se se mo tafoleng se e se boneng, ga e a bona sepe, mong wa tshimo ke ene a boneng sengwe le sengwe. Ke tsaya gore dikgang

tse fa di tlhotlhomisiwa sentle di lebelelwa, tsone tsa Mogoditshane tse ke ntseng ke itebagantse le tsone, ke dikgang tse dintsi tse di gakgamatsang.

*Land transfers* tsa Mogoditshane ke mathata a a gakgamatsang. Fa motho a kwadile fela a re ke *transfer plot* e kwa go semangmang, mokwalo o le teng, fa e tsena kwa, e betswa ka bogare gotwe fa e le gore *plot* e e ne e le 1 *hectare*, e betswa ka bogare, yo mongwe a neelwa bontlha bongwe, jo bongwe bo a sala.

Dikgang tsa Mogoditshane Land Board, le a itse gore bošheng jaana le kile la utlwa gotwe go diragetse matlhotlhapelo, mongwe o itseetse botshelo, ga nkake ka mmua ka leina. Ke dikgang tse e leng gore fa re lebelela fela mo Mogoditshane bagaetsho, ke mathata a a seng kana ka sepe. Ga ke ka ke ka tshela metsi mafoko a a builweng ke Motlotlegi Hikuama, ke a a akgola. Jaaka *Minister* a bua, mafelo a a tshwanang le bo Palapye, re mo mathateng. Fa o kare o a lebelela gore DCEC e tlhotlhomisa dikgang tse di kae gone kwa bo Palapye, ke dikgang fela tse dintsi. Bagaetsho, lefatshe le ile. Khumo e tona ya batho ke lefatshe.

E bile jaanong go simolotse kgang e ntšha ya borukutlhi jwa lefatshe. Batho ba lwela lefatshe mo e leng gore *Mr Speaker*, fa yo mongwe a robetse gotwe go na le *dispute* ya lefatshe, bosigo o tsamaisa yo mongwe o a mo kgama, o a mmolaya. Ke dikgang tse mapodise ba di tlhotlhomisang tse go neng go na le *disputes* tsa lefatshe. Metlha ga e sa tlhole e le ya maloba e gotweng ba go akanyetsa ka tsela nngwe gore ba go ntshe mo lefatsheng. Nnyaa, ba tla fela ba go tsietsa ba re motho yole o kare lefatshe le o tlaa le bona, a re mo tloseng. Dikgang tse *Mr Speaker*, di re utlwisa bothoko, a re di lebeleleng re tsenelela kwa pele. Re lebelele dikgang tsa *applications*, batho ba tlola ba bangwe mo *applications* wena o sa bolo go *apply* mme yo mongwe fa a tla maabane jaana wa go tlola.

Bana ba gompiano, ba botlhale mo go maswe. O tlaa bona ngwana a le monnyennyane a re o seka tshimo ya ga rraagwe rraagwemogolo. Ke gore rraagwemogolo le rraagwe ba fetile, ga ba a seka boswa joo. Ngwana wa ngwana wa ngwana ene fa a tla a re boswa jo e bile ke a bo batla, bo ntebagane. O tlaa itshoka fela ngwana wa gompiano a ba a bo bone.

Bagaetsho, re mo mathateng ka dikgang tsa lefatshe. Ke batla gore re di lebelele tsotlhe mme e re fa go ya go lebelelwa, re lebelele dikgang tse re buang ka tsone tsa batho ba ba tloang ba bangwe mo *line*. Dikgang tsa

*transfers* tse e leng gore wena fa o re o kopa *transfer* fa gongwe o itheketse lefatshe, fa o re o a re, o fitlhela yo mongwe a setse a beilwe mo teng. Bagaetsho, dikgang tsa lefatshe ke selelo sa khuranyo ya meno.

Tse dingwe tse o tlaa fitlhela e le gore bangwe gatwe e a bo e le bagolo. Ke gore fa gotwe go na le *dispute* mo kgannyeng go bo gotwe kana kgang ke e e kwa *land board* go na le *dispute*, fa go santse gotwe ke *dispute* kana go a ngangisanwa e bile *land board transfers* lefatshe e le neela yo mongwe. O bo ipotsa gore jaanong e kare kgang e santse e le mo tafoleng e bo e bile *land board* gape e ntse e le yone e bo e fetisa lefatshe e le neela yo mongwe gore motho wa Modimo a swelele a se ka a bona sepe.

Bagaetsho, rona re di bone tsotlhe dikgang tsa lefatshe tse di tlhomolang pelo. Fa gongwe fa o tla o re o ikopela *transfer* o itheketse, o rekile fela sentle o re ke ya go reka *plot* ke e fa mo go letlelelwang ka fa molaong, ba a taboga ba ya kwa go yo mongwe yo o nang le madi ba re se rekisetse Motaosane, rekisetsa Ramogapi, o na le madi go gaisa Motaosane. Go tlaabo go raya gore jaanong Ramogapi ene o a tsena, o phamolela Motaosane se se neng se mo tshwanetse. Dilo tse ke dikgang tse e leng gore di teng, Batswana ba lela ka tsone gore batho betsho re thuseng.

*Honourable Barongwang*, o tsile ka *Motion* o o siameng ka nako e e siameng. Rraetsho, ba rotlhe re a o *support*, re go eme nokeng. Ke tsaya gore le batho ba Mogoditshane ba go reeditse rra gore o a ba bulela ka selelo se ba sa bolong go nna le sone sa kgang ya kabo ditsha. Kgang ya teng ga e fele, e kukela letsatsi le letsatsi. O kare o thiba ka fa, o thibolola ka fa, ke kgang e e leng gore ke mathata. *I therefore, support the Motion* jaaka o ntse *Mr Speaker*. Ba ba o baakanyang ba ka o baakanya.

#### MINISTER OF LABOUR AND HOME AFFAIRS (MAJ. GEN. MOKGWARE):

Ke a leboga *Mr Speaker* and good morning mongwame. Ke dumedise Ntlo e. Mma le nna ke re ke eme fa mo letsatsing le la gompiano ke *support* motlotlegi ka *Motion* o montle o ke bonang a o tsisitse fa mme e bile ke bo ke amogele tse tsotlhe tse di builweng ke *Minister* Dikoloti. Ke bona gore o e beile sentle ka bokgabane tota a bua gore kgang e, e a tshwenya, e ntse jang. Tse tsotlhe tse a di buang tse, re kile ra mmiletsa kwa Kgotleng ya Gabane maloba a go ya go ikutlwela batho tota ba mmolelela matshwenyego a bone le *land board*. Ba ne ba mo supegetsa gore *land board* e ya Mogoditshane ka fa o e bonang e dira ka teng jaana, mongwe le mongwe a ema a re ke selo se se

tswang kgakala. Ke ratile thata ka *period* e a e beileng ya 15 years gore re leke go boela kwa morago kwa, re bone se se diragetse eng, go ne go dira bo mang. Le yone Kgabo Report fa e sena go nna e dirwa jaana, ga ise e salwe morago *fully as it was recommended* ka fa go neng go dumalanwe ka teng. Re bona le bangwe batho ba ba neng ba tseetswe ditsha ba ba neng ba dumela go fa *land board* ditsha tsa teng, mo dingwageng tse, ba buile gape, *they have handed them* la bobedi, ba batla *compensation* la bobedi gape. *Land audit* e ya go ntsha selo se.

Bagaetsho, lefatshe *is an asset* ya any other nation. Lefatshe ga le oketsege, go oketsega batho. Ke sone se o bonang gore, gore o fe motho seriti, ke fa o mo neetse setsha; a ke sa bonno, kgwebo kana sa eng fela. Jaanong re tshwanelwa ke go ema ka dinao mo Ntlong e ra bona gore sone selo se, Motswana mongwe le mongwe o a se akola e le *birth right*. Ke tshwanelo ya Motswana mongwe le mongwe gore a bone setsha gongwe le gongwe kwa a batlang go se bona teng. E bile a se bona a se dirisa ka fa a batlang go se dirisa ka teng *as long as* go le ka fa molaong go tshwanetse gore a se dirise ka tsela e e ntseng jalo.

Jaanong dikgang tsa kwa Mogoditshane Sub-Land Board fela ka botsone fa re ka di nnela fa fatshe, tse dingwe batho ba kwa mabitleng, ba tlhokafetse e le pelo, motho a tselwa setsha kana tshimo go sena ope yo o itseng.

Gompiano jaana re na le *lawyers* tse pedi mo Botswana, fa o ka tsena kwa Mogoditshane Land Board, go busa tsone fela. *Two lawyers*; ba na le *over hundred plots*. Ke bone le bodiredi jwa *land board* ba ba berekang le bone.

*Mr Speaker*, maloba go ne go tsile a *board member* a tsile go nthaya a re, re tlhola re ntse re utlwa o bua ka ditsha kwa, rraetsho, ke batla go go tlhomamisetsa gompiano gore se se diragalang kwa, ke sone se o neng o se bua maloba. Ke gore mokwaledi wa *land board* o kgona go tsaya ditsha fela a re tse ke tse di laolwang ke nna. Jaaka fa o tsamaya ka tsela e o ya Molepolole, *opposite Bokamoso Hospital*, go na le ditsha ka fa, go dirilwe sekonotere teng koo, motho a re tse ke tse di abiwang ke nna fela, lona le le *board* didimalang, a bo a gakgamala *member* a re aa-aa, ke raya gore jaanong go laola mang jaaka re ntse jaana...

**MR LUCAS:** *Clarification.* Ke a leboga.

**MR SPEAKER:** Nnyaa ema pele *Honourable* Lucas. General o ele tlhoko Standing Order 57.6, o se ele

tlhoko thata, *unless there is a substantive Motion*, we cannot discuss the conduct of individual public officers. Ee, *unless* lona le ka sutisa le bo le tlhophha ka *two thirds*, ke gone jaanong le ka buang ka *conduct* ya ba ba seyong fa go ka ipuelela.

**MR LUCAS:** *Clarification.* Ke a leboga *Mr Speaker*. Ke ne ke re kana General Mokgware ke motho yo o itseng dikgang tsa kgaolo ele thata. E kile ya bo e le Mopalamente teng, ke tsaya gore fa gotwe *investigate* 15 years, e tlaabo e le mongwe wa ba ba tlaa bong ba lebilwe, kana baeteledipele ba na le go nna dingalonyana mo dinalanyaneng...

Ke ne ke re e ke neng ke e utlwa e buiwa ke *Honourable* Barongwang...

**MR SPEAKER:** *Honourable* Lucas, you are imputing, contrary to Standing Order 57.5.

**MR LUCAS:** *I withdraw* yone eo. Tota ke ne ke re ke tsena mo go e ya “mphela ngwana.” Ke re ka wena o ntse o le kwa ka lebakanyana, e e neng e buiwa ke *Honourable* Barongwang a re go na le thulaganyo e gotweng “mphela ngwana” a o a e itse? A e kile ya ama bangwe ba o ba itseng, fela jalo? Ke re o re e tlhalosetse, e ngakgamaditse thata. Ke a leboga *honourable*.

**MAJ. GEN. MOKGWARE:** Nnyaa, tanki *Mr Speaker*, ke go utlwile sentle. O a bona Tautona fa a ne a re re nne re go ela tlhoko jaana, o bolelela ruri, re go etse tlhoko *Honourable* Lucas.

Ka fa go neng go ntse ka teng, kgang *Mr Speaker*, e tsile jaana, e ne ya re fa go dirwa ditsha kwa Mogoditshane batho ba tselwa masimo, go bo go dumalanwa le bone gore batho ba tlaa beelwa bana, ke gore go tlaa tsewa tshimo ya gago o bo o neelwa *compensation plus* o bo o boa o beelwa le bana ba gago. Jaanong mme e ne ya re go fa go tsamaya, kana tumalano e ne e le gore fa ke na le tshimo e tsewa, ke na le bana ba le batlhano, yone nako e go neng go dumalanwa ka yone eo, go bo go raya gore jaanong kana go tlaabo go balwa bana ba ba le batlhano, go raya gore ke ya go fiwa ditsha tse tlhano. *That is the literal interpretation of it.*

Jaanong gompiano ma *land board* a fa go bewa, fa ba tsena kwa ba re, nnyaa, nako e go neng go tsewa tshwetso e gotwe o tlaa beelwa bana, bana ba gago ba ne ba le dingwaga tse kae, jaanong ngwana wa gago o ne a le *six years*, so ngwana yo o *six years* ga a tshwanelwa go bewa setsha, ka molao wa *land board*, o jelwe. E ne e le teng, jaanong ke yone e re e lwelang re re nnyaa, ka

fa re itseng ka teng fa go tlhalosiwa le kwa Kgotleng, fa gotwe o tlaa beelwa bana, go ne go tewa gotwe go balwa *the number of children* go sa lebelelwa dingwaga tsa bone, ba o nang le bone gore e tlaa re fa ba godileng teng, ke gore o ya go fiwa ditsha tse di lekanang le dipalo tsa bana ba gago. Jaanong bone ba a e fetola, batho bao ba latlhegetswe gompieno, ga ba bone sepe.

*Mr Speaker*, ke tlhologanya kgakololo ya gago ya gore re lebelele gore re bua jang, mme nako e nngwe o fitlhela re pitlagana tota mo go maswe, ka gore kana dikgang tsa kwa Mogoditshane Land Board gore o di bue sentle batho ba go tlhologanye, tšhaba ya Botswana e go utlwe, e batla *examples, relate it to something* se batho ba ka se tlhologanyang. O a bona fa ke ka tsena ka goloetlega fela jaaka ke utlwa motlotlegi a kile a bua a re batho ba a goloetlega, fa Batswana ba tla ba re nnyaa, re utlwile, a bua fela, ga re itse gore o ne a bua ka eng, *but* go batla re e fa *examples* tota tse di supafalang jaaka di dirwa jaana. Le gompieno jaana kana ba ntse ba a baya, ba baya le bosigo. Se ba se dirang ba a tsaya, ba sega ditsha, fa ba sena go nna ba di sega, ba bo ba se bitsa ka Motlotlegi Rre Motshegwa, ba bo ba mo fa *certificate*, Motlotlegi Rre Motshegwa ga a itse gore ene o beilwe setsha kwa ba tsere *information* ya gagwe golo gongwe fela jaaka e ntse ba bo ba mmaya setsha. Fa ba sena go nna ba mmaya setsha se, ene ga a itse kwa a teng, ba a se tsaya *certificate* se ba ya go rekisetsa Motlotlegi Rre Hikuama ba mo raya ba re ke na le setsha kwa nna ke *agent* ya ga semangmang, e ntse e le modirelapuso. Motlotlegi Rre Hikuama o a se reka, ba sutlha Rre Motshegwa, mme Rre Motshegwa a sa itse, letsatsi le a reng o ya *to apply*, o tewa gotwe re kile ra go neela setsha o bo o se rekisa. *These are facts, DCEC is investigating these issues.* Ba di sega fela ka bomo ba re nnyaa re bone *space* fela re ya go sega jaana.

Ke mathata a re nang le one ka fa, re se ka ra itebatsa gore rotlhe re Botswana, e bile gape dikgang tsotlhe re a di itse, a tshwana ka kwa Kgotleng le ka fa Tlokwenng ka fa. E bile se se botlhoko a bo a fetelele a ye kwa makgobokgobong kwa Maun kwa. Dilo tse re tshwanetse gore tota re di ntsho ka gore gongwe le gongwe kwa e ka reng lefatshe teng le nna le tlhwalhwa, bogodu jo jwa lefatshe bo nna bontsi teng.

Ke sone se ke neng ke kopa Ntlo e gore gongwe re baakanyetse motlotlegi fa Motlotlegi Rre Barongwang, le rona re baakanyetse Botswana botlhe kwa ba leng teng ba ba ntseng ba lela ka dilo tse, gongwe re *amend Motion* o, ke gore re o nontshe *Mr Speaker, if I am may*

*be allowed.* Re o nontshe gore re se ka ra nna e kare nnyaa re batla go lebelela bagarona fela ka kwano. Re re, *“that this Honourable House requests the government to consider instituting a forensic land audit in Tawana Land Board, Mogoditshane and peri-urban areas covering all land allocations in the past 15 years, land board officials and employees.”* Ke batla gore *land audit* e re se ka ra e tsaya ka gore *according to my intelligence information*, go ne go na le ka fa setlhophanyana sengwe sa babusi se neng e le gore se ne se ikaya gongwe le gongwe...

**MR SPEAKER:** Lebelela nako ya gago, ga ke itse gore a o *move amendment*. O e sutisa o reng?

**MAJ. GEN. MOKGWARE:** Jaanong ke ne ke kopa *to move this amendment Mr Speaker*.

**MR SPEAKER:** O e sutisa o reng? E kwalekwale foo o e nnee kana o e mpalele.

**MAJ. GEN. MOKGWARE:** Ee rra, ke ne ke e bala jaana, *“that this Honourable House requests the Government to consider instituting a forensic land audit in Tawana Land Board, Mogoditshane and peri-urban areas,”* e bo e tswelela, *“covering all land allocations in the past 15 years,”* or Botswana.

**HONOURABLE MEMBER:** Le Bobonong.

**MAJ. GEN. MOKGWARE:** Nnyaa le tlaa tla le *amend*. A ke re Botswana mongwame, go siame.

**MR SPEAKER:** Gore *the land audit* e e akaretse lefatshe lotlhe?

**MAJ. GEN. MOKGWARE:** Ee. Se ke se kopang fa ke gore go nne le *timeframe*, go se ka ga nna fela. *I so move Mr Speaker*.

**MR SPEAKER:** Hang on, there is an amendment that has been moved.

...Silence...

**MR SPEAKER:** Order! Order! Honourable Members.

**HONOURABLE MEMBERS:** Procedure.

**MR SPEAKER:** Nnyaa, ema pele ka *procedure*. Ga ke itse gore le tlaabo le dumalane jang, mme *amendment* ya ga *Honourable Mokgware* ke go ntsha ‘Mogoditshane’ a bo a tsenya ‘Botswana’ *so that it covers the whole country. So, my reading of Order 47.1B* ga e tswe mo *objective*, *gakere it will still cover Mogoditshane, so it is not a new matter, it is not seeking to achieve a different*

*objective than the original Motion. So, mma ke utlwe procedure Honourable Barongwang.*

**MR BARONGWANG:** *Procedure.* Ke a go leboga *Mr Speaker.* Tota ke ne ke batla go tlhalosediswa gore fa ke kopa go tlhalosa gore ke eng tota ke ne ke ikganeletse mo Mogoditshane, ga ke itse gore a ke na le sebaka sa teng kana jang.

**MR SPEAKER:** Ee, o tlaa *debate amendment* gakere, fa e le gore o gana *amendment* o tlaabo o e *debate*, gore a o a dumalana le yone kante ga o dumalane le yone, mme e bo e tla e tlhophelwa. E tlaabo e tla e tlhophelwa.

*So, I put the question. Honourable members...*

**HONOURABLE MEMBER:** Further amendment.

**MR SPEAKER:** Nnyaa, le tshwanetse *to debate amendment* eo, le bo le e dumalana. *Honourable Segokgo*, fa ke eme ka dinao, o nna fela kwa, ga gona sepe se o ka se dirang.

**HONOURABLE MEMBERS:** ... (Murmurs)...

**MR SPEAKER:** Order! Honourable Members. The amendment reads as follows, “that this Honourable House request Government to consider instituting a forensic land audit in Botswana covering all land allocation in the past 15 years, covering land board officials and employees, Councillors, Members of Parliament and Tribal Administration senior staff.”

*Ke yone amendment eo, fa le debate amendment ke tlaa le fa two minutes fela.*

**MINISTER FOR INTERNATIONAL RELATIONS (DR BUTALE):** Ke a go leboga Motsamaisa Dipuisanyo tsa Palamente. Ke dumela gore ga gona ope yo o ka ganetsang botlhokwa jwa Tshutiso e, e bile ga gona yo o ka ganetsang botlhokwa jwa lefatshe le go tsamaisiwa sentle ga lone. Le ka fa e leng gore fa le sa tsamaisiwa sentle, go ka felela go amile maikaelelo magolo a Puso a gore, re kgone go fetola lefatshe le, re fetole matshelo a Batswana. Jaanong ke dumela gore batlotlegi ba buile sentle gore, a re se ka ra ganelela kwa Mogoditshane. Le fa re ka tswa re itse gore bothata go lebega bo ikganeletse koo, mme rona ba re mo Gaborone re amiwa thata ke gore re bo re na le *waiting lists* tse di saleng di simolola ka bo 1990, re itumelela gore *let us have a national look at this thing, and go to the bottom of it.* Kgang e bontsi jwa yone fela ke gore, *how do we strengthen systems* tsa rona tsa *land management, how do we ensure that we track* batho ba ba ntseng ba dira ka tsela e e ntseng jalo.

Jaanong ka bokhutshwane fela Motsamaisa Dipuisanyo tsa Palamente, ke dumalana le paakanyo e. Ke dumela gore e ka thusa Batswana, *it is not limiting.* Also *I think it will assist in ensuring that we get to the bottom of this problem and strengthen mechanisms* tsa go tsamaisa lefatshe le go le aba gore batho botlhe ba felele ba na le lefatshe, le ba re saleng re emela lefatshe mo Gaborone. Ke a leboga.

**MR SPEAKER:** Before I take Honourable Motaosane, let me bring your attention to Standing Order 47.6, because it appeared to me that you wanted to move an amendment on this amendment. So, you can evoke Standing Order 47.6, “an amendment to an amendment which a Member wishes to propose may be moved at anytime after the question on the original amendment has been proposed, and before it has been put at the conclusion of the debate on the original amendment.”

**MR MOTAOSANE (THAMAGA-KUMAKWANE):** *Thank you my Lord.* E re ntswa ke dumalana le paakanyo go tsenya *the word “Botswana” instead of Mogoditshane*, mme ke belaela gore fa e ntse jaana e supa gore *land board officials, employees, Councillors, Members of Parliament and Tribal Administration senior staff, I feel* gore *it is bottling up* batho ba ba ka tlhotlhomisiwang. Re ka bo re tsenya re re, *former Councillors, former Members of Parliament and the large citizenry and former staff.* Fa o ka ela tlhoko, di diragetse ka nako e batho ba teng gone jaana, ba sa tlholeng ba bangwe e le *board members*, ba bangwe ga ba sa tlhole e le Makhanselara, ba bangwe ga ba sa tlhole ba bereka gone kwa. Kgang e, e ka ba ama, e a ba ama tota e seng go le go nnyennyane. Le bangwe ba Batswana jaaka *Honourable Mokgware* a ntse a bua ka *some two lawyers, I know* le nna gore go na le *lawyers* ba e leng gore dikgang tsa Mogoditshane ke bone fela *who handle them.*

Ke akanya gore *Mr Speaker*, fa re ka tsenya gone fa ra tsenya bo *former Councillors, Former Members of Parliament, former administration staff and the public at large, because* golo kwa ga go senye bodiredi fela. Kgang e le kwa Thamaga e teng. O ya go fitlhela motho a tshotse setlankana, a bo a go raya a re o go rekisetsa *plot* e, a bo a ya go go neela lefatshe *elsewhere*, a sa rekise *plot* e. Ke gore *they use one certificate to go around locating free land*, ba bo ba tsamaya ba e rekisetsa batho fela jalo. Kwa Mogoditshane *it was very peculiar.* Kgang e ya bo mpeela ngwana ga se molao, e ne e se molao, *it was just a gentleman’s agreement.* O fitlhela e le gore jaanong batho *were taking advantage,*

ke mosupi wa bangwe ba ke ka ba supang ka maina gore lefatshe le ba le tshotseng fa Dintorokong...

**MR SPEAKER:** E go tshwere *Honourable* Motaosane.

**MR MOTAOSANE:** Thank you sir. I move the amendment as such. Thank you.

**MR SPEAKER:** Nnyaa, ga o a *move* ka gore nako ya gago e tšhaile o ise o e *move*. Jaanong ga ke itse gore a gongwe o tle o kope mongwe a e *move*. Fa ke e reeditse, *I think it can be covered by after 15 years, gakere? It is already covered.*

**MR MOTAOSANE:** No, it is not covered Mr Speaker. When you are talking about Councillors, Members of Parliament, *o sa bue le ka bo* former, it is not covering. *Ga e ka ke ya re ke innetse kwa ga me, ke kile ka nna Mokhanselara, o bo o ntatela.* These 15 years...

**MR SPEAKER:** *Nnyaa*, mme it is covered.

**MR KAPINGA (OKAVANGO WEST):** Ke a leboga *Mr Speaker*. Ke tlaa farologana le bontsi jo bo mo Palamenteng e. Lebaka la me le lengwefela fela, Setswana sa re “o se ka wa palama setlhare ka dikala,” e bile sa re “o itshegele tema e o ka e kgonang.” *Comrade* Barongwang o tlike ka *Motion* o a kopang gore go tlhotlhomisiwe *land board* ya Mogoditshane. Rona jaanong re batla gore go gobokiwe sengwe le sengwe *at one go, is that feasible? Do we have the resources to do such a massive exercise?*

Ke ne ke le bolelela maloba ke re fa le tsaya ditshwetso, *remember “realistic” in the word SMART. Are you being realistic* gore le bo le re le batla *forensic examination* e e tlaa gogobang *land boards* tsotlhe *at one go?* Di ya go tswa kae *resources* tseo, re le mo seemong se re leng mo go sone se? Fa o sa *prioritise, everything becomes a priority and you will do and achieve nothing.* Ke le bona le batla go tsamaya ka tsela eo. Ga go kgonagale bagaetsho, ke lona ba le neng le ntse le bua maabanenyana jaana le re *Rome was not built in one day.* Jaanong lona le tsaya kae mogopolo wa gore le ka tlhotlhomisa *land boards* tsotlhe ka motsotso o le mongwefela?

Tlogelang *Motion* wa ga *Honourable* Barongwang o ntse fela jaaka o ntse. *Once it is done, you move to the next one. Otherwise* le ya go kgamiwa *by chewing more than you can swallow.* Ke sone se ke se bonang le batla go se dira, *you want to chew more than you can swallow. It is not realistic Mr Speaker, these things are complicated and expensive. Let us do them one step at a*

*time*, ke gone re ka kgonang go dira selo se se bonalang, se na le maduo. Ke a leboga *Mr Speaker*.

**MINISTER OF LABOUR AND HOME AFFAIRS (MAJ. GEN. MOKGWARE):** Procedure. Thank you Mr Speaker, *Motlotlegi* Kapinga, I hear you very well. *O tloga jaanong a bo a tsietsa le ba bangwe.*

*Selo se se botlhokwa ke gore*, when you pass a law like we are supposed to be doing, the law should be all encompassing. After this particular law we have passed, now we are going to set out priorities. You are not going to do it in one day, you are going to have priorities *gore jaaka ke letlelelwa go dira* this forensic audit, *re prioritise eng pele.* It is a well-known fact *ya gore* this is a massive issue, and *ga re ka ke ra e dira letsatsi le le lengwefela.* We have to prioritise looking at the resources and the gravity of the matter...

**MR SPEAKER:** *Nnyaa*, o *debate amendment* jaanong.

**MAJ. GEN. MOKGWARE:** Ke raya gore ke ne ke batla go rialo. Tanki mongwame.

**MR MOROLONG (KGATLENG CENTRAL):** Ke a leboga Motsamaisa Dipuisanyo tsa Palamente. Ke tsaya gore ba *land board* ba itumela mo go maswe ka fa *Honourable* Kapinga a e bayang ka teng. Motsamaisa Dipuisanyo tsa Palamente, ke tlatsa *Honourable* Motaosane, mme ke mo tlatsa ka go kopa gore mo *amendment* re tsenye le bo Tautona ba ba fetileng, re se ka ra tlogela ope kwa morago. Re se ka ra bofelela *audit* matsogo ka kwa morago, e phuthologe fela fa e tsena mo *land board*.

Kana go na le batho ba e leng gore ga ba mo *senior management*, ke *surveyors*, and bone bao fa re ka ba tlogela kwa morago, re tlaa fitlhela e le gore ke bone baji ba lefatshe go feta ba ba mo *senior management*.

Se sengwe Mtsamaisa Dipuisanyo tsa Palamente kana kgang ya lefatshe tota e tona. *There are situations* tse re di itseng tse e leng gore le *drivers* ba na le lefatshe. E rile fa ba bona bagabone ba ntse ba tsaya lefatshe ba bo ba re ehe, le dira jaana le rona re le isang kwa *sites* re reng, mme re sena lefatshe, ba bo ba felela le bone ba didimadiwa ka go fiwa sekidinyana sa lefatshe. Kgang e ga se e nnyennyane. Fa e le gore *audit* e ya go dupa kwa Oodi Sub-Land Board, *for instance*, a e phuthologe fela. Le fa *Motion* o ne o itsetlegetse gore o ema fa, e phuthologe fela e aname re se ka ra e beta. Mo kgannyeng e ke name ke akgetse gole jalo. A bo Tautona ba tsene mo kgannyeng e.

**MR SPEAKER:** *Honourable Morolong*, ke ne ke re le etle le gakologelwa batlotlegi gore fa mogopolo wa lona o atlegile, fa e le gore *forensic land audit* e a dirwa, kana e na le mo gotweng ke *terms of reference*. Le se ka la akanya gore sengwe le sengwe se ka kgobokanngwa mo teng ga Tshutiso sa ba sa nna teng. Go tlaa nna le *terms of reference*, e ka nna ya nna *five or 10 pages* go bo go akaretsa le dikgang tsotlhe tse le ka di akanyang. Ga ke le kgoretse *to debate*. *Honourable Morolong* ga ke itse gore a o wetse, o setse ka *14 seconds*.

**MINISTER OF TRADE AND ENTREPRENEURSHIP (MR NTSIMA):** *Thank you Mr Speaker*. Mma ke leboge Rre Barongwang go tla ka *Motion* o, le ba ba o baakantseng go o atolosa gore o ye kwa mafelong a mangwe. Go na le kwa e leng gore gongwe ga re belaele jaaka mafelo a tshwana le bo Francistown, ga go ise go nne modumo, mme go na lebaka e le gore ga go na yo o neelwang setsha. Go bothokwa gore le rona re itse gore bothata ke eng gore e bo e le gore go ntse jaaka go ntse. Ke itumelela gore se a tlleng ka sone se tlaabo se baakanya le ditsamaiso gore gotlhe fela kwa e leng gore lefatshe le abiwa teng, e bo e le gore go na le tsamaiso e e salwang morago, mme e bile e setswe morago ke gore ga e le gore ka fapoga go ka nna eng, go ka diragala eng.

Mma ke se ka ka dumalana thata le se Rre Kapinga a tlang ka sone ya gore gongwe re ikganelele fela mo khoneng, gone moo re tlaabo re sa itirele sentle. Go bothokwa go itse gore *holistically*, go tsamaya ka tsela e e ntseng jang. Fa re ka ikganelele golo gongwe, re tloga re tlogela tse di bothokwa kwa morago.

Gongwe e bile fa e leng gore go na le mo gotweng ke *cross-pollination*, kana o kgona go fitlhela ba Mogoditshane gongwe ba dirisana le ba Tati Land Board e le gore ba abisana ditsha. Gone moo fa e le gore go tlaabo go ikganeletse fela mo khoneng re ka tloga ra *miss information* e e bothokwa e e ntseng jalo e re tshwanetseng go e tshwaragannngwa fa e le gore go lebeleletse lefatshe lotlhe. Gongwe jaaka Rre Mokgware a ne a bua, *to prioritise* ke sengwe se re ka se dirang, mme fela re supile gore go lebelelewe lefatshe lotlhe ka bophara.

Ke ne ke fetsa fela ke lebogela gore jaanong go tsentswe mongwe le mongwe le ba ba neng ba sa akarediwa ke Rre Barongwang fa a akanya kgang ya gagwe. Bo *former* jaaka ba le mo teng jaana Rre Motaosane, Sekgoa se se siame thata ke ntse ke gakololwa ke Motlotlegi Motshegwa, a re o kile a ruta Sekgoa go raya gore ba mo

teng, dingwaga tsa bone *implicate them* gone foo. Ke a leboga *Mr Speaker*.

Amendment agreed to.

**MR SPEAKER:** The floor is open.

**MR MMUSI (GABANE-MMANKGODI):** Tanki *Mr Speaker*. Mma le nna ke eme nokeng mogopolo wa Mopalamente wa Mogoditshane East. Kana re bapile, mathata a a a bonang ke a ke a bonang. Dikgang tsa lefatshe mo dikgaolong tsa rona ka fa Gabane-Mmankgodi di kwa godimo fela thata. Fa o tsena kwa ofising mo mosong o fitlhela go na le *clients*, bone ba ba go tlhophileng ba le 20, o ya go fitlhela e le gore ba ka nna 15 tota ke ba dikgang tsa lefatshe, gongwe e sale *certificates* di tsewa ke *land board* ba sa itse se se diragalang. Dilo tse di bakile *a lot of tension and pressure* mo bathong le mo *land board*.

Ke batla go leboga gore maloba gone Tona Rre Dikoloti o ne a kgabola gone kwa Gabane, a tla go reetsa Balete le Bahurutshi mo Kgotleng ba mmolelela mathata a ba a bonang. Nngwe ya dikgakololo tse re neng ra di bua Motshwarelela Tona ke gore tota *land board* e tle kwa Kgotleng. Kana go a tura gore letsatsi le letsatsi batho ba bo ba ya kwa *land board* ba ya go tlhola koo, maitseboa *land board* e a tswalwa ba a boa ba sa bona thuso. Gongwe fa *land board* e ne e ka isa ditirelo kwa bathong gone go ka kgona gore dikgang tse gongwe di rarabololwe ka bofefo, di reediwe ka gore le fa e le gore re dira *the forensic audit*, go na le dikgang tse di teng tsa letsatsi le letsatsi *and they need to be addressed*. Batho ga ba ka ke ba emela *forensic audit* fela gongwe e e tlaa tsayang ngwaga gongwe tse pedi. Kamoso go tlaabo gotwe ga go na madi, ga go na eng, mme *we also need to come up with a plan* e e leng gore e tlaabo e *address the day-to-day issues* tse di itsang batho go ka itlhabolola, go ka itirela, go ka aga mo ditsheng tsa bone. Ba bangwe ke ba e leng gore gongwe batsadi ba bone ba sale ba tlhokafetse, mme ditsha tse ga di ise di tsenngwe mo maineng a bone kgotsa *land board* e tsenya madiadia fela.

Ke dumalana le one thata rra ke go ema nokeng e bile ke a go leboga. Gongwe e bile mogopolo o re tlaa tsenya Tshutiso gape e nngwe, ke bona o sa tsenye morafe ka kakaretso, *the public at large* re tle re oketse. Ke bona e le bodiredi fela o tlogetse setshaba jaaka Tona Rre Mokgware le Rre Motaosane ba bua ka diagente. Ga ke itse gore bone ba tsena fa kae gone fa, gongwe legale ga

ke tlhaloganye Sekgoa, Tona Motshegwa o tlaa nthuta Sekgoa sa teng gore tota *the public at large* e tsena fa kae mo teng ga kgang e rraetsho.

Go ne ga nna le kgang ya gore batho ba tlise masimo ba tlaa neelwa ditsha, mme kgang e nna ke bonang e ne ya nna le bothata jo bo tona ke gore gongwe Mogoditshane le Sub-Land Board *they report* kwa Molepolole. Jaanong sengwe se e leng gore gongwe *Minister* le ene o tshwanetse gore ba se fetole ka bofefo gore re kgone go bona dithuso ka bofefo ke gore gongwe Mogoditshane e dirwe *main land board* ka gore Mogoditshane o motona, *it encompasses constituencies* ke belaela gore di ka nna *five*, mme di di tona. Ke dumela gore tota Mogoditshane e tshwanetse gore *a main land board*.

Kgang e fa o ne o e reetsa ya *to exchange* masimo, e ne ya re fa Mogoditshane Sub-Land Board e fetsa go tsaya tshwetso, *main land board* e bo e e busetsa morago e re bale ba ne ba sena dithata, fa o ntse o utlwa dikgang tsa teng, mme bale ba setse ba simolotse. Lantlha ba ne ba re ba ne ba filwe *permission* ba bo ba tswelala, bale ba bo ba boela morago.

Tota ke akanya gore *Minister* ka bofefo jo bo rileng a dire gore batho ba dikgaolo tse tsa rona tsa bo Gabane-Mmankodi ba kgone gore ba itseele ditlamelo gauifi gone fa, ba kgone gore ba ye kwa Mogoditshane Sub-Land Board, e se ka ya re a tsena koo go bo go boa gotwe a ye kwa Molepolole. Ke dumela gore ke dilo dingwe tse e ka reng fa go ntse go diriwa *forensic* di bo di tlaletsa gore di tswale *gaps because* le fa re ka dira *forensic* mme re sa tswale *loopholes*, dilo di ntse di ya go tswelala di ntse di diragala. Jaanong ke ne ke akanya gore fa re ne re ka dira jalo, go ne go ka siama thata.

Rraetsho, dikgang di dintsi mo kgaolong yone e. Gone mo go neng go isiwa masimo go bo gotwe o neelwa ditsha, bangwe ba ne ba setse ba dumeletse (*granted*), bangwe ba setse ba rekisitse ditsha tseo mme ga ba a ka ba neelwa *certificates* tsa ditsha. Mme ka gore batho ba tlhoka bonno, *waiting lists* di ne di le kwa godimo, bangwe ba setse ba agile mo ditshetseng tsona tseo mme ga ba na *certificates*, ke *up and down* fela le nnetlane.

Ya gore go tlhotlhomisiwe lefatshe, go na le batswakwa ba le bantsi mo kgaolong yone e ba ba setseng ba na le lefatshe le le boketekete thata.

Ke ne ke re gongwe gape sengwe se re tshwanetseng gore re gakolole *land boards* ka sone ke gore *land board* e se ka ya batla go tsaya masimo a batho fela e dira ditsha, e rotloetse batho gore ba dirise masimo a ka gore

masimo ke botshelo. Ba tshwanetse gore ba tswelale ba ntse ba lema mo go one, ba se ka ba re *fast-track* fela gore re buse masimo ba bo ba re neela ditsha mo e keteng re bona madi ka bofefo. Ba rotloetse gore masimo a re tswelale re a lema, a kgone gore a tsise dijo. Re se ka ra emisa ka fa e bo e le gore ka fa go nna le phatlha e tona.

**MR MOROLONG:** *Point of clarification.* Ke utlwa motlotlegi, o e tshwere sentle. Ke ne ke re ntlhalosetse, kana *land board* fa e batla tshimo go baya batho ditsha, e batla tshimo e motse o setseng o gorogile fa go yone. A motlotlegi jaanong a re gone foo go tswelale go lengwe fela batho bone ka fa ba lela ka ditsha mme tshimo ya ga Morolong e le yone e e foo e ka bo e kopiwa gore go bewe ditsha mo go yone? Ke batla o e tlhatswe sentle gore re thuse le yone *land board*, re se ka ra e omanyana fela. Tanki.

**MR MMUSI:** Tanki *Mr Speaker*. Kgang e e teng *honourable* ke gore, kana *process* e ya go tsaya ditsha, *example* gone fela ka fa Gabane ka fa, ditshimo di setse di tserwe mme go na le *dispute* e e leng gore *it has been going on for more than bo 20 years*, batho ba ga ba leme masimo a bone, ka gore *land board* e ne ya itlhaganelela gore e tseye *certificates*. Batho ba gompieno go raya gore ba bangwe ba a tlhokafala, bana ba rona fa ba tla ga ba itse gore ke tlogetse fa kae *certificate* sa me sa tshimo. Jaanong go nna fela go nna le tlhakatlhakano. Fa bongwanake ba re ba ya kwa *land board* go batla *certificate*, *land board* ba re ga ba itse sepe ka *certificate*. *So, ownership* e nna fela mo phefong, kamoso bongwanake ba ka tsoga ba latlhegetswe ke se se neng se ka ba tshetsa.

Ke sone se ke reng a re name re ntse re tlogetse batho ba dirisa masimo, *whilst the negotiation is being done*, ba tshotse *certificate* sa bone go fitlhelela tota go wela, go dumalanwa gore re ka ya kae.

Ke go ema nokeng *Honourable* Barongwang jaaka go buiwa gore gongwe e ka atolosiwa le lefatshe la Botswana mme e tsamaye *stage by stage*, gongwe go simololwe kwa go wena Mopalamente yo o amegang, yo o tlleng ka Tshutiso e rraetsho. Ke re ke go ema nokeng jalo. Tanki Motsamaisa Dipuisanyo tsa Palamente.

**MR SEGOKGO (TLOKWENG):** Ke a leboga *Mr Speaker*. Tota ga ke emele sepe fela se se leele, ke emela fela go ema mokaulengwe wa me nokeng ka go ntsha *Motion* o, o e leng gore re dumela tota jaaka Rre Mokgware a ne a bua, ga se gore gongwe o ama ba Mogoditshane fela, o ama Batswana botlhe ka kakaretso.

Ke mo leboge ka gore ke kereka le ene mo kerekeng e e busang lefatshe le la Botswana ya Umbrella for Democratic Change (UDC). Re dumela gore ke gone jaaka re tsweletse *ticking the right boxes*.

Fa o lebelela Pillar No.3 ya UDC *Manifesto*, we have been talking about the social contract for the past three days gore a mme are we fulfilling the social contract e re nang le yone re le Botswana. Fa o lebelela Pillar No. 3 *Mr Speaker*, e bua ka *land, housing environment, climate change and green energy*. The objective ya teng e tlhalosa gore we want to achieve fair distribution and efficient use of land, supply of decent housing, sustainable environmental management and transition to green energy and reduction of carbon-based production systems that destroy environment and cause global warming. Fa e fologetse e ya kwa tlase kwa go 3.1 e tlhalosa jalo gore upon assumption of power, we are going to review the Land Act and Land Management System with the intention to ensure equitable access to land by Botswana. Mo godimo ga moo e bo e tlhalosa kwa bo 3.1 (b) gore we are going to conduct land management and tenure, a national land audit to address issues of land allocation and ownership. Ke dumela gore o e tshwere sentle jaaka ke ne ke tlhalosa mokaulengwe. Ke dumela gore ke jaaka re ntse re tsaya steps ka bongwe ka bongwe.

Se ke dumelang gore gape re tshwanetse gore re se dire, we have to ensure gore upon implementation of this Motion, o tsamaisanye le National Development Plan (NDP) 12 in the agricultural sector fa e bua gore re tshwanetse gore re ye go fetola le melao e e tsamaisang kabo ya lefatshe. Honourable Motshegwa, ke dumela gore re tshwanetse gore re ye go dira mo gotweng ke Constitutional devolution gore melao e e leng gore ke ya lefatshe, e se ka ya tshwana lefatshe lotlhe ka bophara. Rona kwa Tlokweng, Mogoditshane, gongwe le kwa bo Gabane jalojalo, re hupediwa ke gore re gaufi thata le toropo ya Gaborone. Gongwe le kwa bo Francistown le dikgaolo tse di bapileng le ditrope tse di tshwanang le bo Jwaneng le bo Sese.

Ke dumela gore e re fa re gata your Decentralisation Policy Honourable Motshegwa, re tsamaisanye le mo re go bitsang re re ke Constitutional devolution. E re fa re ya go dira the Review of the Constitution, re ye go felela re tsamaya kgato ka kgato go baakanya melao yotlhe ya lefatshe. I am skeptical gore fa e le gore gongwe re ka tabogela gore in terms of implementation... ke gore fa re ka dumalana in principle ka Motion mme

fa re tswela kwa ntle in terms of implementing this particular Motion, re se ka ra tlogela melao e mengwe e re e tlhalositseng mo NDP12 le mo State of the Nation Address (SONA) jaaka Tautona a ne a bua gore re tle re kgone go bona gore we align all the strategic objectives tse di teng gone foo di bo di felela di converge into one thing. Ke gone fa e leng gore re tlile go ntsha selo se se lephongka se Botswana ba ka se itumelelang.

Dikgang tse dingwe ke gore fa o tsena kwa khanseleng ke e fa sekai, o ya go fitlhela e le gore le fa go tsena mo dipegong, golo mole ga maloba ke go bua mo ke neng ke re ke the triangular matrix of reporting, kwa e leng gore even the Land Board Secretary o ya go report kwa go Tona, kgantele gape gatwe o na le report ya gagwe e a e isang kwa khanseleng.

Fa o lebelela the Physical Planning Department, o ya go fitlhela e le gore tiro ya bone thatathata ke demarcations tsa lefatshe le to approve plans tsa lefatshe mme e santse e beilwe ka kwa dikhanseleng ka kwa. Jaanong nna ga ke itse, gongwe ke go akanya go ya kwa pele because di dirilwe ka nako ya Ministry wa Local Government o santse o tlhakane le wa Lefatshe ka bo the 80's or early 90's. Ke gone gongwe di bo di felela e le gore di tlogelwa gone koo. Ke dikgang tse e leng gore re tshwanetse gore le tsone re tle re kgone go bona gore re di kopanya ka tsela e e ntseng jang.

Issues tse di tshwanang le bo expropriation, rona kana kwa Tlokweng re bapile le dipolase tse pedi. Fa o fofa kwa godimo o ka bona gore tota mo gongwe ke virgin land. Motho fa gongwe o dirisa only 10 per cent ya polase eo. A re ka se ke gongwe ra akanye re wetse maikutlo, re sa lwe, le bone beng ba farms tsone tseo, the southern farms le the northern farms tse e leng gore ke tsone tse e leng gore di hupetsa motse wa Tlokweng. Re re ao, batho ba Modimo, tlheng population ya Tlokweng e godile e tsamaya kwa go bo 70 000, a mme gone re ka se ke re buisanye gore gongwe le re tlopoeleng sekgethenyana mo teng.

E rile ke le Modulasetilo wa Khansela fa re santse re dira review ya Tlokweng Development Plan, ke kile ka leka go bua le bone ba the northern farms le southern farms. Ga ke batle go bua maina, ga ke itse gore a gongwe o ka ntetla, Mr Speaker. Ke dumela gore la re the southern farms ke tsa ga Brink, the northern farms ke tsa the Khama family. Ke kile ka buisana le bone, tota ke ikobile fela ke tlhalosa gore fa e leng gore ga le dirise teng, a le ka se ke le ngathe hectaresnyana bogolo la re neela ka kwano, ra buisanya ka go bona gore re ka dira

*compensation* ka tsela e e ntseng jang. *I believe* gore we *have to stoke and investigate that conversation again in the public sphere so that we can debate it*, re buisanye go bona gore batho ba Tlokweng ba a hupelwa. Ke dumela gore *we are supposed to allocate 1,800 plots, gongwe very soon* fa Rre Dikoloti a fetsa ka dikgang tsone tsa *compensation*. Mathata e tlaabo e le sekgame sa bofelo, mo go setseng jaanong go tlaabo gore re ye go pota ka kwa Mabutswe. Fa go buiwa ka bone batho ba e leng gore *they are listed*, o fitlhela fa gongwe motho a na le *plots* di le bo 10 or 12.

Selo se sengwe fa e le gore re tlaabo re tsamaela gone koo, ke dumela gore *we just have to adopt model* o gotweng ke *smart land allocation*, re ye go leka go buisana. Ke dumela gore Tona Ramogapi ke phophothlhelatla, o dira tiro e ntle ka dikgang tsa *habitable housing*. Re tshwanetse gore le ene re mo tshware mogoma, *we should just ride on his pedestal* ka *vision* ya gagwe, re ye go bona gore mo gongwe re ka se ke re dire kwa e leng gore gongwe re agelela fela jaana, re bo re dira *allocations* teng, re dira *gated estate* gore re fokotse *square meters* tse e leng gore motho o a di neelwa, re isa kwa tlasenyana re bo re dira bo *gated estate*. Rona kwa Tlokweng fa o bone mogoafatshenyana o, fa e le gore go na le fa e leng gore e kare fa o latlhegelwa ke ngwana kana jang, fa re ka bona *space* sa lebitla fela fa morago ga ntlo eo, re tlaabo re siame, mme go na le yone *gated estate* yone eo. E ka tla le tsone dikgang tsa borukutlhi jalojalo.

Selo se sengwe jaaka ke bua ka melao, *we have to start what we call the democratic accountability and efficiency* Mr Speaker. *We have overly powerful bureaucratic system*. Badirelapuso ba rona *are overly powerful over* mapolotiki, *but we have to know* gore go na le golo mo gotweng ke *democratic accountability and efficiency*. *We have been elected by the people*, mo gotweng ke *universal suffrage*, batho ke bone ba ba re tlhophileng, *and they expect that accountability from this House* re le *elected officials*. Fa e fologela kwa tlase, ke ntse ke go leba Tona Motshegwa, re tshwanetse gore jaanong le bone bao ba *land board*, fa e le gore Tona gongwe o na le ba le batlhano ba e leng gore o a ba tlhoka, ke supa wena ka gore ke a itse gore *you are the champion of decentralisation and devolution of power*. Gore fa re fologela kwa tlase, bogolo mo malokong a le maratara a *land board*, ba le bane Mr Speaker, a ba tlhophiwe ke setšhaba *so that* re dira yone e gotweng ke *democratic accountability*, ba le babedi gongwe ba bo ba itlhopelwa ke Tona *so that* e re fa ba tsamaya

ka yone *their manifesto* wa *social contract*, e re fa ba palelwa ke go re fa ditsha, re bo re re nnyaa mme re tlhophile lona ka gore le ne le re le tlaa re thusa ka *to allocate* ditsha. Ke sengwe se e leng gore re kile ra se dira, *but this one* e e leng gore...

**MR HIKUAMA:** *Clarification*. Ke a leboga *honourable*. Kana go ne go na le dipuo tse di farologaneng, ba bangwe ba re a re rulaganye sesha lone lekalana la kabo ditsha, go tlhantlhamolola le go phimola yone *land board* yotlhe ka bophara, re simolole lekana le le siameng. Wena o santse o bona gore *land board* e ka re isa golo gongwe?

**MR SEGOKGO:** Ke a leboga. *Now we can debate* tsone dikgang tseo le tsone tsa bo *land board*, fa *debate* eo e le *in the public sphere*, re ka tla ra buisanya jaanong gore gongwe re ka dira ka tsela e ntseng jang.

Kwa bofelong, dikgang tse di kwa Tlokweng tsele, di tlhomola pelo, ke gore o fitlhela e le gore motho o mo *waiting list* gatwe ke *number 5000*. Kgantele go bo gotwe go tlhatswiwa *waiting list*, a bo a fitlhela e le gore jaanong *they jumped from 5000 instead of* gore a ye kwa tlase, jaanong o ya kwa godimo gatwe ke *number* bo 35 000. Ke dikgang tse e leng gore di utlwiswa botlhoko. O fitlhela monna yo o 65 years a santse a nna le mmagwe kwa Tlokweng, ke dikgang tse e leng gore di utlwiswa botlhoko fela thata.

Sengwe se ke neng ke re ke tlaa se bua jaaka ke bua ka *Constitutional Devolution*, ke gone gore le yone *the uniform allocation because* dikgang tsa rona di a farolagana, ba kwa Maun ba na le dikgang tsa bone tsa makgobokgobo e ntse e le dikgang tsa lefatshe, ba kwa bo Tsabong, Tokyo kwa Gantsi ba na le dikgang tsa *farms*, mme e ntse e le *issue* ya *the land question*. Rona ka kwano ba re bapileng le toropo re na le dikgang tsa *residential plots*.

Fela ka go rialo, ke re ke go eme nokeng mokaulengwe, o gata dikgato sentle, ke tlaabo ke ya go tlhophela le wena kgantele gore re fetise *this Motion* o o yang go dira ditso tsa lefatshe la Botswana. Ke a leboga.

**MR BOGATSU (LENTSWELETAU-LEPHEPHE):** Tanki Motsamaisa Dipuisanyo tsa Palamente. Le nna ke ne ke re ke eme ka dinao, go ema mogopolo o nokeng. Ka e bile e rile go baakangwa gatwe *and other peri-urban areas*, fa e ntse jalo, e tsenya kgaolo ya me mo teng segolo jang motse wa Kgope, ka gore *it is only 20 kilometers (km)* go tswa mo Gaborone, fa o tlola ka

kgaolo ya ga Rre Shawn Ntlhaile o bua ka 6 km go tswa mo Gaborone. Le yone ke kgaolo e e gateletseng thata ke tshenyetso-setšhaba ya *land board* e re leng mo go yone.

E rile morago ga ditlhopho, ke ne ka leka ka thata gore ke tshware *meeting* le Modulasetilo, ga pala go fitlhelela a bo a ya *transfer*. Jaanong ga tla ga tsena yo mongwe, ke ene a neng a mpha monyetla wa gore ke ye go kopana le ene e le ka mabaka a masa a kokometse a a diragalang mo kgaolong ya Lentsweletau-Lephephe. Metse e e amegang segolobogolo e ke ka sekeng ka e lebala, e e sokodisiwang, e e tshwereng bothata, e le motse wa Kgope, o e leng gore koo jaanong ke dintwa tsa masimo a e leng gore ga go itsiwe gore gatwe seemo sa one ke eng, ke a bo mang, go tthatlagane. E se Kgope fela, le motse wa Mmatseta, a e leng gore le one jaanong ke dintwa tsa masimo, *land board* e duetse batho, mme batho ba ba duetsweng bao, ba boetse gape mo masimong a teng. Motho a le mongwefela o kgona *to be compensated* gabedi.

Fa re tsaya wa Kopong ka one jaanong segolobogolo ke *residential*, go na le selelo sa dipeo sa masimo, mo e neng ya re mo ditlhotlhomisong tsa me, ka felela ke bone *map* wa *allocation*, mme ke bontshiwa go na le *gaps* gore fa le fa ga go a bewa, jaanong seo ke sehuba sa babereki ba *land board*, e tlaa re fa ba go ratile, ba ye go go sukunyetsa ka nako e e leng ya bone. Jaanong mogopolo o, ke o ema nokeng thata wa gore a o emelwe ka dinao go ye go bonwa gore gatwe go diragala eng kwa kgaolong ya rona ya Lentsweletau-Lephephe.

Mo kgaolong e ya rona, ke ne ka kgona go bona gape le dintlha tse di supang gore batho bangwe ba duetswe, mme ba ntse ba mo masimong a bone. Madi fela a tsitsibanyang mmele a a fetang bo P100 000, mme e bile e kare gongwe ba bone ba setse ba duetswe gape, mme ba ntse ba mo masimong one ao a bone. Ke gore *land board* *compensates* motho gore e mo tseela tshimo, go tsweng foo motho yo o a tlogelwa gape. Tota e tshwanetse gore *this audit* e ye go simolola kwa Lentsweletau-Lephephe, Mogoditshane o tla a tla *number 2*. Ke bothata fela jo bo hutsafatsang ka fa seemo se ntseng ka teng.

Fa e le dikgang tsa masimo, ba bangwe ke a e utlwa kgang ya teng gore go diragetse jaana, batsadi *were compensated*, bana jaanong ba buseditse *cheques* kwa *land board*, mme ba dira morago ga tlhokafalo ya batsadi ba bone. Jaanong ke ipotsa gore *why land board* e kgona gore e amogele dilo tse di ntseng jaana ka gore e ne e na le tumalano le batsadi e seng le bana.

Ba bangwe motho o tsaya tshimo fela jaaka mo Lentsweletau, go na le *self-allocation*, motho o kgona go itshegela lefatshe a bo a batla gore a *demarcate* a bo a ipeela batho mo, *claiming* gore tshimo ya teng ke ya gagwe. Le gone mo gape, ke na le sengwe se se supang kgang ya mofuta wa teng ka gore ke ne ka shebasheba mme ka bona ke sedile dilo dingwe. *I even have receipts* tse di supang gore batho ba duetswe, mme ba ntse ba mo masimong a bone. Jaanong kgang e ya gore go tlhodumelwe thata mo *land boards*, ke e ema nokeng ke tlhwaafetse. Letsatsi le letsatsi ke nna ke lelediwa ka kgang ya *land board*, ke tshwere maina a batho ba e leng gore ba santse ba le mo dintweng tsa lefatshe, ga ke ka ke ka a bala mo Palamenteng. Ba bangwe o ne o utlwa motho a re gatwe o eme. *I think the change of Government* e dirile gore jaanong batho ba simolole *to panic*. Mo e leng gore le fa o ne o tlhoboseditswe, o kgona go tewa gotwe sengwe se tlaa tla. Tse dingwe go ne ga nna gatwe ema pele, re a bona gore e kare seemo se seng.

Ke tshwenngwa ke batho ba ba duetsweng *Mr Speaker*, ba boetse mo masimong a bone. Ke tshwenngwa ke *gaps* tse ke di bonang mo mmpeng wa Kopong wa *allocation*, tse di *marked* ka bohobidu tse di supang gore tse ga di a bewa, di tshwanetse gore di ye go tlhodumelwa re itse gore di saletse eng, ke eng di sa bewa.

Ka bokhutshwane jo bo kalo, mogopolo o ke o ema nokeng thata. A re yeng go namola batho mo dikgannyeng tse, di dintsi ga se tse di ka kgonwang ke motho, di a boitshega. Fa Gakuto fale ke mase a kokometse le gone, kwa ga bo Motlotlegi Ntsima, go mathata le gone ka koo le ye go lebelela. Mma ke eme gone fa Motsamaisa Dipuisanyo tsa Palamente.

**DR GOBOTSWANG (TSWAPONG SOUTH):** Ke a leboga *Mr Speaker*. Le nna ke emela go ema nokeng mogopolo wa ga *Honourable* Barongwang. Ke o ema nokeng pele ka gore tota one ke mogopolo wa Botswana Congress Party (BCP), o re tswang kgakala re bua ka one. Ene o tsile ka Sekgoa se se monatenyana a re *“forensic,”* rona re ne re bua ka *“land audit,”* jaanong ga gona ka fa re ka o ganang ka teng. Le ka fa *Honourable* Kapinga a neng a bua ka teng le gone go ne go tlhamaletse, ka gore ene o ne a bua ka seemo gore a mme mo seemong se re leng mo go sone re ka kgona gore re dire gotlhe. Fa mogopolo o ntse jaana re tlaabo re o fetisa, go tlaabo go le mo Pusong gore jaanong ba nne fa fatshe ba loge leano la gore ba ya go o diragatsa ka tsela e e ntseng jang.

Ke tshwenngwa ke selo se le sengwe fela se se tona *Mr Speaker* sa gore, tota re fetisa *Motions* mme ga re ke re itse kwa di feletseng teng. Go batla gore gongwe re dire tsamaiso nngwe e tota Goromente a ka tlamegang gore a nne a a fa dipego tsa gore o tsamaya fa kae. Kgang e re kopane le yone ka le itse ke le Modulasetilo wa *Government Assurances*, kwa komiting ya me jaanong re leka go sala morago dikgang tse di dumalanweng gore di tsamaya fa kae. O fitlhela bodiredi mo gongwe bo o fa mabaka a gore, e rile fa ba tshwanetse gore ba diragatse mogopolo ba kopana le makgwere a a rileng. Jaanong o kare ga gona tsamaiso ya gore, fa ba fitlhela go na le makgwere ba dire jang. Kakanyo ya me e ne e le gore, ba tshwanetse gore fa ba setse ba leka go diragatsa mogopolo fa ba rakana le makgwere ba boele kwa Palamenteng, *Minister* a tle *to report* gore ba tsamaya fa kae. Selo se se a tshwenya *Mr Speaker*.

Mogopolo o o tsile jaana e le gore go na le *forensic audit* e e tswelletseng, mongwe o ka botsa gore jaanong ke eng re batla go tla ka mogopolo wa *forensic audit*, mme go ntse go na le *forensic audit* e e tswelletseng. Bagaetsho *forensic audit* e e tswelletseng ele *is opaque*, e sephiri, rona re le Mapalamente le setšhaba ga re itse le gore go dirwa ditlhotlhomiso tse di tseletseng mo go bo mang, maphata afe. Ke tsaya gore re tshwanetse re le Palamente gore rona re tswelile jaaka o kare ga go diragale sepe, ka gore ga re itse sepe se se diragalang. Bagaetsho kana *forensic audit* jaaka re ntse re bua, maikaelelo a yone ke gore kwa bofelong go baakannwe ditsamaiso. Ga e tshwane le *audit* nngwe le nngwe, e ka gore e a go lebelela *irregularities and fraud* go raya gore kwa bofelong mongwe o tshwanetse gore a ba a tselwa dikgato. Ga se e re tlileng go tla re bona gore a *processes* di ne di setswe morago, re ya go bona masula le tlolo molao tse di diragetseng, ba ba tlaabong ba tlodile molao ba ya go tselwa dikgato. *Forensic audit* e tshwanetse gore e nne jalo, ga se *audit* nngwe le nngwe fela e e fang *recommendations* tsa gore baakanya fale le fale. *Fraud, irregularities and maladministration*, mongwe o tshwanetse gore a di arabele kwa bofelong, ke gone re tlaa itseng gore e berekile *Mr Speaker*.

*Mr Speaker*, dikgang tse di lebelelwang bakaulengwe ba buile ka tsone tse di gakgamatsang, tse batho ba tlhatlagannwang ba bewa gabedi mo setsheng se le sengwe fela, se go nang le dipoko fela, ditsha tse di senang beng ba tsone. Tse o fitlhelang gotwe ditsha ke tse o sa itse gore ke tsa bo mang, mme go belaesega gore di ka tswa di beilwe batho. Go na le *files* tse gotweng di a nyelela mo *land board*, o fitlhela fela gotwe *file* e

nyeletse mo *land board* motho a tsentse kopo a sa tlhole a itse gore go diragala eng. Go na le ba e leng gore motho o iponela phatlha mo motseng, fa a sena go nna a e bona a ya kwa *land board* a bolelela *land board* gore ke bone phatlha fale, letsatsi le lengwe o bona jaanong go bewa motho o sele. Ke tsone dilo tse re di bonang fela tse di gakgamatsang.

Go na le *manipulation of waiting lists*, di a sokwasokwa *waiting lists* tse. E tlaa re wena o ntse o itse gore o *number 10*, o tlaa ne o sale o nna *number 10* mme batho bone ba ntse ba tsamaya. Go gontsi mo go diragalang, mme kana go dirwa fela ke gore ga gona *transparency*. Fa nne *transparency* e le teng, go ne go ka se ka ga nna le go tlhatlaganya batho, go ne go ka se ka ga nna le *ghosts* tse di foo di beilwe, mme o sa itse gore ke bomang. Go ne go ka se ke ga nna le dikgang tsa gore *files* di latlhegile, go ne go ka se ke ga nna le *manipulation of waiting lists*.

Dilo tse fa go ne go na le *transparency*, maranyane a re tlholang re a bua re a dirisa. Fa go tla mo maranyaneng, *land boards* o kare ke nngwe tse di ka fiwang *priority*. *Paperwork* e e dirwang kwa mekoakoa ya *files*, ke tsaya gore le kwa Deeds Registry le gone e tshwanetse ya bo e le mekoakoa fela e e seng kana ka sepe. *The more we speak about digitization*, o kare re boela morago, dipampiri o kare di a oketsega mme fa re bua re bua gore nnyaa re a baakanya re tsenya maranyane, *on the ground* dipampiri di a oketsega. *Honourable Minister of Health*, re batla *paperless hospitals*, gore fa o *press button* ke le kwa Gantsi e bo dikgang tsa me di tswa, ngaka a nthusa a sa tlhole a batla dipampiri mo go nna. Ke tsone dilo tse di leng teng.

Dikgang tse dingwe tsa *land board* tse di dirang gore re bo re le mo mathateng a mangwe ke *compensations*. Molao o tlhamaletse fela wa re "*adequate compensation*." Go tshwanetse gore fa re ya kwa pele, go nne le *holistic approach to compensation*. E ka nna *compensation in cash, compensation in kind, market value* kana *settlement value*. Mo e leng gore fa lefatshe la gago kana *property* e le foo, e nngwe e o e fiwang o tshwanetse gore o agelwe ntlo, gongwe e e botoka fa e le gore ba tsaya ntlo ya gago. Fa e le gore ke tshimo, fa ba go ntsha mo tshimong e bo e le gore *settlement value* o a go fiwa tshimo e e tokafaditsweng e tsentswe terata, e bile go bo go epilwe sediba. Ke gone kwa re tshwanetseng gore re ye teng.

Go na le mo gotweng Free, Prior and Informed Consent (FPIC), kwa go pateletsang *negotiation* motho a dumalane a tlhaloganya ditshwanelo tsa gagwe.

Jaanong mo go diragalang ke gore, *land board* fa e batla go tsaya lefatshe la gago e sokeletsa mosadimogolo le monnamogolo molala fela, o bo o fitlhela e bile ba mo file *even below market value*. Batho ba tshwanetse gore ba rutwe ka *the wealth* e e tshwerweng ke lefatshe. *To unlock the wealth* e e tshwerweng ke lefatshe, ke gore batho ba bo ba tlhologanya gore lefatshe ke te mane e e seng kana ka sepe, ga le ka ke la tsewa motlhofo fela, *cheap* fela ka tsela e e ntseng jalo. O tlaa fitlhela e le gore gongwe kwa *land boards*, fa ba batla lefatshe ka fa ba tlaabong ba le batla ka teng, o tlaa fitlhela gongwe ba sokoleditse motho molala. Ke dilo tse di botlhokwa, *negotiation...*

**MR MOROLONG:** *Clarification.* O a utlwala *Doc*. Ke ne ke re *are you aware* gore mo mabakeng a o a buang ao, o fitlhela motsadi yo motona e le ntemogolo kgotsa nkuku, fa tshimo e bitsa ene ba *land board* ga ba letlelele gore ba ka mo reetsa, gongwe fa a tla ka ngwana. Tota a sa ikgone monna yo wa Modimo, ga ba reetse ngwana fa a ka *advice* monnamogolo, ba batla go utlwa fela ka monnamogolo kana mosadimogolo wa bogodi jo bo kalokalo.

**DR GOBOTSWANG:** Ke a leboga. Ke dilo tse di tshwanetseng gore *forensic* e di lebelele. Ba lebelele le gore *property* e e tsamaile jang gore e bo e le mo diatleng tsa yo. Ba bo ba lebelele gore a mme tlhwatlhwa yone e e filweng *the land holder*, a mme ke e e tshwanetseng, go diragetse jang gore a bo a neetswe tlhwatlhwa yone ele, mme kwa morago ba tlaa fitlhela e le gore go sokeleditse monnamogolo le bogo, ba sa batle gore ngwana a bo a le foo, a mo thusa go mo reedisa le go mo thusa go akanya. Ka tshwanelo o ne a ka tla le *lawyer*, ya tla go mo thusa gore e *negotiate*, *because* nako e nngwe go tlaa tlhokafala gore o bo o *negotiate* le a *mining company*.

Go tshwanetse gore *communities* di *negotiate* le *mining companies* gore kwa bofelong gongwe ba nne le *stakes* mo *mining companies*. *The whole system* e re e dirisang e e leng gore sengwe le sengwe ke bofitlha, ditshwanelo tsa batho di gatakiwa ka dinao, ke tsaya gore fa re ka dira *forensic audit*, dilo tse di tlaa senoga, ga baakanngwa, ba ba molato ba tshwanetse gore ba e arabele. Ke a leboga *Mr Speaker*.

**MR MOSANANA (KANYE EAST):** Ke a go leboga *Mr Speaker*. Ke bo ke akgole mokaulengwe gore a bo a tsile ka *Motion* o o nonneng o. Mokaulengwe kgang e ya lefatshe e, o se ka wa re ke Mogoditshane fela, le rona mo dikgaolong tsa rona re tshwere bothata mabapi

le dikgang tse. Ke batla gore ke se ka ka tlhoka go bua fa gore, kana kgang ya lefatshe le *land board members* tse di leng teng gompiano, dingwe tsa tsone ke *political appointees*. Rotlhe re a itse gore go ne ga diragala eng fa *boards* tseo di ya go dirwa. Jaanong ke dilo dingwe tse e leng gore bangwe ba ne ba ipaakanyetsa le fa ba sa batle go buiwa jalo, ba tlaa intshwarela.

Motsamaisa Dipuisanyo tsa Palamente, lefatshe le teng mo Botswana, mathata ke gore batho ba filwe lefatshe, bogolo jang dipolase, tse e leng gore *they are under-utilised* mo go tlhwaafetseng. Jaanong o fitlhela e le gore ga go na gore go tlaa tweng ka gore ba setse ba a filwe. Puso ya rona e tlaa tshwanelwa ke gore re bone gore re dira jang go ya pele mabapi le dikgang tse. O fitlhela e le gore mo motseng go na le *open spaces*. *Open spaces* tse e leng gore di ne di tlogetswe jalo gongwe gotwe ke patlelo kwa magaeng. Kgantele o bona motho a beilwe foo, o sa itse gore o beilwe jang, mo go rayang gore ga go tsamaye sentle gotlhelele. Ke gatelela gore fa e le tsa dipolase, re tshwanetse go bona gore lefatshe le le busediwa kwa go ba ba ka le dirisang botoka, *either* ka *lease* kana *state* se le reke jaaka fa re na le *projects* tse di tlang tsa bo *hemp* jaana, tse di tlhokang lefatshe, lefatshe le le dirisiwe.

Go na le bothata mo ditoropong, o tlaabo o fitlhela e le gore motho o kile a kwalelwa gore o filwe setsha, *all of a sudden* se tserwe se neetswe o sele, a filwe *plot number*, a kwaletswe. Ke ka a fa sekai ka Rre Evans Jane kwa Kanye. Ke tsaya ke re o tlaa utlwa fa e le gore ga a reetsa, gore dilo tse, ga se gore ke dilo tse di letlelesegang mo molaong. Mo gongwe batsadi ba rona ba felela ba sokasokana le *land board*, e ba beile golo go le gongwefela e sa ba rulaganyetse ka fa go tshwanetseng ka teng. Golo mo go tsenya batsadi ba rona bokoa, mo e leng gore ba bo ba felele Modimo o ba gapa e ise e nne nako ka ntata ya gone go itse botlhokwa jwa lefatshe, mme *land board* e gana go ba rulaganyetsa ka fa go tshwanetseng ka teng.

Ke bua jaana mosadimogolo Mma Thomas, yo o se keng a tlhoka go lebelele *television*, a reetsa le *radio*, ke dumela gore o reeditse ka dikgang tse di tshwanang le tsone tse. Tona, a re boneng gore re thusa batho jang, ba kgone go thusega, ba tsewelele pele le matshelo a bone. Kana fa a hulara fela jalo, ga go na se se tlaa tlholang se diragala, bana ba tlaabo ba kgaphelwa kgakala fela gotwe motho yo e neng e le mong wa setsha seo ga a sa tlhole a le teng, jaanong boela kwa morago.

Go na le bothata *Mr Speaker*. Golo kwa *land boards* go na le *files*. Ke ntse ke utlwa mokaulengwe a bua ka

*paperwork* e ntsi e e dirwang mo Pusong. Fa o re o a ya kwa o tewa gotwe *file* ya gago ga e bonale. O tlaa botabota koo o tsaya dibeke, dikgwedi go ntse gotwe *file* ga e bonale. Ke ipotsa gore a ga go na ka fa e leng gore tota fela ka gore ba na le *computers*, a *information* e yotlhe ga e tsenngwe mo *computers*? Gore fa o tla fela motho a bo a tobetsa, a bo a go thusa, o bo o tsamaya, go na le gore o bo o nnela jaanong go boaboa kwa *land board*.

Sengwe se se botlhokwa ke go rotloetsa banana ba rona gore tsweetswee, iketleleng go rekisa lefatshe, ka gore fa o rekisa lefatshe ga o na go tlhola o le bona gope. Se se diragalang ke gore fela fa a bewa gompiano jaana, o botsa yo o bapileng le ene gore a ga o se batle setsha se, ke a se nwa. Ke bua dilo tse di tshelang bagaetsho, ke bua boammaaruri *and* golo moo ke diemo fela tse di bokete tse e leng gore ka gore ga a na go tlhola a se bona gope, a jaanong o ikaelela gore a ye go nna kae.

Go na le kgang ya *lawyers* tse go lelwang ka tsone, bogolo jang thatathata teng kwa Mogoditshane. Kgang e le yone e tshwenya fela thata gore a batho ba ba Modimo ba, bone ga ba na kutlwelobotlhoko mo setšhabeng sa bone gore fa ba tetepa lefatshe le le kanakana, kana sa teng fela ke go ya go le rekisa, gore ba dire madi ka lone, mo e leng gore ga go a re siamela re le setšhaba.

Selo se sengwe *Minister*, go na le thulaganyo e e leng teng e e dirwang ke *land boards* tsa rona, o tlaa fitlhela gongwe batho ba beilwe sediba sa baikopanyi. A bo *land board* e gana fela gore ba se dirise. Ke kile ka tla kwa go wena *Minister* ka kgang e, mme ga e wele. Batho ba ba Modimo ba a lela, mme ra re re leka gore re thuse balemi ba rona, re tsadise dikgomo tse e leng gore re ka kgona fela fa e le gore metsi a teng. Kgang e ke e tlhamalatse fa gore batho ba, sediba se se gaufi se bidiwa sa Bolokwe, se gaufi le tsela ya sekonetere. E ne e le sa batho ba ba neng ba dira tsela, ba bo ba se neelwa ke Water Affairs. Jaanong ba re re tlaa goga metsi *from* sediba se re a isa selekanyo se gotweng re a tsamaisetse teng, mme Kanye Sub-Land Board e a gana ka sediba se, mme menahune ya re go na le ba e leng gore le bone ba a se batla, ba e seng ba kgaolo eo, gore ba tle ba se tseye jaanong e bo ba ya go rekisetsa batho ba metsi, mo e leng gore ga go letlelesege. Nna fa ke santse ke le teng, ga go na go diragala jalo *Minister*. A re boneng gore re thusa Batswana gore e tle e re se maikaelelo a rona e leng sone, a gore re atise dikgomo tsa rona, se tle se diragale.

**DR DOW:** *Point of clarification. Thank you very much.*

Ka bofefo fela ke a bona gore ga o na nako, kgantele o ne o ama kgang ya *lawyers* mme o ne wa se ka wa e tlhalosa, o ne wa bua fela gore ga o itse gore a ga ba na pelotlhomogi, mme o bo o sa itse gore mathata a bone kwa *land board* ke eng. Ke re gongwe o tlhalosetse Batswana.

**MR MOSANANA:** Ee mma, ke a go utlwa *Mother of the House*. Mathata ke gore o ne o seyo fa go alwa kgang go buiwa ka *lawyers* tse e leng gore go ne gotwe di pedi, tse di tletlepileng lefatshe la Mogoditshane lotlhe. Ke bua jaana le nna ke le mongwe yo ke santseng ke emetse setsha gone kwa Mogoditshane. Gatwe batho ba tsere ditsha fela tse di gakgamatsang, rona Mogoditshane Sub-Land Board e sa kgone go re baya ka gore gatwe lefatshe le a tlhabela. Ke a leboga *Mr Speaker*.

**MR MOTAOSANE (THAMAGA-KUMAKWANE):** *Thank you Mr Speaker.* Mma ke leboge *Honourable* Barongwang yo o sa itseng leina la me mme a tswa kwa Mogoditshane. Mme gone o tsile ka Tshutiso e e siameng thata.

Tota *Mr Speaker*, o bona kgang e fa e ne e kete ke leka gore go nne le *amendment*, e ne e se gore ka lepe fela ke batla go senya Tshutiso. O bona kgang e ya Mogoditshane, ga se Mogoditshane fela, le kwa Thamaga. Fa Kumakwane fa re feletswe ke lefatshe, ke gore le le neng le le teng ba le sotlile mme batho ba Kumakwane ga ba bewe *because of the land board*. Ke batla gore ke tlhomamisetse *Honourable* Barongwang gore fa go tlhokafala gore bangwe re botswe re tle go araba, re ka dira jalo.

*I remember* nako e go neng gotwe *land board* e dumalane gore go dirwe *compensation in kind* and rona fa re setse batho morago, Goromente golo gongwe e bo e le gore gatwe *a hectare* e ka bidiwa tshimo. *Initially standard* sa masimo e ne e le gore *anything below four hectares*, ga go ka ke ga nna tshimo. Ga tla gore la bofelo e bo e le gore *a hectare is called* tshimo. *That is why* bone bo magwagwantlhane ba lefatshe ba *decided* gore fa go santse go builwe le batho gore go ya go tsewa lefatshe mo go bone, bone ba bo ba taboga ba ya go le reka mo bathong ba itse gore go dumalanwe *a particular amount of land* e e leng gore ke yone e ka dirisiwang *to compensate*. *The whole idea of compensation in kind, it was because* Goromente o ne a sena madi a a lekaneng gore masimo a fa a tsaya o ka duela batho *on the spot*.

Jaaka *Honourable* Mmusi a ne a bua kgantele, o fitlhela e le gore *land board* ya re re tsaya masimo a, o tlaabo

o nna 10 years land board e ise e go duele. O sa leme, o eme fela, ke gore e nna a serious loss mo go wena. Kgang e ya compensation in kind, rona re ne re ntse re e bua, re eletsa gore Puso fa e tsaya, mo five hectares gongwe e neele motho plots tse tharo, e le dikakanyo e ise, e nne mogopolo. Ba ka ba ne ba ntse ba na le maikaelelo, ba bo ba taboga jaanong ba ya go reka masimo mo bathong, one a a setseng a le envisaged gore ke one a a tsewang.

Se se botlhoko, what they did, o ne o fitlhela e le gore ba dira jaana tshimo e ba buang ka yone e tlaabo e le kwa Kubung mme ene a go tseela lefatshe mo Mogoditshane. Ke gore e ne e le matlhabisaditlhong, matlhotlhapelo, o bona gore it has been systematically planned ke bodiredi and even some board members. Kgantele fa o ne o utlwa ke ngongorega o kare ke bua ka bo former jaana, I was one of the people ba re neng re ile kwa main land board gore le tsamaya fa kae ka kgang e ya nnenyane. Kante re tsentswe jaana batho bone ba itse gore ba ipaakanyetsa jang. I still remember main land board e re raya e re nnyaa golo moo ga go ise go nne ditumalano. Ga re ise re dumalane, ke kgang e re santseng re e sekaseka, kana fa re fetsa go e sekaseka go tlaa nna le the regulations. You cannot believe gore these guys went ahead ba bo ba tsamaya ba ya go dira jalo.

Kgang e rra o tlile ka yone ka nako e e tshwanetseng gore a ko re ye go okomela. E re re okomela, go na le kgang e ya bo mpeela ngwana. Kana golo moo ga se molao. Gompieno it is painful gore ba bangwe ba neetswe, ba bangwe ga ba a neelwa ka gore it was not documented gore go ya go dirwa jalo. It was just a gentleman's agreement e e neng e le foo fela e bo e sa dirwe gore e nne ka tsamaiso.

I remember one old woman kwa Kumakwane yo o tseetsweng lefatshe, a neela land board lefatshe gore e age sekole, mosadimogolo wa Modimo a re a beelwe bana ba le bararo only. Eo e a pala. Officials tsa land board, when it suit them ka nako eo, they do it. Fa e le ka nako e e leng gore ga ba batle kana ke yo ba sa mmatleng, ga ba kgone go thusa seemo sa go nna jalo. A poor old woman o tlaabo e le gore kgang yone e pala e nne teng ka gore ba mo raya ba re ga go na record. Who is supposed to keep the record? Land board, it is supposed to keep the record. Fa e le gore golo moo e ne e le tumalano, land board e tshwanetse e ka bo e ne e na le tumalano eo. Jaanong ke matlhabisaditlhong rra.

Fa o bua jaana ka kgang ya Mogoditshane, fa o batla file, ga e nke e bo e nna teng. Fa o ka tsamaya wa ya

go batlisisa, files tse di nyelediwa ka bomo. Batho gatwe ke technical officers, surveyors kwa land boards. These guys are deadly, very dangerous. O fitlhela go le botlhoko e re go ntse jaana go bonala kgang e le teng, e bo e le gore motho o tlaabo a seegilwe, go tswa fa e bile o busediwa mo tirong. Things e bo di nna normal mme go na le bosupi jwa gore... o tlaa fitlhela ba fitlhelwa ka ditempe le stationery tsa land board mo matlong a bone. Dilo tse di tlhokana le gore re tle re tobetse re bone gore totatota gatwe go diragala eng mo land boards.

Gompieno fa o ya kwa Mogoditshane Sub-Land Board o bua ka plot ya gago e e kwa Thamaga, ga ba kgone go tsena mo maranyaneng gore ba go thuse.

Gompieno batho ba kwa dikgaolong tsa rona kwa, go kile ga bo go baya Thamaga Sub-Land Board. Fa e baya, go bo go fetolwa plan gotwe jaanong batho ba bo Moshaweng bo nneu ba tseye ditlamelo kwa Letlhakeng. So, go ya go rurifatsa certificate fela gare o tswe kwa Thamaga o ye Letlhakeng o bo o tswa koo o ya Moshaweng. Dilo tse go botlhokwa gore Tona o bone gore land boards di a tshwaragana. Ke gore fa o batla selo kwa land board, le fa o le mo Mogoditshane Sub-Land Board o bua ka setlankana sa kwa Thamaga, e bo e le gore they can access the system ba bo ba go ntshetsa copy ya setlankana se bo se rurifadiwa. Golo ke gone go ka fokotsang le jone borukutlhi jo bo kanakana.

Go na le batho fela ba ba tona jaaka ke bona, o tshabile go tlhalosa, o rile le Tribal Administration Senior staff. O tshaba go tlhalosa, ga ke itse gore ke eng o tshaba. Go na le Magosi ba ba dirang jalo ba ba rekisitseng lefatshe mo Mogoditshane. Last time e rile ke bua batho ba bo ba re ga ke bue sentle ke re batho ba Mogoditshane ba ye go thubelwa. Nako e ba neng ba eme fa pele ga front-end loader, heela! nna ke ka mo gokolela ka ya go mmaya fale, because those plots di ne di segilwe e le tsa land board go tshwanetse gore go ye go bewa batho. Those guys ba land board went go aba ditsha tseo, land board fa e tshwanetse gore e ye go abela batho ba e ba biditseng, ga go na sepe se e se ba abelang. More than 500 plots di tserwe ke batho ba e leng gore they were not eligible.

So, kgang e rra, o e tsisitse ka nako e e tshwanetseng. Ke kopa gore batho ba go kileng gatwe ba a thubelwa bale, plots tseo, o bona gore go ne go le motlhofo gore go ne go baya bone ma land board, e bo le ditlankana ba di ntsha, ba bo go raya gore ba gokelelwa le metsi le motlakase fela go le bonolo go sena plot epe e e fapogilweng, di tserwe sentle fela ka fa di netlilweng ka teng.

Jaanong golo mo go *clear* gore batho ba Mogoditshane ka fa rra, lefatshe le utswilwe, mme bana ba Mogoditshane ga ba na kwa ba nnang teng, ba nna le batsadi ba bone mo matlong. Ke kgang fela e e bokete, e e botlhoko, e e leng gore o le Mopalamente, a ko o ba bitse le bone le ye *to plan* mmogo, re se ka ra ba *isolate* fa re bua ka kgang ya *audit*, ba na le *information, they will give you the information* gore bomangmang le bomangmang ba ne dira jaana le jaana.

*Honourable* Barongwang, ke lebogela tshutiso e rra gore o bo o tsile ka yone gore kgang e ya Mogoditshane e tle e fele gangwefela. Tota yone e tshwanetse gore e fele, re itse gore Mogoditshane go diragala eng. Batho ba bo 1993 ga ba ise ba bewe, mme lefatshe le fedile kwa Mogoditshane se se utlwisang botlhoko, mme batho ba ntse ba mo *waiting list*. Ke a leboga Modulasetilo, *I support sir*.

**MR J. T. I. MODISE (K GALAGADI SOUTH):** *Thank you Mr Speaker.* Ke ne ke re ke tseye sebaka se le nna go lebogela mogopolo o o duleng wa lefatshe; *Forensic Land Audit*.

Ke simolole pele ke re fa o tsena mo Baebeleng e e boitshepo kwa tshimologong ya lefatshe...

**HONOURABLE MEMBER:** ... (Inaudible)...

**MR J. T. I. MODISE:** Morena Modimo o ne wa neela Adam le mohumagadi wa gagwe Efa, wa re tshimo ya Eden ke eo, le nne mo tshimong ya Etena, mme le leungo le se ka la le ja. Ga diragala jalo, ya re Adam a seyo, mohumagadi wa gagwe Efa a sala a ngatha leungo a sena go le neelwa ke phologotswana e e botlhale thata e e bidiwang gotwe noga. Ya re a tla Adam a bodiwa potso...

**HONOURABLE MEMBER:** Ke Beula.

**MR J. T. I. MODISE:** Modimo o mmotsa gore Adam le dirile eng. Adam a re botsa ene mosadi yo o mo nneetseng. Ga ke ye koo *Mr Speaker*; ke ne ke fetisa *verses* tsa Baebele.

*Land board* e tsenye re na le tshepho e ntsi mo go yone gore *land boards* tsa rona di tlaa direla lefatshe la rona tshiamo, mme se re se bonang gompiano, tshaga e fapogile lerago ka gore dilo di pedi tse re di lemogang mo *land boards* tsa rona, ke *corruption* le bopelotshetlha.

**HONOURABLE MEMBERS:** ... (Laughter!)...

**MR J. T. I. MODISE:** Ke tsone dilo tse di dirang gore gompiano Batswana re bo re lela...

**HONOURABLE MEMBERS:** ... (Murmurs)...

**MR J. T. I. MODISE:** ...ka gore bopelotshetlha le go senyetsa setšhaba...

**MR FURNITURE:** *Procedure.* Ke a leboga *Mr Speaker*. Ga ke itse gore a lefoko le a neng a le dirisa le ke tshabang go le bua, le *parliamentary*. O tlaa nthusa *Mr Speaker*, mme fa e le gore ga le *parliamentary*, ke kopa gore a le boele morago, o santse a le moshia, ke le *Form 1*.

**MR SPEAKER:** O bua Setswana. Tswelela *Honourable* Modise.

**HONOURABLE MEMBERS:** ... (Murmurs)...

**MR J. T. I. MODISE:** Ke a leboga *Honourable* Furniture, kana Setswana sone se dingalo, mme re a bo re re re fete fela ka sone e se gore re a bo re senya sepe.

Mma ke tswelele mongwame, ke supe fela gore se *honourable* a se buang ke gore re tshwanetse go ema ka dinao re le Mapalamente go leka go baakanya. Fa o lebelela *history*, bogologolonyana fale Dikgosi ke tsone tse di neng di aba lefatshe, mme go ne go sena dikgang tse di ntsintsi tse re di bonang gompiano. Maabane fela jaana ka 1976, go ne go baakanngwa tsamaiso ya lefatshe go bo gotwe jaanong *land boards* di a tsena. Ke mongwe wa Mapalamente a gompiano ke ka reng gongwe re ka senka tsela nngwe ra e tsaya, *phase 1* e ne e le ya Dikgosi, *phase 2* ke ya *land boards*, ke tsaya gore jaanong re tshwanetse *to change gears* re ye kwa go *phase 3*. Re senke tsamaiso nngwe e e botoka ka gore jaanong go setse go kgothelesegile gore *land boards* di bo di dira dilo tse e e seng tsone.

**HONOURABLE MEMBER:** Elucidation.

**MR J. T. I. MODISE:** Tlaa ke tswelele mokaulengwe, ke tlaa go neela... (Laughter!)...

**HONOURABLE MEMBER:** ... (Inaudible)...

**MR J. T. I. MODISE:** Se ke buang ka sone, kwa kgaolong ya rona ya Kgalagadi, setlhabi se se tona ke sa dipolase, *residential plots* ke a di bona di na le mathata, mme mathata a teng ke a mokaulengwe Rre Mosanana a setseng a kgabotse ka one a gore bana ba rona le fa ba neelwa *plots* ba a di rekisa, mme gone fela sebe se segolo ke dipolase tsa rona. Fa o tsena kwa kgaolong ya Kgalagadi, o ya go fitlhela e le gore re lwa ka dipolase, mme dipolase tse fa o setse o bona, seemo sa mathata a re setseng re...

**HONOURABLE MEMBER:** Procedure Mr Speaker.

**MR HIKUAMA:** *Procedure.* Nnyaa, mme ke a leboga *Honourable Speaker.* Ke ne ke re gongwe re tle re gakolole, ke raya ke go kopa gore o tle o gakolole *Honourable Tokyo Modise* gongwe o ne a re o a *yield* fela sentle mo *elucidation*, fa ba re gana, a bo a tsaya gore gongwe ke selo se se sa letlelesegeng...

**HONOURABLE MEMBERS:** ...(Murmurs)...

**HONOURABLE MEMBER:** Point of order.

**MR HIKUAMA:** Jaanong mme gongwe fa o ka mo gakolola gore ke ditsamaiso fela tsa Palamente, fa motho a batla go go tlaletsa kana a oketsa *point* e o e buang, *you yield* fela sentle. Ba ba buang ba re gana bao, ba go ruta tsamaiso e e seng yone, e e sokameng.

**MR SPEAKER:** O a itse *Honourable Hikuama* gore fa wa gaeno a emeletse a *debate*, o a bo a *debate* mme gape le ba ba mo letlhakoreng la gagwe ba na le kgatlhego e ntsi mo go se a se buang, le gore maikaelelo a bone a goroge, mme jaanong fa gongwe go tlaa diragala gore e re o *debate*, e re yo mongwe a re *elucidation* fa e le wa gaeno, fa gongwe o kgothatsege gore nnyaa mo tseye. Fa gongwe fa e se wa gaeno, fa gongwe gotwe *no*, tswelala, tlhokomologa yole gore *point* ya gago e tle e goroge. *It is normal* mo *debate*. Ke tsaya gore ditsamaiso o a di itse, o ntse a di bona malatsi a a ntseng a le fa. O a itse gore *to yield* go tswa mo go ene, mme ga go molato gore o kare o le mo Palamenteng *debating*, o bo o ka utlwa bagaeno. Jaanong *Honourable Modise*, ke tsaya gore o a itse ditsamaiso tsa teng, *to yield* go tswa mo go wena, *it is entirely up to you*.

**HONOURABLE MEMBER:** ...(Inaudible)...

**MR J. T. I. MODISE:** Tanki *Mr Speaker.* Mo botshelong re nna re ntse re gakololana. *Honourable Hikuama* o siame o nne o gakolole, mme fela ke tsaya gore bontsi ke a ingapangapela, ke ntse ke a di lemoga.

**HONOURABLE MEMBERS:** ...(Laughter!)...

**MR J. T. I. MODISE:** Ee, ke ya teng koo, mo e tlaa reng golo gongwe jaanong o bo o sa tlhole o itse gore o ka tlhola o nkgakolola eng.

**HONOURABLE MEMBERS:** ...(Laughter!)...

**MR J. T. I. MODISE:** O re nnyaa ke *master*.

**HONOURABLE MEMBER:** Re tsamaela gone koo.

**MR J. T. I. MODISE:** Ke ne ke itebagantse le ya dipolase gore rona...

**HONOURABLE MEMBER:** Elucidation.

**MR J. T. I. MODISE:** ...kwa Kgalagadi South re lwa ka ya dipolase. Kana dipolase tse, o tlaabo o fitlhela e le gore fa di tserwe ke batho ba letso le lesweu, e se gore *I am a racist*, le e tshwerwe ke rona beng ba naga, e bong rona *indigenous* Batswana, o tlaabo o fitlhela e le gore bone ka ba na le dithata le *foundations*, ba sale ba tswa kwa ba tla ba na le madi a *grandfathers* tsa bone ba e leng gore ba na le madi a mantsintsi, ba kgona gore dipolase tsa bone ba di tlhabolole. O bo o fitlhela e le gore bontsi jwa rona ba e leng beng ba naga, ka ga re na madi a dithoto tse di kalo, fa re ntse re bona melao e e batlang gore re nne le dituelo, kgantele o bona gore polase e e ntsenya *stress*, ke gore ke e rekise, re bo re boa re di rekisetsa bone ba bo ba di tsaya. Jaanong ka bogologolo rona go ne go tsomelwa koo, tsone dipolase tse gompiano di teng, diphologolo tse re neng re ntse re na le tsone, *are captured*, di tsentswe mo dipolaseng tsa batho. Jaanong potso e gongwe le nna ke e ipotsang, legale tsamaiso gongwe e tlaa tla e ntlhalosetsa, gore mme tota diphologolo tse fa di tsene mo dipolaseng tsa maburu, rona re ne re itse gore ke *wild animals*, gompiano *the ownership* ke ya me ke le mong wa polase kana ke tsa rona re le Batswana. Ke tsaya gore e tlaa re fa go ntse go dirwa *forensic audit* tsone tseo tsa *land*, gongwe karabo eo ke tlaa tla ke e bona mo *report* gore ke tsa ga mang. Gompiano re latlhegelwa ke diphologolo tse di ntsi, fa re neng re ntse re bona diphologolo teng, ga re di bone.

Le bana ba dikole malatsi a fa ngwana a bodiwa kwa sekolong gotwe nkwarela *domestic animals* tse pedi, o tlaabo a go kwalela a re *lion and zebra*, o bo o beela ngwana *wrong* ka *content* e e teng mo dibukeng, mme ngwana kante o bua boammaaruri ka gore o tlhola a bona *zebras* tseo fa Botswana Defence Force (BDF) fa Mogoditshane, o a itse gore jaanong nnyaa *zebra* e ruilwe. Wena o le morutabana ka gore *content* e e koo, o beela ngwana wa Modimo *wrong*, mme re na le bana *who are very good*, ba bona dilo tse, *observation* ya bone e ba raya e re phologolo e *is a domestic animal*, e ruilwe.

**HONOURABLE MEMBERS:** ...(Laughter!)...

**MR J. T. I. MODISE:** Ya bofelo ke wela ka gore, ke tlaabo ke beilwe *syndicate in a communal area*, go bo go bewa batho ka fa thoko ga me ba bo ba teratela. Fa

ke re ke ya kwa *land board* gore kana baagisanyi ba me ke ba ba teratetse, a le nna ga se gore le nneele tetla gore ke teratelele, *land board* e bo e ntsha karabo fela e e tlhamaletseng e re wena ke *syndicate*. Fa re batla *fairness*, dilo tse re tshwanetse re di sekaseke, re emele mo gotweng *all animals are equal*, re se ka ra ikgaoganya re bo re re nnyaa yo o ka se ka a teratelele, yo ka gore ke motho yo o nang le dithata ene o ka teratelelela. Ka mafoko a a kalo...

**MR LUCAS:** *Elucidation.* Honourable Tokyo Modise o bua kang e e molemo thata ya gore, sengwe le sengwe se na le nako ya sone. O ne a supa gore go kile ga nna le nako ya Dikgosi di aba lefatshe, ga nna le nako ya *land boards*, jaanong go gorogile nako ya gore go tle se sengwe gape. O bua kang e e bothokwa thata Honourable Tokyo Modise, e bile o gaisa le ba ba ntseng ba le fa ba le ba gologolo ba. O mošha o tla ka go amogela gore tota dilo tse dingwe di fetilwe ke nako.

Se rona re a tleng re se bue ka kwano ke gore, go tlhokafala a Land Management Authority which is manned by professionals, di tle di kgone go aba lefatshe. Ke lebogele megopolo ya gago ya gore nako ya Dikgosi le *land board* e fetile, jaanong ke nako ya Land Management Authority. Ke a leboga.

**MR J. T. I. MODISE:** Tanki Honourable Lucas. Ke tsaya gore fa o bua se se molemo se se ka isang lefatshe pele, ga re na gore mogopolo ka gore o tswa kwa go wena o le mo letlhakoreng la kganetso, re tlaa o amogela ka gore rona re batla go direla Batswana sengwe le sengwe se se boammaaruri. Jaaka o ne o utlwa Honourable Segokgo a supa gore, *manifesto* wa (UDC o tsepame o na le thulaganyo e, e rile a simolola a *present* o buile ka yone. Mokaulengwe le wena re lebogele kgakololo eo ya gago.

Ke wele ka gore ke eme mogopolo o nokeng 200 per cent, go ye go sekwasekwa *land board* e se gore ngwana wa ga ope o tlaa ba a tlhoilwe. Kana Batswana re na le tumelo ya gore nako e nngwe fa o sekwasekwa, o tsaya gore o tlhoilwe o setswe morago. Ke ntse ke reeditse *clips* tsa monna mongwe a ntse a re, batho ba mo setse morago, go sena batho ba ba mo setseng morago, go setswe tsamaiso ya boammaaruri morago. Ka mafoko a a kalo *Mr Speaker, I support* mogopolo o. *Thank you.*

**HONOURABLE MEMBERS:** ... (Applause!)...

**DR DOW (KGATLENG WEST):** Ke a leboga *Mr Speaker*, ke a leboga mosutisi wa Tshutiso e, le ka fa e tlhabolotsweng ka teng. Ke emela go ema Tshutiso e

nokeng ka botlalo. Tshutiso e e tlaa senola dilo tse di farologaneng, la ntlha e tlaa senola gore a go na le ope kana bape ba ba dirileng melato, mme ba tlaa tselwa dikgato. E tlaa senola gape jaaka Motlotlegi Tokyo Modise a ntse a bua gore, a tsamaiso e re tsamaisang ka yone gompiano go aba lefatshe, a ke yone e e tshwanetseng gore re tswelele ka yone kana re e fetole. E tlaa senola gape gore, a mme mathata gongwe ke melao, a re baakanye molao gore ka mokgwa o re tsamaisang kabo ya lefatshe ka teng, a ke gone mo go ka re isang kwa re batlang go ya teng.

E tlaa tlhalosa gore, ke eng go le thata go utswa *passport*. *Land board* fa e fetsa e go fa setlankana, ke bukana fela e e tshwanang kana dipampitshana tse di tshwanang le *passport* le Omang, tse di go fang dithata dingwe. Ke eng go le thata gore motho a itirele *passport*, mme go se thata gore motho a direle yo mongwe *lease* ya *land board*. Re ithute kwa maphateng a mangwe a ba nang le *security features* dingwe tse di dirang gore go se ka ga nna le bogodu jo bo tshwanang le jo kana go tlhoka tshiamelo. Ke eng go le thata gore o kgone gore o itirele a *tittle deed*, potso ke gore Attorney General lephata la gagwe la *titles* ke eng le sireletsegile ka botlalo, mme kwa *land board* go sa sireletsega ka botlalo. Re ithute mo go tsone tseo, maphata a a teng a a amanang le go fa batho dithata, jaaka ke bua ka *title deeds* jalojalo, re ithute gone foo.

Tiriso ya maranyane mongwe o ne a bua ka yone kgantele, e bothokwa thata. Maranyane a fokotsa gore dilo di se ka tsa tsamaya sentle, gape a senole dilo, *transparency* e nna thata kwa maranyaneng go kgona gore go itsiwe gore *who punched here* fa a direla Motlotlegi Dr Dow *certificate, resolution* kana jang, ka gore go na le *date stamp* le go supa gore ke mang yo o neng a tsene mo maranyaneng ka nako e gotweng mang. Ke tsaya gore se se tona ke gore, fa re fetsa re tshwanetse gore re itse gore tota mathata a fa kae.

Re ka ema fa ra omana gore batho ba rekile lefatshe, batho ba rekisitse lefatshe, potso ke gore fa le tsenela kwa teng a le tlaa fitlhela e le gore mme gone a ba ne ba tsuolotse molao kana molao ke one o letlelelang gore lefatshe le rekisiwe ka tsela e e ntseng jang. Fa e le gore go ntse jalo, re batla gore re kgaole thapo e fa kae. Melao e e kgone go diragatswa ya gore fa o filwe setsha sa mofuta o, ga o ka ke wa se rekisa mo dingwageng tse kae kana jang. Ke tsone dilo tse re ka di botsang, gore tota a mme motho yo ene yo re ka lela ra re a o ka rekisa tshimo ya ga mmago ya bofelo. Fa e le gore molao o a

mo letlelela, go tllile go nna thata gore rona re ka mo emisa.

Go na le kgang e nngwe e e etleng e buege kgantele *Honourable* Mmusi o ne a bua ka yone, mme e bo e kete fa a setse a botswa potso ga a tlhomamisa ka yone. Ya bonno *versus* masimo, gore ke eng se se tshwanetseng gore se nne bokete go na le se sengwe. Betsho la ntlhantlha a re dumeleng gore lefatshe jaaka *Honourable* Ramogapi a ne a bua kgantele, ga le oketsege. Modimo ga a tle go tla go le oketsa, ga le ka ke la *apply for extension* kwa go ene gore a le oketse, le feletse fa le feletseng teng, *unless* le ya kwa ngwedding. Boamaaruri ke gore motho o tshwanetse gore a nne golo gongwe, bonno bo a tlhokafala le fa o agang teng. Go tshwanetse gore fa o lemang teng, gore go nne le dijo. Jaanong potso ke gore fa dilo tse di *compete*, ke eng re tsaya gore ya go nna e kwa godimo ga ya temo. Kwa mafatsheng a mangwe o tlolela ka kwa, re ile kwa mafatsheng a mantsintsi a e leng gore fa tshimo e le teng foo, a go a patalesega gore e tsewe kante ...(*Inaudible*)... o tlolele ka kwa ga tshimo, jaaka go le teng kwa mafatsheng a mangwe. Re ipotse gore pele ga o tsaya tshimo ya motho o re ka gore o batla gore o e kgaoganyetse batho ba bangwe gore ba nne gone foo, ka le bone ba tshwanetse gore ba nne le kwa ba nnang teng, yo o mo fang naga ene..., ke gore o tsaya tshimo ya ga Rre Modise mongwe, ga ke reye Rre Modise yo, ga ke reye wa Ngaka ke raya Modise mongwe fela ka gore ke *surname* e e motlhofo gore ke e dirise ka bo Modise ba bantsi. Fa o tsaya tshimo ya ga Rre Modise a le fa Tlokweng, o bo o e putlaganya o e neela batho, batho ba bone ba nang le masimo kwa Leshibitse, a o *fair* mo go ene gore o mo tsele tshimo ya bofelo, gompiano gore o bone tshimo ga go motlhofo. Jaanong potso ke gone foo gore, a mogopolo o o neng o le teng wa gore e re bogolo o mo tseela tshimo, o e putlaganyetsa batho ba bangwe, o mo fe sengwe se e kareng kamoso le ene... mo fe *plots*. Go molato eng gore o mo fe *plots* di le *four* kana *five*, ka gore o a bo o mo fa boswa jwa bana ba gagwe fela jaaka bone bale. Yo o mmayang kwa Tlokweng kana Mogoditshane, o na le tshimo gape kwa Malotwaneng. Fa re tshwantshanya bonno le temo, re ipotse gore ke eng re tsaya tshimo e, re e tsaya mo mothong yo re re ka gore e tshwanetse...

**MR SPEAKER:** Heelang, le diga *quorum* lona ba le tswang.

**DR DOW:** Ke raya gore ke buelela *honourable*, ke tsaya gore *Honourable* Dikoloti o tlaa dumalana le nna gore tota fela ga a dumalane gore *production* ya gagwe, nako le nako e kgamelediwe kwa morago kwa go senang

ditsela, metlakase le ditlamelo, gore fa tshimo e le fa gare ga motse mme e dirisiwa, fa e le gore go lemiwa ka tsela e e leng gore ga e *pollute* lefatshe, ga goreng, go molato ka eng gore le e pote ka kwa, gore batho ba ba lemang ba, ba nne gaufi le kwa ba rekisetsang teng kante kwa batho ba b aba rekisetsang, e se gore nako le nako *production areas* di bo di nna kgakala kwa go senang ditlamelo, mme gongwe e ne e ka nna mo teng.

Go pala eng gore fa e le gore o batla go tsaya tshimo kana motho ga a e dirise, o mo *encourage* gore a e rekisetse motho yo o tlaa e dirisang e ntse e le tshimo fa gare ga Mogoditshane, Mochudi, Kanye, Takatokwane kana Tsabong? Ke tsaya gore kgang e ke yone e leng gore a re se ka ra dumalana fela gore bonno nako le nako bo tshwanetse gore bo fete...

**MR HIKUAMA:** *Clarification.* O tshwere kgang e e utlwalang. Se o se buang ke gore masimo a botlhokwa fela jaaka bonno. Ga go pale gore re nne le tshimo fela mo Mogoditshane, e sa tsewe ke *land board* gore a e neele batho go nna. Golo mo go supa gore o batla gore go nne le phetogo ya dikakanyo mo go rona babusi le banni ba lefatshe la Botswana, gore ga go molato go nna le tshimo e ntse e le mo Mogoditshane. Ke tsone dikakanyo tse o eletsang gore di fetoge mo go rona ba rotlhe.

**DR DOW:** Ke a go leboga. Tota ke sone se ke se buang gore ga go molato gotlhelele gore o bone dijwalo di phaphasela fa gare ga Mogoditshane. Se ke se buang gape ke gore lefatshe la Botswana le lekana le la France le Texas. Mathata ke gore re le aba jang. Lone ga le tlhaele gotlhelele, ga le ise le tlhaele, le santse le le lentsi thata. Go na le batho ba ba reng jaanong go ngotliwe dijarata go nne bo 20 by 20. Betsho, fa re dira jalo, re santse re na le lefatshe. A re se ka ra fetola ngwao ya rona ka gore fela fa o dira jalo, o fetola ngwao ya rona, o mpateletsa gore jaanong fa ke fitlha ke ye kwa kerekeng kante kwa hoteleng. Fa ke nyadisa ke ye go batla kwa hoteleng. O fetola ngwao ya me, ka gore o batla gore ke tshele jaaka motho yo o kwa Lontone. Ga ke batle go tshela jaaka motho yo o kwa Lontone. Ke santse ke na le lefatshe le ke ka tshelang jaaka Motswana ke le mo Botswana. O batla gore kamoso o bo o tla o mpoletlela gore ke ye *to the park*, mme *park* ya me e ne e kile ya bo e le fa pele ga me fa, e le patlelo.

*So, you are asking me to change my way of life. You are asking me gore ka Sontaga, I should take my kids to a park somewhere which you are going to build. My park used to be right in my neighbourhood. Neighbourhood*

*must have open spaces* fa e leng gore bana ba ka tshameka teng, batho ba ka gorogela teng, e kare go nyadisiwa dikoloi tsa *park* teng foo. Ke sone se ke buang gore tota fela a e re fa re aba lefatshe re se ka ra lebala gore re mo Botswana. Gompiano jaana kwa Maun, batho ba na le ditsha fa pele ga noka akere. Ka Setswana noka e a tlhakanelwa. *The bank of the river is for everybody; those are common areas.* Gompiano re dirile megopolo e e tswang kwa America, kwa kae, re bo re tla re baya batho mo nokeng. O kganela motho yo o seng mo nokeng gore a se ka a kgona gore a tle go lema gone foo kana a tle go tsoma ditlhapi gone foo.

Gompiano, ka Setswana re itse gore ga go na yo o bewang mo godimo ga thaba a okamela ba bangwe. Thaba e a tlhakanelwa, ke gone kwa re yang kgonnyeng teng, kana re ya eng teng. Gompiano jaana ba ba nang le madi ba pagama kwa godimo ga thaba, jaanong ba a re okamela. Ke dilo tse e leng gore fa re dira melao e mesha le tsamaiso e ntsha, re di lebelele. *Thank you, Mr Speaker.*

**MR SPEAKER:** Please note that I will be calling the mover to reply at exactly 11:37 a.m.

**MR BAGAISAMANG (SHOSHONG):** Ke a leboga Motsamaisa Dipuisanyo tsa Palamente. Mma ke eme fa Motsamaisa Dipuisanyo tsa Palamente, ke supe gore ke ema nokeng Rraetsho Barongwang ka Tshutiso e a e beileng Ntlo e pele. Maikaelelo a yone e le gore go ye go dirwa ditlhotlhomiso ka se se ntseng se diragala mo kabong ya lefatshe mo dingwageng tse di lesome le botlhano tse di fetileng. Ke bo ke mo lebogele gore a bo a letleletse Ntlo e gore e baakanye Tshutiso e gore jaanong go se ka ga itebagannwa fela le *land board* ya Mogoditshane. Ke leboge gore jaanong tshakatsheko e ya go dirwa go ralala *land boards* tsotlhe mo lefatsheng la Botswana.

Ke supe gore ke batla ke leboge bongwefela jwa pelo jwa bakaulengwe Mapalamente ka fa re tshwereng kang e ya lefatshe ka teng, le ka fa ba sutisang ka teng, ba tlhatlhelela gore tota sekaku se kekela se tswa kwa kae. Bothata bo kwa *management* wa *land board* ka fa go dirwang ka teng. Gongwe le go supa jaaka Rre Morolong a ne a supa le Rre Motaosane gore go se ka ga lebelelwa fela batho ba ba fa, go lebelelwe thata bodiredi jotlhe jo bo tsayang karolo mo kabong ya lefatshe. Ke rata ke supe gore jaaka fa Rre Mathoothe a ne a bua fale, re batla gore le rona Tshutiso e e ye go ama thata kwa pitseng ya kwa kgaolong ya rona. Ke okametswe ke Shoshong Sub-Land Board, *which reports* kwa Serowe

Motsamaisa Dipuisanyo tsa Palamente, kwa Ngwato Land Board, kwa re bonang gore bothata bo tswa teng.

Ke ema Tshutiso e nokeng ka gore gompiano jaana, ke dumela gore ke gone e tlaa yang go araba dikgang tsa dipolase tse di bewang kwa godimo ga Leetselente kwa go sa beweng dipolase teng. E tla ya go araba dikgang tse ke di amogetseng tsa batlhophi jaaka le ne le supa, ba ba neng ba tseelwa lefatshe mo Mogoditshane gotwe go tlaa tla go bewa bana ba bone. Ba teng, di teng le gompiano jaana, ke di tshwere dikgang tseo. Ba e bileng ba filwe makwalo ka nako e go neng go dirwa *those resolutions* tsa gore re tsaya tshimo ya gago, wena o bo o tla o supa gore jaanong o tlaa tla o ya go bewa le bana. *I have those resolutions* tse di neng di dirwa ka nako eo, mme jaanong gompiano e le gore ga ba kgone go bona tshiamelo eo.

Bogodu jo bo ntseng bo dirwa mo *land boards*, ka di 26 tsa ga *March* ka 2023, fa o bona ke re ke dumalana ke batlotlegi, batho ba ne ba bidiwa ke Mookane Sub-Land Board, ba sale ba ikopela masimo, fa ba tsena kwa ba le 150, ba bo ba ba raya ba re ga go na le fa e le lefatshe fa re tlileng go le baya teng, boang mme le itse gore ke gone jaaka re le beile lefatshe. *People drove from all walks of life* mo Botswana, ba tswa kwa bo Gantsi le Francistown, ba tla ba sikere makono a go neng gotwe ba tle ka one ba tle go bewa lefatshe, batho fa ba tsena ba bo ba ba raya ba re ga go na lefatshe jaanong, boang le itse gore re le beile lefatshe. Ke bo ke bona gore kang e nne *Honourable* Ntsima a e buang ya *cross pollination* go raya gore e teng. Batho bale ba a busiwa e nna o kare ga ba a bewa lefatshe, badiri ba, le bone ba ba ntseng ba tshwere tiro gone jaana, ba ya go ikabela lefatshe leo ka maina a batho bale. Go botlhokwa gore go ye go dirwa tshakatsheko yone e rraetsho.

Re tlhasetswe kwa kgaolong ka fale, ga ke itse gore a *sub-land board* ya me ke gore ke nngwe ya tse di ntseng di sa lemosege kana jang. Ke tlhasetswe ke Palapye Land Board, e baya batho didiba le matamo kwa go tshwanetseng gore go beye Shoshong Sub-Land Board teng. Jaanong go botlhokwa gore go ye go dirwa thulaganyo e e maleba, e e tlhwaafetseng, *forensic land audit*, gore re ye go bona bonokwane le boferere jo bo ntseng bo dirwa.

Ke dumela gore mo e ya go nna tharabololo ka gore jaaka o utlwa bakaulengwe ba bua, jaaka *Honourable* Tokyo Modise a ne a bua, *sub-land boards* ga di na *mandate* wa go baya dipolase. *Main land boards* tsone ka gore di na le dithata, jaanong di baya batho dipolase

le kwa rona re sa tlhomamg (*designate*) gore go ka bewa dipolase teng, mme golo mo go ikabela bone ba ba tshwereng thata gompiano. Ba ba neng ba hirilwe ka thulaganyo e ba neng ba hirilwe ka yone, ba ba emetseng dikgatlhego tsa batho ba ba neng ba bewa foo go se ka fa tsamaisong. Go tshwanetse gore golo mo go tsamaye go ye go tlhodumelwa. Mo ba senang thong gore ba ye go baya polase mo godimo ga diphuphu tsa batho. Ba beile batho dipolase kwa Leetselente, mo godimo ga diphuphu tsa batho ba Leetselente, *that is criminal* Rre Lucas. *An audit must be conducted*, dilo tse di tsamaye di ye go ntshiwa. Ba ba tswang go bewa dipolase go se ka fa molaong kwa godimo ga motlhaba, re etla kwa go bone. Ke dumela gore thulaganyo e e tla e le maleba gore jaanong e ye go senola, e ye go busetsa lefatshe la batho ba Moralane le le tserweng ka thulaganyo ya gore go bo go ne go sa dirwe dilo ka fa tsamaisong. Jaanong go maleba gore go ye go nna ka tsela e e ntseng jalo.

Ke sone se ke emang fa gore ke dumalana le wena rraetsho gore thulaganyo e ya gore go ye go dirwa *land audit* e bo e ya go tla mme e akaretisa lefatshe le lotlhe ka gore tumelo ya rona ke gore re se ka ra ya go itebaganya le *a symptom* re tlogela bolwetse ka kakaretso. Ke sone se ke dumelang gore go ye go dirwa *a holistic land audit* mo lefatsheng la Botswana. Re ye go atumela *land boards*, re ye go atumela *the surveyor*. *All surveyors must be audited*, go ye go tlholwa gore ba na le lefatshe kae.

Thulaganyo ya *cross-pollination* e tshwanetse gore e tlhodumelwe. Se se diragalang e le boammaaruri ke gore golo mo ke bolwetse jo e leng gore bo teng mo makalaneng a rona a Puso. Fa e le kwa dikhanseleng tsa ga Rre Motshegwa, ba ba abang *tenders* fa ba le kwa Mahalapye, ba di neela ba gabone ba ba kwa Jwaneng. Le mo *land board*, go ntse jalo, ba abelana lefatshe ka kwa, ba itshegela dirwe go bo go twe tsaya ka koo o nneele kwa, e bo e nna o kare bone fa ba leng teng ga ba senye, boammaaruri e le gore ba a senya. *So, there is a lot of criminal injustice* e e leng gore e a dirwa kwa *land boards*. Re tshwanetse gore re tsholele boammaaruri jo mme Tshutiso e e tshwanetse gore e dirwe. Jaaka bakaulengwe ba ne ba na le letshogo la gore gongwe re tlaa bona kae madi a go reng le a go reng, lefatshe jaaka mokaulengwe a ne a bua, *it is a great asset to the nation* ya Botswana. Re ka mpa ra ya go dira sengwe le sengwe go bona gore re batla madi a a ka yang go dira *audit* gore re ye go bona gore Batswana kwa bofelelong jwa letsatsi ba bona tshiamelo ya lefatshe le le mo diatleng tsa palo potlana ya ba e leng gore gompiano

ba le tshwere. Ke dumalana le wena mokaulengwe, ke a go *support* ka thulaganyo e e ntseng jalo gore re fetise *Motion* o, o tsamaye o ye go dira *audit* ya ka fa lefatshe le ntseng ka teng.

*A lot of people have been disadvantaged* gompiano, ga ba na lefatshe. Le ba ba neng go dirilwe *resolutions*, ga ba na lefatshe. Ba bangwe ba sale ba tshwara makwalo ka nako e ke neng ke tsholwa gone mo Gaborone. Le gompiano ba ntse ba tshwere makwalo ao, ba nna ba tewa gotwe feta o dire “ke a tshela” o supe gore a o fetotse *addresses* kana jang...

**HONOURABLE MEMBER:** A o raya ka 2000?

**MR BAGAISAMANG:** Nnyaa, ga ke le 2000...

**HONOURABLE MEMBERS:** ... (Laughter!)...

**MR BAGAISAMANG:** Re tshwanetse gore re tlhodumele thata mo dikgannyeng tse go bonwe gore kwa bofelelong jwa letsatsi Batswana ba ya go bona lefatshe la bone ka ke jone boswa fela jo e leng gore re na le jone mokaulengwe.

Ka a le kalo Motsamaisa Dipuisanyo tsa Palamente, ke a go leboga. Ke dumela gore e tlaa re kwa bofelelong jwa thulaganyo e, lefatshe le le tseetsweng batho ba ba kwa kgaolong ya me le ba boele le bana ba bone, gongwe go tle go thuse le Tona wa *Lands* gore jaanong go ye go nna le *speedy allocation* ya lefatshe le e leng gore gompiano jaana ga le kgone gore le abiwe, go dikgangkgang tse di santseng di tshwere ke thulaganyo e. Ka a le kalo, mma ke go leboga Motsamaisa Dipuisanyo tsa Palamente.

**MR MOROLONG (KGATLENG CENTRAL):** Ke a leboga *Mr Speaker*. Ke emela fano go ema nokeng mokaulengwe ka *Motion* wa gagwe o a re o beileng pele. Kana *mandate* wa *land board* o mongwefela e bile o motona, ke wa *to manage and administrate tribal land* mo lefatsheng la Botswana. Ke one *the core mandate*.

O gakologelwe gore Tautona o a tle a re omanyane re le Mapalamente gore tiro ya rona e tona ke go dira melao...

**HONOURABLE MEMBER:** ... (Inaudible)...

**MR MOROLONG:** Wa re Tautona o a aka Hikuama?

**HONOURABLE MEMBERS:** ... (Laughter!)...

**MR MOROLONG:** Ke yone tiro e tona ya *land board*.

**HONOURABLE MEMBERS:** ... (Murmurs)...

**MR MOROLONG:** Kana jaanong *Mr Speaker*, ke mo mathateng a gore ga ke itse gore fa ke eme jaana...

**MR SPEAKER:** Order! *Honourable Members*, Order 58.4, le tshwanetse gore le reetse *Honourable* Morolong thata, le se ka la mo itaya tsebe le buela kwa godimo. Jaanong le wena o se ka wa *address side remarks*, o lebe nna kwano, o bule le nna, Order 51.1.

**MR MOROLONG:** *Mr Speaker*, ga ke tseye gore go maleba gore motlotlegi le fa gotwe *side remarks* bathong, ga ke a tshwanela go utlwa... motlotlegi re mo utlwa fela rotlhe fa ke bua kgang ele a bo a re Tautona o a aka. A mme go maleba tota bagaetsho, re didimalele Rre Hikuama?

**MR SPEAKER:** Ga go maleba gotlhelele.

**MR MOROLONG:** Ke kopa o mo kgaleme, ke tlaa nna fa fatshe.

**MR SPEAKER:** Tsweetswee, o se ka wa *address side remarks*.

**MR MOROLONG:** Ke a leboga. Tiro e tona ya *land board is to manage and administrate* lefatshe, ke yone *the core mandate* ya *land board*. Ke tsaya gore batlotlegi ka fa re ntseng re araba ka teng, re supa gore gone moo go a pala, ga ba go kgone mmaarona Mma Dow, ga ba kgone go dira tiro e.

Re itse gore go na le dikgwetlho, tse dingwe ke tse ba di tsalelwang ke rona re le batho re le baikopedi, *we acknowledge* diemo tseo.

Fa ke ka go fa *background* fela ya kwa ke tswang teng kwa Mochudi, go tswa fela kwa morago kwa, o tlaa utlwa botlhoko *Mr Speaker*. A le a itse gore sekole sa Ba Isago se ka bo se agilwe kwa Mochudi? A le a itse gore sepatela sa Bokamoso se ka bo se agilwe kwa Mochudi? Mme ka mabaka a *land board* ka fa e dirang dilo ka teng, ga re kgone go amogela le bagwebi ba ba tshwanang le bone bao. Le gompiano dikgang tse di ntidising thata, e re ntswa ke lediswa le ke tse di amanang le *residential applications*, ke dikgang tsa bagwebi ba ba tlang go gweba kwa Kgatleng. Re tlhokana le bagwebi mme *land boards* tsa rona ke sekgoreletsi *in facilitating* bagwebi gore ba gwebe mo motseng wa rona.

Go na le *policy* ya Land Administration Procedures Capacity and Systems (LAPCAS) e re neng re solofetse gore ke yone e ka thusang *land boards* tsa rona go itse gore mang o na le eng, fa kae e le lefatshe, mang ga a na eng fa kae, fa e ka nna lefatshe le e leng gore gongwe

e ka nna lefatshe le e leng gore go ka thusiwa batho ka lone. Lenaneo le ga le dirisiwe gompiano, ke lone le le neng le ka thusa. Fa *land boards* di ka bo di ne di itebagantse le lone di ka bo di se mo mathateng a ba leng mo go one gompiano.

*Mr Speaker*, bo Tautona ba pele le bone ba amiwe ke kgang e. Kwa lefatsheng la rona le le nnyennyane la Kgatleng, namame tse ditona di ne tsa itshegela lefatshe ka fa Mmabe, di ne tsa ipha dirwe mme Bakgatla ba sena lefatshe. Ke sone se ke reng ke rotloetsa gore *forensic audit* e se ka ya tshaba bo Tautona ba pele bagaetsho. Fa e le gore ba ne ba abetswe lefatshe sentle, ga go molato mme fa e le gore golo gongwe ga ba a le abelwa sentle, go molato, ba tle ba tseelwe dikgato.

**MR LUCAS:** *On a point of clarification*. Ke a leboga *Mr Speaker*. O kare kgang e Rre Morolong o e boelela gantsi ya bo Tautona ba pele. Kana ba bantsinyana, jaanong kgantele o tlaa tloga e kete o ba akaretsa botlhe. A o batla ba tlhotlhomisiwa botlhe kgotsa go na le yo o mo akantseng?

**MR MOROLONG:** ...*(Laughter!)*... Ke ne ke sa itse gore tsala e ya me ya Mmirwa ke ntotlha. *Mr Speaker*, ke kopile gore a *forensic audit* e se ka ya bofelela ba ba tlaabong ba e dira matsogo ka fa morago. Fa e le gore e ka felela e ya kwa go bo rraarona Seretse wa ntlha, ga go na le fa e le mathata. Kana e bile rona re le Bakgatla re sale re tsiediwa fela ka Kgatleng, gatwe go na le kgang ya ka losika, gongwe le yone e ka re thusa gore lefatshe la rona la Bakgatla le re boele go tswa kwa Serorome go ema fa le leng teng.

*Mr Speaker*, ke kopa go bua kgang e mme ke itse gore gongwe e tlaa ntosa le bagaetsho. Bagarona, a re bueng boammaaruri fa pele ga Modimo, re botoka ba dikgaolo tse tsotlhe tse di mo Botswana. *Districts* tsotlhe tse di mo Botswana re botoka gona le Batlokwa bagaetsho. Ga se gore ke tswa *from Motion Mr Speaker*, Batlokwa ba mo mathateng, ga ba na lefatshe. Ke ne ke re ke kope Dikgosi tsa rona tsa *districts* tse di gaufi le Gaborone le Tlokweng gore re ba fe boroko. A re ipitlaganyeng le bana ba batho bagaetsho, Batlokwa fela ba ba tshotsweng mo Tlokweng, Balete, Bakgatla le Bakwena, a re akanyatseng Batswana ke ba, ke barwarraarona. A re ipitlaganyeng le bone mo kobong e le nngwe, re ba fe boroko. Dikgosi tsa me tse di tlotlegang, sekasekelang Batlokwa sekidi. Ke ka leboga thata fa mongwame Kgosi Kgafela fa jaaka a tla jaana a ka reetsa kgang e, a batlela Batlokwa sekidinyana mo Kgatleng yo o seyong, bogolo ra tsena mo ntlong le bone. Mme *strictly*

Batlokwa ba ga Kgosi Gaborone ba fiwe lefatshe ba tle ba bone boroko ka tsela e e...

**HONOURABLE MEMBER:** Clarification.

**MR MOROLONG:** Ke a go neela *Honourable* Segokgo.

**MR SPEAKER:** Clarification Honourable Segokgo.

**MR SEGOKGO:** Tota e ne e le *elucidation*, o tlaa intshwarela *Mr Speaker*. Gone o e tshwere sentle mokaulengwe. Gakere mme tota gone go sa re sepe, ka gore tota rona rotlhe fela Bakgatla le Batlokwa re *descendants* tsa Kgosi Tshwaane, re emeletse mmogo fela, re ile ra kgaogana fela fa Potchefstroom, rona re sala koo, lona le tlaa ka kwano jalo. Re bo re tla re le setse morago, jaanong re morafe o le mongwefela, e tlaabo e se gore ke sepe fela se e leng gore se diphatsa gore re ka kopana ra nna selo sele sengwefela.

**MR MOROLONG:** Ke a leboga Motlokwa. Ga ke bone bodiphatsa mo kgannyeng e, ke dumalana le wena tota. Ke buisiwa se ke lorato le pelotlhomogi, le Bakgatla ke itse gore ba na le pelotlhomogi le lerato la gore ga go ka ke ga nna morwarraarona yo o welang mo isong re mo lebile. Motswana o tshotswe a ntse jalo, Mokgatla o ntse jalo. Ke re ke bue...

**DR DOW:** *Point of elucidation*. Ke rata kgang e o e buang. Ke re gongwe gape o gakolole Bakgatla botlhe, batho ba *south* fela botlhe, gantsi fa batho ba tswa kwa *north* gatwe hee! ba re tseetse masimo, ba re tseetse lefatshe. Ba lebala gore mme rona re ba tseetse diteemane, ke gore lefatshe le ke la rona rotlhe. Re le tlhakanetse fela rotlhe, o tshwanetse gore o nne fa o batlang teng. Ke raya gone gore gantsi go na le ngongorego e ntsi Bakgatla, le na le ngongorego e ntsi le a mpoletlela gore Bangwato ba tsaya ditshimo kwa Dikgonnye. Betsho, ke le gakolola gore ga ke gane, rona re tsaya diteemane le metsi kwa godimo kwa. Lefatshe le ke la rona rotlhe, a re le tlhakaneleng, a re nneng ka kgotso.

**MR MOROLONG:** Nnyaa o a utlwala mmaarona, Mma D. Ke tsaya gore re ntse re e fa batho lefatshe ka tsela e e ntseng jalo. Batlokwa bagaetsho, *is a special case*, ke sone se ke reng ke dira ikuelo mo Magosing, Marara a rona gore a re lebeng morafe wa rona ke o, ke Batswana jaaka rona.

*Mr Speaker*, ke gore fela nako e o re fileng fa e khutshwane, batho ba felela ba fiwa ditsha kwa ba sa

batleng go ya teng. Batho ba felela ba ikopela ditsha kwa ba sa batleng go ya teng. Tota fela ka ntlha ya gore motho o a bo a batla lefelo la bonno, mme e se gore o nale lorato la koo. Ba bangwe ba rona jaaka kwa kgaolong e re tswang kwa go yone ya Kgatleng, fa ba felela ba abetswe setsha *elsewhere within* Kgatleng e ntse e le batho ba rona ba Bakgatla, ga ba felele ba amogelwa sentle koo. Kgang e ke ne ke re o ka bona gore re na le mathata a gore *land board* go palelwa ke go sala *their core mandate* morago, e felela e dira gore batho ba se ka ba ya go nna ka kagiso kwa ba abetsweng ditsha teng.

Re na le mathata le *land board Mr Speaker*, ke gore kgang e e ne e sa batle gore re fiwe 10 *minutes* gore re akgele ka yone. Ke ne ke ka go khurumololela dikgang tse e leng gore fa ke ka di khurumolola fa, o tlaa bona gore tota *indeed* go na le mathata a a tshwanang le a a buiwang ke *honourable* kwa Mogoditshane. Fa a bua ka Mogoditshane, ke ne ke utlwa o kare o bua ka *sub-land board* ya rona ya Mochudi. Ga re robale bagaetsho, ke rata *Motion* wa motlotlegi, ke a itse gore *audit* e tswa go kgabola kwa Mochudi kwa, ke itumelela se ba se dirileng. Ke a leboga *Mr Speaker*.

**MR SPEAKER:** Order! Honourable Members, I now call upon the mover to reply to the debate. Honourable Member, Letlhogonolo Barongwang.

**MR BARONGWANG (MOGODITSHANE EAST):** Nte ke go dumedise Motsamaisa Dipuisanyo tsa Palamente. Ke leboge segolobogolo Mapalamente a Palamente e ya bo 13. Ke ne ke leka go tsaya dipalo tsa gore go buile ba le kae, *I have unfortunately lost count*.

Mo go botlhe ba ba buileng, ke ba ba emang nokeng Tshutiso e. Selo se bakaulengwe, ke a se lebogela, ka gore go supa gone gore re mo moonong o le mongwefela *especially* fa go tla dikgang tse di amang matshelo a batho a letsatsi le letsatsi, ke a leboga fela mo go feteletseng. Ke utlwile ke leboga, e bile ke nona pelo fa e bile le ene Rre Tokyo a supa gone gore kgang e ya lefatshe o e tlhaloganya le go feta, e bile a tlhaloganya thata gore go na le dilo dingwe tse di sa tsamayang sentle kwa tshimologong, e seng fa re leng teng. Gongwe gompiano *we complain* ka se re se bonang gompiano, kana mme bothata gongwe bo tswa kgakala.

E rile fa le simolola batlotlegi, le ne le supa ka fa *Motion* o leng botlhale ka teng. Nna e rile fa ke le reeditse, ke bo ke lemoga gore nnyaa *Motion* o ga o botlhale, o utlwisa botlhoko. O roba pelo, o diga mowa mo go

feteletseng. Fa o lebelela gore re ne re romile batho re ba file boikarabelo jwa go tsamaisa se e leng boswa jwa mongwe le mongwe go balelwa le ene ngwana wa Mogoditshane, yo e leng gore gompiano ga a ikaye ka sepe. Fa o re o a lemoga gompiano, ga go na sepe se a ka ikayang ka sone. Nte ke reye ba Mogoditshane ke re le ne le nthomile gore ke tle ke fetise Tshutiso ya dikgang tsa lefatshe tse di le tsentseng tsebetsebe. Ke lekile Bakwena betsho, mme ke feletse ke patelesega gore mo thomong ya lona, ke dumalane le botsamaisi, gore ka re se *selfish* rona batho ba Mogoditshane, re reetse mongwe le mongwe yo o mo Ntlong e. E bile re dumalane le se ba se akantseng gore gona le gore re itebelele re le ba Mogoditshane re le nosi, gongwe re o atolose. Ke le reye ke re nnyaa mme thomo yone ke e tsisitse betsho, e bile e amogelesegile.

**HONOURABLE MEMBERS:** ...(Applause!)

**MR BARONGWANG:** Ke dumela thata gone gore bontsi jo bo setseng bo akgetse, bo supile gone gore mathata ga a kwa Mogoditshane fela, a gongwe le gongwe. Ke santse ke ka kaya, le dipalopalo di ka kaya gore Mogoditshane o ka fa mosing mo go feteletseng, mme ga go na gore re ka reng, ke ditsamaiso. Nte ke boe ke le gakolole gape gore e rile fa re ipapaletsa ditlhopho tsa 2024, re ne ra ipaya pele gore re eletsa gore re le fe *a decent life*, lona Batswana ka kakaretso, re akaretsa le bone ba Mogoditshane. Ga re ka ke ra go fa *a decent life* o sena lefatshe. Re simolola pele ka kgang ya lefatshe, mme e bile re akaretsa mongwe le mongwe, re se ka ra e tsaya ra e isa kwa Mogoditshane fela e le nosi.

Ke re ka a le kalo, ke supe gone gore ba Mogoditshane re na le lona, ga re a le latlha. Kgang e fela e ke e kopang mo pele ga Ntlo, fela jaaka ke bona le nkema nokeng, ke kopa le tswelele le nkeme nokeng mo kgannyeng ya gore tota tota e remelele ka bokete kwa Mogoditshane Sub-Land Board. E bile gongwe e supe e simolola kwa Mogoditshane. A e re fa e ntse e tlaa jaana, e nne e supe gore *findings* ke eng *land board by land board because* mathata a rona a a farologana jaaka re tsamaya ka *land boards* jaana.

Nte ke supe gore ke itumetse Tona ka fa o setseng o fetotse ka teng, o supile gone gore o nkema nokeng, mme e bile le na le tse le setseng le di dirile tse le le kang gone gore mathata a le itebaganye le one. O supile gone gore ba DCEC, DIS le ba *Land Tribunal* ba setse ba na le keletso tota kana tiro ya go netefatsa gore kgang e, ba e ipaya pele. E bile le supa gone gore mathata a ga se a Mogoditshane a le nosi, go setse go na le *groups*

kana ditlhotšhwana dingwe tse di ikopantseng tse di setseng di kile tsa tla tsa ngongorega kwa go lona. Nte ke go bolelele, fa e le kwa ofising ya Mopalamente wa Mogoditshane gone, ke yone kgang e e leng gore e begwa le go feta, mme nte ke leboegele *support* ya gago.

O supa gone gore mathata one a ke a itemogetseng kwa Mogoditshane, a a akaretsang *double allocations*, *maladministration* wa bone ba re ba romileng, le a itemogetse le lona mo dipatlisisong tse le setseng le di dirile. Golo moo nte ke supe gone gore nnyaa re mmogo.

Go kile ga supiwa gore go na le *National Forensic Audit* e e leng gore *it covers* le Kweneng. Tota se se setseng se builwe gone fa se supa gore nnyaa e ne e sa batle Kweneng a le nosi, jaanong e ne e batla gore go akarediwe lefatshe lotlhe, mme e bile go supe gone gore e tlaa re fa e boela fa moragonyana, gongwe e nne botoka ka gore *it is not going to cover 10 years, it is going to cover 15 years with clear terms of reference* tse e leng gore ke dumela gore di tlaa tla di tlhalosiwa.

Gongwe fa ke ka tsamaya ka bongwe ka bongwe ga go ka kgonagala. Rre Hikuama o supile gone gore go akarediwe kgaolo ya Maun le Tawana Land Board. Ke dumela ke re a fa e fetotsweng ka teng, e go arabile ka gore o ne o supa gone gore rona re lela ka *double allocation*, kwa go wena wa re go na le *four times allocation*. Go raya gore mathata a, a a kekela fa re ka tsenelela kwa teng mo go tseneletseng.

O supile gore tlhodumelo e e tla a re thusa go re fa boitseanape kana *it will reveal* boitseanape kana e tlaa *demand* gore go nne le boitseanape jo bo tseneletseng. Jaaka mongwe wa mokaulengwe ka fale a ne a supa gore, go na le *tools* tse di ka dirisiwang tse di ka supang ka bonako gore fa sengwe ga se tsamaye sentle, e bile bontsi jwa one e nne maranyane.

Rre Ramogapi o supile gore Tshutiso e tsile ka nako e e siameng, gore se re se tshepitseng Batswana re felele re se fitlheletse. Le nna fela jaaka ke ne ke tshepitsa Batswana kwa Mogoditshane gore, kgang e ya lefatshe ke a itse gore ga e le beye sentle. Ke bua ka Mogoditshane thata ka gore go setse go na le *history* le *records*, tse di supang gore kwa Mogoditshane go setse go kilwe ga dirwa Kgabo Commission. E ne ya felela mo tseleng, mme ke kopa gore jaaka re tlaabo re tsenelela mo tirong e, gongwe re nne le mo go tlaa salang morago gore re bone gore go diragala eng fa re sena go nna re fetisa Tshutiso e. *We need to be having a monitoring tool*, ya gore fa re sena go nna re fetisa Tshutiso e, e nne le ba ba e salang morago. Rre Ramogapi ke leboga thata, kana

le kwa Palapye fela jaaka Mogoditshane, ke nngwe ya dikgaolo tse di supang di na le dikeletso mo go direng *business* kana go nngeng kwa Palapye, Mogoditshane le Tlokweng. Jaanong mafelo a a tshwanang le Palapye le Mogoditshane, a na le mathata a a fetang kgaolo nngwe le nngwe.

Rre Mokgware o supile gore kwa Gabane e bile ba setse ba kile ba bitsa phuthego ya Kgotla, e Batswana ba supileng gore ga se Mogoditshane, Maun le Tlokweng fela, le Baletse ba supile gore re na le mathata a. Ke sone se ka mafoko ale ke reng, re dumalane le gore e akaretse lefatshe ka bophara. O buile ka *demand for compensation* e e *adequate*, e tsamaelana le se se tlaabong se tsewa kana e le lefatshe le tsewa mo Motswaneng.

Ke sebetse se molangwana ka kgang ya *policy* ya 2019, e e reng *one man, one plot*. Fa o ya kwa Kgaolong ya Mogoditshane, *policy* e jaanong o kare ke yone e dirisiwang go tima Batswana ba ba sa bolong go ema lebaka la 30 years. Ke gore o tlaabo o sa bolo *to apply* ka 1994, o bo o nna go fitlhelele bo 2002 o ntse o sa bidiwe o sa diriwe sepe, o sale o filwe *acknowledgement letter*: E bo e re ka 2019 go bo go fetisiwa *policy* Rre Lucas, e jaanong e yang *to apply* e boela kwa morago...

**HONOURABLE MEMBER:** ... (Inaudible)...

**MR BARONGWANG:** Ga ke itse gore e fetisitswe leng, mme ba bangwe ke ba ba supa gore e fetisitswe go le bosigo. Jaanong fa e sena go nna e dirwa ka 2019, e ya go ama wena yo o sa bolong *to apply* ka 1994. A mme Mma Dow, a molao o a tle o akaretse o boela kwa morago kana re dira molao o ya kwa pele. Se le sone jaaka o ne o supa Mma Dow, ke dilo dingwe tse gongwe re yeng go di lebelela, *loopholes* di teng di dintsi. *Loopholes* tse, *impoverish* Batswana ka bokete. Gompiano, re ntse pelotelele re sa bue ka kgang e, mme jaanong fa ke lebile dikgang tse di tsenang kwa ofising ya Mopalamente, bontsi e le ba jaanong *those who are cleaning waiting list* ka *policy* ya 2019, *they are cleaning waiting list* e e dirilweng ka bomo e go neng go kile ga tswalwa fa moragonyana. *I remember* fa ke fetsa Form 5, ke se ka ka bua dingwaga...

**HONOURABLE MEMBERS:** ... (Laughter!)...

**MR BARONGWANG:** ... Ke bo ke re mma ke ye go ikopela lefatshe, ke bo ke fitlhela go tswetswe.

**HONOURABLE MEMBER:** Ka 2000.

**HONOURABLE MEMBERS:** ... (Laughter!)...

**MR BARONGWANG:** Fa go tswetswe jaana, kana go raya gore jaanong ba *session* eo ba ba neng ba tshwanelwa ke gore ba nne le lefatshe, gongwe jaanong ba phatlalala le Mogoditshane o otlhe, ga ba kgone go tla ba ikopela lefatshe kwa ba eletsang go nna teng. Kana re le batho ba Mogoditshane kana re le gope kwa re tswang teng, *we have the right of identity and* kwa re tswang teng *it is our right of identity*. Ke eletsa go supiwa ke le motho wa Mogoditshane, fela jaaka Mma Dow o etle o nne o itshupe jaaka o le motho wa Dikwididi. Mma ke kopele batho ba Mogoditshane gore, fa o bona re ne re kopa lefatshe kwa Mogoditshane ka 1994 re ne re re re batla go supiwa re le batho ba Mogoditshane, re tle re kgone re itshupe ka ngwao e le nngwe fela. Jaanong gompiano seemo se re leng mo go sone re iphithlela rona ba re kopileng ka 1994, balaodi ba basha kana batsamaisi ba basha ba tsile ka molao, kana ke molao kana ke *policy*. O ne o supa gore ke *policy*, ga se gore ke molao. Jaanong botsamaisi bo dirisitse *policy* e, *to deny* se se tshwanetseng Batswana. Le *policy* e, a re e lebeleleng ke ikuela mo go lona bogogi gore gongwe *policy* e, re e *reverse*. Re e *reverse* ka gore Batswana ba le bantsi ba setse jaanong re ba tlhokela dikarabo, re ba arabela ka kgang ya *policy* ya 2019 e e reng *one man, one plot*.

Jaanong fa o ka lebelela kwa dikgaolong dingwe tse di tshwanang le Mogoditshane le Tlokweng, tse di fitlhelwang mo gotweng *Greater Gaborone*. Ga se rona re ikopetseng go nna kwa Mogoditshane, *it is nature*, jaanong le motho yo o tlang a tswa kwa Maun a eletsa go tla go nna kwa Mogoditshane, go nna le *pressure* mo godimo ga banni ba Mogoditshane. Ke sone se maloba ke neng ke supa gore, *we cannot breathe* kwa Mogoditshane ka kgang ya gore re gateletswe ke dikeletso tsa batho ba ba tswang kwa ntle ba tla go nna mo Mogoditshane, fa go tswa fa go bo go *apply* gotwe *one man, one plot*. Kana go raya gore nna yo ke sa bewang kwa Mogoditshane kwa ke neng ke letsa teng, gongwe ke bo ke felela ke kopile kwa Moshupa ke bo ke fiwa lefatshe kwa Moshupa, ke santse ke emetse go bileliwa lefatshe la Mogoditshane. Jaanong go raya gore lele la ntlha le ke neng ke eletsa gore e nne lone le le ntshupang gore ke motho wa Mogoditshane, ke Mokwena, *I have been denied that right*. Ke raya gore re le Puso ya ditshwanelo, *the right of identity* e tshwanelwa ke gore e lebelelwe. Mo nakong e e tlang ke tlaa kopa gore le ba Mogoditshane ba lebelelwe gore fa go setse go tla go tsena mo kgannyeng e ya go aba mo *waiting list* ya gompiano, go lebelelwe gore a mme bone ba ka se ka ba fiwa *the first preference*. Ke a itse gore re

sutisitse phetolo e ya gore molao o o akaretse Botswana jotlhe. Ke bona go le kaone gore bao ba ba nthomileng ke gatelele mafoko a bone ka sebaka se, ka gore go na le bothata jo bo feteletseng kwa go ba ba nthomileng.

Le wena Rre Bogatsu o supile gore le na le mathata a a tshwanang le rona, thatathata kwa Kopong. Ke bona gore Kopong e tshwana fela le Mogoditshane le Palapye e na le kgatelelo e e feteletseng, o supa gore go na le *maladministration*. O supa gore o kile wa kopa mongwe wa a senior official gore a re tle re kopane re lebisane mathata a, mme a go gana. Kana fa o bona re batla gore *the officials* tsa *land board* re ba bitse, gore a mme a e seng tota ke bone ba itseng boammaaruri jwa gore lefatshe le kwa kae. Fa gongwe rona re le Mapalamente ga re kgone go gobelega gore fa o le *Government official* ke go biletsa kwa ofising ya me, o a patelesega gore o tle kwano re tle *to address* mathata a batho, ka gore ba *report* koo, rona re koo. Re leke ka bojotlhe gore Palamente ya bo 13 e supe gore Mopalamente o na le dithata, *especially* fa go tla go buiwa dikgang tsa batho, ka gore ga re bue dikgang tsa batho re kopa tlhopho, re a bo re setse re bone tlhopho, ra a bo re re ye *to solve* se batho ba se re romileng. A e re fa re bitsa *these land officials* ba tle, ka gore kgantele e tlaabo e nna o kare re lwa le bone jaaka gompiano gongwe re ntse *specific* re re semangmang le semangmang. Ga se gore re lwa le ope, kgang ke gore go na le a *tool* e e dirisiwang mo Palamenteng, ya *Motions* ya gore jaanong re ka *compel whoever* re dirisa molao.

Mma ke itlhaganelele kwa go Rre Kekgonegile...

**MR SEGOKGO:** *Clarification.* Ke a leboga *Mr Speaker*. Ke rata ka fa o e tshwereng ka teng. Ke gore o raya gore dikomiti tsa Palamente jaaka di na le *powers to subpoena any Government official*, go tla go araba, le wena o le Mopalamente fa o na le *issue* o nne le *powers* tsa gore *you can subpoena any Government official to your office*, go tla go araba dikgang tse di amang matshelo a batho ba kwa Tlokweng kana Mogoditshane.

**MR BARONGWANG:** O bua nnete Rre Segokgo. E ne ya re fa ke ntse ke le mo mosepeleng wa go latedisa kgang e ya lefatshe *before* ke *draft Motion* o, le nna ke ne ka kopa mongwe wa maemo a a rileng, nte ke se ka ka mo supa ka leina ka gore go tlaa tloga go nna motlhofo gore ke bua ka mang. Ke fa a nthaya a re, ke ka go bona ka 7 o'clock phakela. 7 o'clock phakela ke a tsena, a re, ga ke yo jaanong. O a bona gore jaanong o kare go na le... Fa o lebeletse nako e a theogelang ka yone ya 7:30 a.m. a re ke ka go bona ka 7:00 a.m., fa o tla *five minutes later*, o fitlhela a seyo, e bo e nna gore a mme jaanong Mapalamente a tsewa tsia. Jaanong jaaka o bua gone gongwe re dire Tshutiso kana molao o o tlaa ba gatelelang gore fa re ya go bua dikgang tsa

batho, ka gore golo fa ke ne ke sa mmiletse gore re tle go bua tsa bonana kana tsa rona tse di kwa thoko, ke ne ke mmiletsa kgang e, e e leng gore gongwe *we could have solved* re ise re tle mo Ntlong e.

Ke tsene mo kgannyeng ya ga *Honourable Dr Gobotswang* a supa gore o itumetse, mme a re ke moonno wa BCP, ga se wa BCP, e bile ga se wa UDC o ke wa rona rotlhe. Gape e bile ga e tshwane, ke sone se nneng Tautona a re *you are triumphant champions* lotlhe mo Ntlong, jaanong o re o kopanetse Motlotlegi Dr Gobotswang. O supa gore re tlaa kgona, gongwe re leke go baakanya *policies* fa go kgonagalang teng. E bile re tseye dikgato, kana keletsokgolo ya me ke gore jaanong go tsewe dikgato ka gore re setse re kile ra supa gore *commissions* di dirilwe, mme ga re bone maduo a tsone. Tota e ke a e kopa mo go lona le le Mapalamente le botsamaisi le lona Palamente, fa re tlhaelang teng le re thuse. Ke a itse gore ke setse ke kile ka bua le wena Parliamentary Counsel (PC), re buile ka thulaganyo e, ke dumela gore *what we set* re ya go se tsweledisa. Re netefatse gore *immediately* fela fa o sena go nna o fetisiwa ke Ntlo e re simolole go berekela mo go one.

Keletso ke gore fa go kgonagalang teng a batho ba tselwe dikgato, fa e le gore di tlaa ama ope yo o nkitseng kwa Mogoditshane ga se ka lepe re ntse re ditsala, re baagisanyi. Kgang fela ke gore a re direle Batswana se ba se batlang *because* fa re leng teng Batswana ga ba tlhoke sepe fela, *they just deserve the truth*. Ke nako ya gore re latele Batswana re ye go ba bolelela boammaaruri. Fa e le gore go ne go na le phitlhela nngwe, ke dumela gore e ne e sa dirwe ke ba ba mo Ntlong e, gongwe ba ba neng ba e dira ga ba yo ka nako e, e le yone e ba gongwe ba kgonneng go tsena mo Ntlong e gompiano ga ba yo. Jaanong a re fetiseng Molao-kakanyetso o gore re ye go bolelela Batswana boammaaruri gore tota go diragetse eng ka gore sebaka se re leng mo go sone ke sone sa go tlhopho *integrity, our own integrity and this Parliament's integrity over silence*.

Ka a le kalo, nte ke le leboge *once again* gore le bo le supile gore le ema nokeng Tshutiso e, ka fa le e fetotseng ka teng, ke dumalana le yone. Ka a le kalo Motsamaisa Dipuisanyo tsa Palamente, *I therefore move that this Honourable House requests Government to consider instituting a forensic land audit in Botswana covering all land allocation in the past 15 years covering land board officials and employees, Councillors, Members of Parliament (MPs) and Tribal Administration senior staff. I so move Mr Speaker.*

Question put and agreed to.

**MR SPEAKER:** The Motion is adopted.

**HONOURABLE MEMBERS:** ... (Applause!)...
