SPEAKER'S REMARKS

**MR SPEAKER (MR MOATLHODI):** Dumelang Batlotlegi Mapalamente, ke kopa gore le tshube *cameras* tsa lona. Re tle re tseye palo re le bone gore le mmogo. *Order! Order! Once more*, ke a le dumedisa Batlotlegi Mapalamente. *Let us start out business of today with Committee Stage of Government Bills.*

**LEADER OF THE OPPOSITION (MR SALESHANDO):** On a point of order. Mr Speaker, yesterday before the adjournment of the National Assembly, we reached an understanding as the House with the Speaker that, today only Bills that do not have substantial amendments or have no amendments at all will be considered today. Bills with substantial amendments will not be considered today, to allow Members to study the amendments and that they will be discussed at the earliest on Wednesday. Therefore, it cannot be correct Mr Speaker that we now have been given an Order Paper at variance with what we agreed yesterday. I therefore, want to get your direction, if we are proceeding with the Order Paper as is, that you would want to go to Committee Stages for all the 16 Bills contrary to what we agreed? If that is the case, what informed the change to the agreement? If there are no reasons for the change, at this stage I would then propose that you allow for a variation or changes to the Order Paper, so that it is consistent with the agreement we reached yesterday evening. I thank you Mr Speaker.

**HONOURABLE MEMBERS:** ... (Murmurs)...

...Silence...

**MR SPEAKER:** *Sorry Honourable Members, I was still looking at the papers together with my advisors, so that we could respond to Honourable Leader of the Opposition's (LOO) question with the honour that he deserves and the papers that they deserve. Mme ga gona ape mathata ngwana wa ga nkgonne, fa o ne o ka lebelela pampiri ya gago... ke kile ka re ke a go lelets a kgantele, ke fitlhetse o santse o le kwa caucus. Ka gore mongwame o kile a mpolelela gore e rile maphakela wa*

letsa, ke ne ke re ke go tlhatswetse ntlha e re ise re tle kwano. *Your question is very innocuous Honourable LOO. Fa o ne o ka lebelela pampiri ya rona jaaka e ntse, the Bills as they are, the first 10, they have got no amendments. Re dumalane jalo re le bogogi gore re tlaa di tliša ka ga di na dipe dingalo.*

Tse di latelang tse tharo, *each one of them has either one or two innocuous amendments. E o kareng e tlaa nna, ga se dingalo tsa sepe ka gore e tswa mo diatleng tse dintle tsa motho yo montle, ya Financial Intelligence, ke yone e re beileng kwa morago gore e tlaa tsena kamoso Honourable Leader of the Opposition (LOO). Otherwise, ga go na sepe se se tshwenyang. Ke dumela gore re ka simolola tiro ya moso ya gompiono.*

**LEADER OF THE OPPOSITION (MR SALESHANDO):** *Mr Speaker, go phoso gore e re gotwe go dumalanwe gore kgang e tlaa buiwa ka Laboraro, se bo se tsenngwa mo Order Paper ya Labobedi. Ga se tsamaiso, go bo gotwe re se tsentse fela mme re se tsenyetsa Laboraro go le Labobedi, it is Tuesday today. Fa e le gore maikaelelo ke gore e se ka ya tsena and Mr Speaker, ke ne ke tsaya gore le ya number 15 fa o ka e lebelela, e na le ditshetla di le mmalwa that amend it mo Order Paper ya letsatsi la gompiono. Ga se 16 fela, number 15 e na le amendments, a re re di pedi, gongwe go ka twe yone e siame but number 14 di mmalwa. Number 13 di pedi. Re ka dumalana gore tota fela 14, 15, le 16 ka fa tumalanong ya rona ya maabane, di ne di sa tshwanela go tsena mo Order Paper ya gompiono. Re ne re tshwanetse re tsenye number 1 up to 13. I therefore Mr Speaker, move in accordance with Standing Order 30.2 that items 14, 15 and 16 be removed from today's Order Paper. I thank you.*

**MINISTER OF FINANCE AND ECONOMIC DEVELOPMENT (MS SERAME):** O tlaa nthusa ka sengwe before re vote gakere?

**MR SALESHANDO:** Ee fa Speaker a go letlelela ke ka go thusa Pegzozo.

**HONOURABLE MEMBER:** Le thusanya ka eng?

**MR SALESHANDO:** Ke tlaa mo utlwa, ke ready go mo thusa.



**HONOURABLE MEMBER:** A o tla re tima mananeo a Puso?

**HONOURABLE MEMBER:** ... (Inaudible)...

**MS SERAME:** Ke kopa thuso.

**HONOURABLE MEMBER:** Wena kana o mathusagotlhe.

**HONOURABLE MEMBER:** Le thusana fela le le babedi fela koo?

**HONOURABLE MEMBER:** Peggy, ke eng o sa kope thuso mo go nna?

**HONOURABLE MEMBER:** ... (Inaudible)...

**HONOURABLE MEMBER:** O ngwana.

**HONOURABLE MEMBER:** Go ka kgona bo Mole Mole, e seng lona, le basimanyana.

**HONOURABLE MEMBERS:** ... (Murmurs)...

**HONOURABLE MEMBER:** O tshagatshega fela Fox.

**HONOURABLE MEMBER:** O ntse o tshagatshega fela, o a itse gore o dirile dilo tse di ntseng ... (Laughter!)...

**HONOURABLE MEMBER:** A ko o tlogele tsa Ledumadumane monna Sethomo.

**HONOURABLE MEMBER:** Nnyaa, ke di khurumetse molekane.

**HONOURABLE MEMBER:** Tsa Ledumadumane ke di feng, tsa go tlhatswa diaparo?

**HONOURABLE MEMBERS:** ... (Murmurs)...

**LEADER OF THE HOUSE (MR TSOGWANE):** Batlotlegi, itseng gore le mo phefong, setšhaba se le utlwile gore gatwe le mo Palamenteng, le tsere dikgang, yo mongwe o bua se, yo mongwe o bua se. Itseng gore *this is live!*

**HONOURABLE MEMBER:** Nnyaa, re ne re botsa gore a ke lenaneo la Puso go tlhatswa diaparo? A go molato?

**MR SPEAKER:** Fa re na le *Bills* nako le nako, tsothle re a di tsenya, *whether* di na le *amendments* or di sena, ke *procedure* ya rona. Re a di golega mo lenaneong la rona. Ga re ke re sia sepe kwa ntle.

Sa bobedi, se ke se tlhalositseng, *Bill* ya ntlha go ema ka ya lesome, ga gona *amendments* mo teng bagaetsho. Ga gona sepe se se ka ntshang Batlotlegi Mapalamente mokola. *Bill* ya 13 go ya go ema ka ya 15, nngwe le nngwe ya tsone e na le *amendment* e le nngwefela go ya kwa go tse pedi tse di *very innocuous*. *Bill* ya bofelofelo ke yone e re boneng fa re ntse re utlwa jaaka le ne le buisana batlotlegi, ke yone e re boneng go tshwanela gore e re bo kamoso Batlotlegi Mapalamente ba bo ba ka kgona go nna le nako e ntsi go ka e lebelela. Jaanong ke gore ke bona ke tsena fa gare ga tsietsego ya dilo tse pedi tse fa Motlotlegi Moeteledipele wa Kganetso a re jaanong re dire lenaneo sešha re ntshe tse dingwe. Go a nketefalela. Legale ka o beile mo Ntlong gore ke yone e di ntshe, *I am going to put a question as your good self want* gore Batlotlegi Mapalamente ke bone ba dumalane le wena kana ba ganetsane le wena.

**LEADER OF THE HOUSE (MR TSOGWANE):** *Procedure*. Kana motho fa a tswa ka mogopolo a kopa gore go ntshiwe sengwe mo Order Paper, *we must hear the opposing views* gore a go na le ba ba ganelang kana ga go na ba ba ganelang. Re ne re batla go latlhela mo kgannyeng e a e beileng pele, ga ke itse gore a re tlaabo re le mo tsamaisong. Legale ba tlaa go gakolola ka koo.

**MR SPEAKER:** Nnyaa, o mo tsamaisong Motlotlegi Moeteledipele wa Ntlo e. Tota fela ka tsamaiso, ke ka bo ke le reile ka re kana kgang ke eo. Ka o setse o kaile gore...

**MR TSOGWANE:** I want to respond Mr Speaker.

**MR SPEAKER:** Please, do Your Honour.

**HIS HONOUR THE VICE PRESIDENT (MR TSOGWANE):** Ke lebogela kgakololo eo le bogakolodi jo bo tlhamaletseng jo o bo tsereng mo go ba o dirang le bone. Tota go tlaabo go se maleba e bile go sa supe gore re tlhoafetse mo Ntlong e fa e re re buisane *Bills* di dule kwa *stage* sa *Second Reading* di tshwanetse go ya kwa *Committee Stage*, e bo e le gore jaanong re mekamekana le tsamaiso re ntsha Ntlo mo tsamaisong. *Bills* fa di tswa mo *stage* se sengwe di ya *straight to the next stage*. Ke dumalana le wena gore mo go e nngwe e o boneng le wena ka fa tebong ya lona, la bona gore e neele batlotlegi nako ka e na le diphetogo tse dintsinyana tse di tshwanetseng go dirwa, ke bona le dirile tiro e ntle thata. Jaanong fa re ka tla mo go reng re tlaa nna re tla go dira *schedule* sa Palamente re tswetsetse ka Palamente, golo mo go tlaa re ketefaletsa tiro. Go tlaa re ntsha mo tseleng go re ketefaletsa tiro. *Schedule* fa se dule jaaka



se dule jaana, se dule e bile se siame ka gore ke se re neng ra se dumalana. Ga go a twe *Bills* tsotlhe di tlaabo di sena *amendments*, jaaka le boletse gore re lebile tse e leng dipaakanyo ga di nke di nna kalokalo. Le dirile fela ka tlhamalalo. Ga ke bone lenaneo la letsatsi leno e le le e leng gore le ka re tshwenya ra a ja nako e nngwe gape re bua ka lenaneo. Ke gore jaanong re dira lenaneo mo Palamenteng le le tshwanetseng gore le dirwe ke Palamente le botsamaisi jwa Palamente, re tla re batla go le dira gape mo Palamenteng. Ga ke bone gore re tlaabo re siame *Mr Speaker*. Ke ganana le Tshutiso eo ya ga Leader of the Opposition (LOO).

**MR SPEAKER:** Ntlha ya bothokwa e ke neng ke lebetse go e bua Motlotlegi Mothusi Tautona le Batlotlegi Mapalamente, ke e rraarona a e buang, ya nako. *These Bills are timed*, maikaelelo ke gore ka 1:00 p.m. re bo re feditse re sutela Palamente ya 2 o'clock. Re ja nako e nngwe gape ka go leka go dira lenaneo sasha.

**MR LEUWE:** *Point of clarification.* Ke a leboga Motsamaisa Dipuisanyo, *good morning sir.* Ke a tsietsega jaanong ka tlhaloso ya gago *Mr Speaker*. Ke utlwa tlhaloso ya gago gore tota ka tsamaiso jaaka re ne re setse re dumalane gore re ya go buisanya eng ka Laboraro, se ne se sa tshwanela go tsena mo *Order Paper*. Jaanong tlhaloso ya gago wa re ka ga le dire *Bills* tse, re di dira jalo re di tsenya tsotlhe. Jaanong go tlhoka go tlhaloganya ga ga Leuwe ke gore, *is it procedural* mo e leng gore le fa re ne re dumalane se, fela ka gore re tlhola re dira jalo, re ya go dira jalo, kgotsa se se tshwanetseng gore se diragale ke eng? Re tshwanetse *to set precedent* e e leng gore e tlaa re le kamoso re boe re dire gape re itse gore re ne re beile fa godimo ga eng. *I am a little bit confused.* Ke a leboga *Mr Speaker*.

**MR SPEAKER:** *It is indeed very procedural* Honourable Leuwe, ka gore fa re ne re sa di tsenya fa, le ne le tlaa itse jang gore go na le eng ga go na eng?

**MR SALESHANDO:** *Point of clarification.* *Mr Speaker, I think I just want to raise two points. The issue raised by Honourable Leuwe is correct, fa go dumalanwe gore kgang e tsena ka laboraro, ga go na se se go pateletsang go e tsenya mo Order Paper ya Labobedi; that is fact.* A re se ka ra leka go fetola melao. Fa re e tsentse mo Order Paper ya gompiano jaaka re e tsentse, *Honourable Speaker*, fa re ka fetsa sengwe le sengwe *Number 1 up to 15 before 1 today*, ka 2 Order Paper ya re re bo re tsena mo go Financial Intelligence Bill e re rileng ke ya kamoso. Re tlaabo re tswela, ga re ka ke ra ema. Kgang e e buiwang ke Vice President (VP) a re ga re ka

ke ra fetola fa gare, heela! O lebala ka bonako, ke ene a tshelang a sutisa go fetola Order Paper Palamente e tsene. Kooteng jaanong mo go ene ke maemo a gagwe, o tshwanetse a dire a le nosi, fa ba bangwe ba dira, ba a senya. Ga se maemo a gago o le nosi, Standing Order seo sa re *even a Private Member can change*. Se ke neng ke se kopa ke gore *let us be honourable*, re letse re nnile le tumalano gore tse dingwe ga di na go tsena gompiano, fa di ntshitswe di tlaa tsena kamoso. Ga go na mo gotweng ka gore e emetse *committee*, e patelesega go tsena mo Order Paper ya gompiano gore e ye go buisangwa kamoso. *That is incorrect; that is a wrong way of interpreting the Standing Orders. I thank you.*

**HONOURABLE MEMBER:** Clarification LOO.

**HONOURABLE MEMBER:** Ke tsholeditse lebogo *Mr Speaker*.

**MR SPEAKER:** Emang pele bagaetsho, emang pele Batlotlegi...

**HONOURABLE MEMBER:** Ke tsholeditse lebogo *Mr Speaker*.

**MR SPEAKER:** Ke go utlwile Motlotlegi Mopalamente wa Sefhare-Ramokgonami.

**DR GOBOTSWANG:** A lebogo o a le bona?

**MR SPEAKER:** Bagaetsho, kana go mo go lona, ke fa sekai; fa re sena go buisanya Melao-kakanyetso e, go mo go lona le le Batlotlegi Mapalamente. E kare fa re tsena mo *Bill No. 12* la bo le sutisa gore jaanong re dirile go ema fa, tse dingwe re tlaa di dira kamoso, *and is much neater that way for Hansard.*

**HONOURABLE MEMBER:** *Mr Speaker*, ke ne ke kopile *clarification* mo go LOO.

**DR GOBOTSWANG (SEFHARE-RAMOKGONAMI):** Tanki *Mr Speaker*. 2021 (NO. 42 OF 2021)**

**MR CHAIRPERSON:** Honourable Members, let us note that the Extradition (Amendment) Bill, 2021 (No. 42 of 2021) has two Clauses. No amendments have been noticed. I shall therefore, call the Clauses all at once.

**HONOURABLE MEMBER:** Procedure Mr Chairperson.

**MR CHAIRPERSON:** *Jeso yo o bonolo*, what is your procedure Honourable Tshere?

**MR TSHERE:** Mr Chairperson, *ga ke batle go go dubela motshelo, mme maabane re ne re dumalane gore* some of the amendments can be moved on the floor, *tse di nnyennyane.* I therefore, have a minor amendment on this particular Bill, Mr Chairperson

**MR CHAIRPERSON:** Honourable Tshere, you are within your right *le fa o ntubela motshelo.* Please go ahead.

**MR TSHERE:** *Thank you very much Mr Chairperson. No, my minor amendment* ke ya maloba re bua ka yone ya *seven days.* Ke tlhalogantse Tona a tlhalosa gore nako e, ke e e tsewang *for* dipampiri *to be filed by* lekgotla, tse di tlhomamisang gore motho yo o bonweng molato kwa ntle ga lefatshe la Botswana a simolole *to be processed* gore a ntshetswe kwa lefatsheng le le mmatlang. Jaanong re ne re ngongorega thata ka *seven days* re re nako eo e nnyennyane bogolo jang fa re bua ka Botswana. Gongwe re ne re ka se ke re tsenye lefoko *'expeditiously'* jaaka re dirile mo *Bill* e e fa morago eo. **MR TSHERE:** Sorry Mr Chairperson. This is Clause 2, that amends Section 9. If I can read it Mr Chairperson, "the transmission of a warrant referred to in Subsection 3 shall be done within seven days of the receipt of the requisition for the surrender of a fugitive criminal." So, I am talking to the number seven. *Gongwe...*

**MR CHAIRPERSON:** *Ema pele* Honourable Tshere. We do not seem to be together. Order! Order! *Ke go tshwere nna mosimane wa Tonota.*



Clause 1 **agreed to.**

**MR CHAIRPERSON:** Ee, jaanong o ka ntsha ngongorego ya gago ka *Clause 2* Motlotlegi Tshere. Go tswa fa ke tlaa tla ke neela Batlotlegi Mapalamente.

Ke kopa e se ka ya re *seven days*, ka go lebega o kare e siantsha thata thulaganyo ya gore re ntshe Motswana mo lefatsheng. Re e tlogele jaaka molao o o fetileng, o o neng o dirisa lefoko '*expeditiously.*' *Therefore, I move gore the amendment should read, I quote from four, "the transmission of warrant referred to in Subsection 3 shall be done expeditiously upon receipt of the requisition for the surrender of a fugitive criminal."* I so move Mr Chair.

**HONOURABLE MEMBERS:** ... (Murmurs) ...

You should read the section from where it begins, your amendment

is that, Section 9 of the Extradition Act is amended by inserting maybe after Subsection 3 the following new subsection and then you read Subsection 4 with the word '*expeditiously*' appearing where within seven days is and then the record will get you right. Thank you.

**MR CHAIRPERSON:** Thank you LPC. Honourable Member, please do so.

**MR TSHERE:** Thank you Honourable Chair. I think I just did, but let me do it again. I am proposing an amendment on Clause 2 which reads, and I quote Mr Chair, "Section 9 of the Extradition Act is amended by inserting immediately after Subsection 3 the following new subsection." So, now I quote where I have amended. Section 4 Subsection 4, "the transmission of a warrant referred to in Subsection 3 shall be done expeditiously upon receipt of the requisition for the surrender of a fugitive criminal." I so move Mr Chairperson. Thank you very much.

**NUCLEAR WEAPONS (PROHIBITION) (AMENDMENT) BILL, 2021 (NO. 46 OF 2021)**

**MR CHAIRPERSON:** Honourable Members, please note that the Nuclear Weapons (Prohibition) (Amendment) Bill, 2021 (No. 46 of 2021) has three Clauses and no amendments have been noticed. I shall therefore, call the Clauses at once.

Mr Chairperson, the justification for this amendment is to make it clearer by removing the words “and commencement.” I thank you Mr Chairperson and I so move.

**MR CHAIRPERSON:** O e tshwere sentle Tshwene.

**MR MMUSI:** Thank you rotwe.

**MR CHAIRPERSON:** O e tshwere sentle rotwe. *The question is that the amendment be agreed to.*

**LEARNED PARLIAMENTARY COUNSEL:** Okay, if that is the case, then the amendment makes sense.

“(1) Any person other than a specified party or accountable institution, having possession of -





(a) property or economic resources that are wholly or jointly owned, held or controlled directly or indirectly, by a nationally listed person, entity or structured group or by a designated person or entity, including property or economic resources that cannot be tied to a particular act of terrorism, plot or threat;

(b) property or economic resources that are wholly or jointly owned or held by a person or an entity -

(i) acting on behalf of, or at the direction of, a nationally listed person, entity or structured group, or

(ii) controlled by designated person or entity; or

(c) property or economic resources derived from or generated by property or economic resources referred to in paragraphs (a) or (b), shall, without delay, give control and possession thereof to the Receiver.”

Mr Chairperson, the justification of the new Clause 46 (a) (i) has the effect of adding to the list of persons that may have possession of property or economic resources that are a subject of the Act. The Clause introduces new terms, “entity and structured group” and removes “government agency or department” as a holder from Subsection 1. The Government does not hold any property under this Act. I thank you Mr Chairperson, and I so move.

**MR CHAIRPERSON:** Honourable Minister, o itse gore ke batla o dira jang?

**MS SERAME:** Ke di dire tsotlhe?

**MR CHAIRPERSON:** Aha! You read your father’s mind, please go ahead *ngwanaka*.

(b) by inserting immediately after the definition of “virtual token exchange” appearing at page B.430, the following new sub Clause -

“(2) This Act is declared to be a financial services law for purposes of the Non-Bank Financial Institutions Regulatory (NBFIRA) Act.”
