**FINANCIAL INTELLIGENCE BILL,
2021 (NO. 34 OF 2021)**

Second Reading

**MINISTER OF FINANCE AND ECONOMIC
DEVELOPMENT (MS SERAME):** Thank you Mr
Speaker. Mr Speaker, I have the honour to present to
this Honourable House for second reading, the Financial
Intelligence Bill, 2021 (No. 34 of 2021).

Mr Speaker, allow me to provide background and
context before I highlight the Clauses of this Bill. By
way of background Mr Speaker, the Financial Action
Task Force (FATF) has 40 recommendations which are
standard and countries have to comply with in order
to tackle money laundering, terrorist financing and the
financing of proliferation.

The rating of countries against the 40 recommendations
are classified as either compliant, largely compliant,
partly compliant or not compliant. Mr Speaker, during the
assessment in 2017, Botswana was found to have serious
strategic deficiencies in her anti-money laundering and
combating the financing of terrorism and proliferation,
AML/CFT/CFR, Framework. No recommendation at the
time was rated compliant; three were largely compliant,
13 were partially compliant, 23 were non-compliant
while one was not applicable. This led to the country
being grey listed by FATF in 2018 and blacklisted by
the EU in 2020. Remedial action towards being removed
from the grey list and the blacklist became a priority
for the country. This is evidenced by the 25 pieces of
legislation passed by Parliament in 2018 and a further
six in 2018. All these efforts led to Botswana being
removed from the grey list in October 2021, because



we had largely addressed the deficiencies and attained adequate effectiveness in the implementation of the AML/ CFT/CFP measures identified in the 2017 mutual evaluation review.

As at the end of December 2021 Mr Speaker, the country was rated complaint on seven FATF recommendations, largely compliant on 22, partially compliant on eight, non-compliant on two and one was non-applicable. During the on-site visit by the FATF delegation in August 2021, Botswana had made a commitment at the highest level to continue strengthening the effectiveness of its anti-money laundering, combating of terrorism and proliferation financing regime. It is in line with that highest level of political commitment, that Botswana is delivering on its pledge and obligation by addressing the remaining deficiencies. In this regard, all stakeholders responsible for anti-money laundering and combating of financing of terrorism initiatives recently embarked on a holistic review of the Financial Intelligence Act of 2019, to address the deficiencies identified during assessments carried out by the Eastern and Southern Africa Anti-Money Laundering Group (ESAAMLG) and the FATF. This resulted in the proposed overhaul of the Financial Intelligence Act and consequential amendments to several other pieces of legislation.

The amendments are intended to address the 10 recommendations where two are currently rated as non-compliant while eight are rated as partially compliant. The amendments of these laws Mr Speaker will strengthened the anti-money laundering countering financing of terrorism and proliferation efforts in Botswana, and will also put the country in a good position during the next mutual evaluation in 2024.

Mr Speaker, the procedure at ESAAMLG is that after a country has amended its legislation, they are allowed to request for re-rating of FATF recommendations that are still rated non-compliant or partially compliant. Further, the request for re-rating has to be made at least six months in advance of the ESAAMLG taskforce plenary meetings. This means that for Botswana the request for re-rating can only be considered during the September 2022 meeting of ESAAMLG. In its request for re-rating, the country has to submit all other information supporting the request for re-rating to the ESAAMLG Secretariat. This supporting information refers to the relevant laws, regulations or other AML/ CFT/CFP measures that are in force and effect.

It is crucial Mr Speaker that the Financial Intelligence Bill and others be elected expeditiously for the country to submit a request for re-rating in February 2022. It is in this regard that through the Office of His Honour the Vice President, the Speakership was requested for a Special Meeting of Parliament in January before the Budget Meeting.

Mr Speaker, I therefore crave Parliament's indulgence for responding positively to this national duty by agreeing to convene this emergency session to consider these Bills. Going forward Mr Speaker, I expect that further amendments to the AML/CTF/CFP related laws will only be brought about by new changes that FATF will introduce in the global standards.

Mr Speaker, the enactment of the Financial Intelligence Act has caused consequential amendments to other pieces of legislation. These are the Companies Act, The Trust Property Control Act, the Societies Act, Proceeds and Instruments of Crime Act, Counter-Terrorism Act, Criminal Procedure and Evidence Act, Extradition Act, Mutual Assistance in Criminal Matters Act, Biological and Toxin Weapons Prohibition Act, Chemical Weapons Prohibition Act, Nuclear Weapons Prohibition Act, Precious and Semi-Precious Stones Protection Act and the Real Estate Professionals Act. Mr Speaker, my colleagues will present the consequential amendments to the other pieces of legislation.

Mr Speaker, I now wish to highlight the provisions of the Financial Intelligence Bill that has been presented to Parliament. The Bill has eight parts with a total of 63 Clauses. Part 1 overs preliminary matters. Under this part, Clause 2 of the Bill subsumes the definition of beneficial ownership as amended in 2021. The Clause amends the definitions of business relationship and specified party to make them consistent with the FATF and Global Forum Standards and improve readability. Further, the Clause amends the definition of prominent influential person to remove religious leaders.

Further, Clause 2 also introduces new definitions such as the definitions of virtual assets, and virtual assets service providers to comply with the revised FATF standards on virtual assets, and definition of a trustee, protector, risk management systems and tip-off.

Part 2 of the Bill provides for the establishment of the Financial Intelligence Agency. Clause 6 is amended to enable the FIA to disseminate Financial Intelligence spontaneously or upon request to relevant competent authorities.



Part 3 provides for the establishment of the National Coordinating Committee on Financial Intelligence. Under this part, Clause 8 of the Bill serves the memberships of the National Coordination Committee on Financial Intelligence or National Coordinating Committee on Financial Intelligence (NCCFI) at Permanent Secretary level. The Clause appoints the Permanent Secretary to the President as the Chairperson of the NCCFI. Further, Clause 8 expands the composition of the NCCFI to include other critical stakeholders such as the Botswana Defence Force. The Clause further incorporates a mandate of National Counter-Terrorism Committee to NCCFI.

Mr Speaker, Part 4 of the Bill covers the duty to implement programmes and identify customers. Under this part, Clause 17 introduces an obligation to register or license agents for money or value transfer service providers. Clause 24 and 25 prescribe penalties for a person who authorises the establishment of maintenance of anonymous accounts and shell banks or shell accounts respectively.

Part 5 provides for keeping of records. Clause 36 of the Bill enables the FIA to initiate analysis of information on its own initiative based on information in its possession or information received from other sources to generate a suspicious transaction report.

Part 6 provides for reporting obligations and cash transactions. Under this part, Clause 44 increases the period of interruption of a transaction to 15 working days.

Part 7 covers referral, supervision and exchange of information. Clause 48 under this part introduces an obligation to supervisory authorities to prevent criminals from holding controlling interest, be it in management or beneficial owner of entities that they licence.

Part 8 of the Bill provides for general provisions. Under this part, there is schedule one of specified parties which has been amended to include virtual assets, service providers, trust and companies service providers, while schedule two is amended to include the Department of Mines. Schedule three has been amended to narrow the definition of accountable institutions for the purposes of the Financial Intelligence Act.

The reason for that is to ease monitoring and supervision of these entities to improve Botswana's compliance with FATF standards.

Mr Speaker, this concludes my presentation. Mr Speaker, I therefore beg move that the Financial Intelligence Bill, 2021 (No. 34 of 2021) be read a second time. I thank you Mr Speaker.

Mr Speaker, *we have lot of challenges*, COVID-19 *has humbled us*, e re rutile gore re itse gore go ikaega fela mo teemaneng le mo dilong tse dingwe tse e ka tswang e le ditswammung tse dingwe le *tourism*, ga se gone. Re ne re bona Tona maloba a re baya pele kopo ya madi gore o batla go kopa madi kwa mafatsheng a mangwe, mme se ga re ka ke ra se kgona *Mr Speaker*, fa e le gore melao ya rona e e dirisanyang ka tsa madi ga e a nna sentle. Ka jalo *Mr Speaker*, ke sengwe se e leng gore ke ema fano, ke ema nokeng molao o gore re o baakanye. Re tswa kwa dikgaolong *Mr Speaker*, *indeed* batho ba tle ba bue ka *shopping lists*, re tla ka *shopping lists* tse dintsintsi thata. Batlhophi ba rona ba kopile dilo mo go rona, ba re supegeditse matshwenyego a ba nang le one, a mangwe a re a iponetseng. Batlhophi ba rona ba batla matamo go nosa dikgomo tsa bone. *Clinics* tsa bone ga di mo diemong tse di siameng le dilo tse dingwe tse dintsintsi tse ke ka di balololang fa re ne re na le nako *Mr Speaker*. Se se tlaabo se raya gore ka seemo sa madi a rona, itsholelo ...*(Inaudible)*... ga diteemane le tse dingwe jaaka *tourism* jaaka ke sa tswa go bua, di tlhokana le gore di thusiwe ka gore madi ga a mantsi ka koo. Fa re sa dira gore re baakanya molao o, go ya go nna thata gore re lebelebe kwa re ka bonang thuso

teng, kwa e leng gore le fa re ka bona thuso, bangwe ba kgona go tshaba ba re, 'nyaa ga re dire le lefatšhe le re sa le tlhologanyeng gore le dira jang, gongwe re le neela madi a rona *to finance* dilo tse e leng gore ga di a siama.' Molao o ke one o o ka re thusang gore re tsewe mo kgannyeng ya go nna jalo. Batlhophi ba rona ba a lela le baithuti *Mr Speaker*. Ke tsaya gore o ka tswa o bone ba lela ka dikgang tse ba batlang dikokeletso tsa dituelo. Segolobogolo e le go lela gore ga ba kgone go nna mo *hostels*. Dikgang tse di ntseng jaana kana fa di ntse fa pele ga rona, go ya go nna le mathata gore re ka kgona go bona a go ka dira ditlhabololo tseo tse ba di tlhokang.

Sengwe se re eletsang go se dira ke go dirisa lenaneo la Public Private Partnerships (PPPs) gore re nne le boramadi ba ba tswang mo lefatsheng leno le ba ba tswang go sele go tla go re thusa go ka dira ditlhabololo tse di tshwanang le bo *hostels in our institutions*. Jaaka re dule mo *greylisting*, re santse re na le dingwe tse di saletseng kwa morago. Re ka se ka ra kgona ka gore se se ka dira gore ba ba kwa ntle ba ba ka nnang le madi ba tshabe go bereka le rona. Ka jalo, ke sengwe se re tlhokanang le gore re se dire ka bonako. *Mr Speaker*, *terrorism* e a runya mo Southern Africa. Re a bona kwa mafatsheng a re bapileng le rona kwa *the northern part* ya Mozambique kwa Cabo Delgado gore *terrorists* di koo di a senya di dira mathata. Ke sengwe se se supang gore fa re sa itsolopaganya ra baakanya melao ya rona, re tlele go nna ba re dirisiwang, madi a tswa kwa a tswang teng *to finance terrorists* tseo. Ke sengwe se e leng gore rona re ka re sena maikaelelo a go dira dipe tse di phoso, mme fela ba bangwe ba kgona go bona *loophole* *Mr Speaker* gore ba kgone go e dirisa. Ka jalo, ke Molao-kakanyetso o re tshwanetseng gore re o tsibogele, re nne *a very trustworthy nation*. *We are a trustworthy nation but we should also be seen as one*. Dipampiri tsa rona di supe gore re siame, sengwe le sengwe sa rona se ne se siame. Ke sengwe se ke neng ke batla go feta ka sone *Mr Speaker*.

Re-enactment ya molao o *Mr Speaker*, e tsile go tla le bana ba yone; *consequential amendments* tse di tsileng go re thusa. Ga go tle go thusa fela gore ra re *we are filling in the blank spaces* gore FATF e tle e re tseye tsia, ke go dira tse dingwe tse di tsileng go re thusa *Mr Speaker*. Ke mongwe yo o dumelang gore maranyane mo gompionong ke sengwe se e leng gore re le Batswana re ka itshetsa ka sone, mme o fitlhela go le bokete fela thata. Ba bangwe fa re leka go dirisanya le bone kwa ntle, o ka tswa o le a *YouTube*, o dira dilo tse dintle, o



bina hosana o tsenya *videos* tsa gago mo YouTube, kwa mafatsheng ba amogela madi fela sentle go tswa kwa bathong ba ba salang morago, mme rona ofithela re na le *challenge because* batho ba le bantsintsi, motho o ipotsa gore tota yo o binang hosana yo fa ke ntse ke mo tshelela madi, a mme madi a teng a ya go felela a dirisiwa sentle.

Kana batho ba le bantsintsi *they are very careful* gore madi a bone a ba a bereketseng a dira jang. Ke sengwe se se tlaa re thusang gore le rona re nne *part of* dikgang tsa go nna jalo. Batswana ba na le kगतlhego ya go ka dira madi, go ka tsena mo ditlhabolong.

The crypto currency Mr Speaker, e gantsi Batswana ba e itseng thata ya *the bitcoin*, Batswana ba le bantsintsi ba latlhegetswe ke madi mong wa me, ba na le kगतlhego ya go ka tsenelela tsona dikgang tsa *crypto currency*. Ba tsenelela fa gongwe kitso e se ntsi. Fa gongwe e le gone gore ba bangwe ba mafatshe a mangwe ba tla bo ba re nnyaa, kana lona le santse le sa letlelesege, mme tsenya ka *account* ya me gore o kgone gore o dirise *this crypto currency*. Se se ne sa felela se dirile gore Batswana ba latlhelgelwe ke madi a mantsintsi, ba felela ba nna le go sa nna le tshepo. Kana *the train is moving, if we do not become of that moving train*, re salela kwa morago. Dikgang tse di ntseng jaana, di tlile go dira gore re phuthologe le rona, re tseye karolo mo go tsona jaaka o utlwa go buiwa *Mr Speaker, which I may not have time to debate, the virtual assets* gore le rona re kgone gore re tle ka melao e e leng gore e tsamaelana le segompiano. Ke ka jalo ke reng, *this is a very welcome move*.

Mr Speaker, one of the things tse gongwe ke neng ke batla go feta ka tsona ke gore, *we need to encourage* Batswana gore ba kgone go tlhaloganya melao e sentle. Kana fa gongwe melao fa e dirwa batho, ba tsaya gore e direlwa go kgokgontsha ope kana goreng. Kgangkgolo ke gore mongwe le mongwe a dire a phuthologile. Fa melao e ntse sentle fela e tlhomame, ga go na bothata, batho botlhe ba lefatshe ba tlaa itse gore nnyaa ga re itsewe fela ka gore re barata Kagiso, mme le go dirisanya le ba bangwe ke sengwe se e leng gore re a se itse.

Mr Speaker, fa ke tla kwa bokhutlong, *my remark* ke re le Batswana re *...(inaudible)...* le bo ESAAMLG. Ke dingwe tse e leng gore jaaka Tautona a sa tswa go bua gantsintsi, *let us make sure that* re nna *part of* makgotlana a, gore bana ba rona ba ba tlaa bong ba le koo, ba nne ba re tlhaba podimatseba; fa e le gore Setswana se a rialo, ba nne ba re tlhagisa ka dilo tse. *We have one of the best drafters in the world*. Ke sengwe se

e leng gore jaaka Tautona a tlhola a rotloetsa, re tseye karolo mo dikgannyeng tse. Ba ye go bereka gone koo, e nne matlho a rona, ba nne ba re tlhagisa gore re se ka ra tloga ra boela gape re nna *grey listed*. Ke sengwe se e leng gore *we need to encourage that. We have done a good job. I always said and I am saying it now* go ruta Batswana.

Sengwe se ke nnang ke eletsa gore se diragale *Mr Speaker*, ke kgang ya gore Batswana *need to go out. They need to go and join the global village* ba bereke, e re ba le koo ba romele *pounds, Dollars* kwano kwa Botswana. Re batla gore se ba se dire go phuthologile. Kana ke a itse gore bangwe ba ne ba bua le nna maloba ba nthaya ba re nnyaa, kana le fa ke setse 2 Pula ke re ke sendela kwa Botswana, fa ke tsena mo go bo Western Union, gatwe nnyaa mme Botswana go santse go na le dikgotlhangnyana dingwe tse di tshwanetseng gore di fetisiwe pele. *Mr Speaker*, se se tlile go re rontsha gore le rona *economy* ya rona e ka gola. Ke selo se e leng gore molawana o fa o ka fetisiwa, Batswana ba tlile go kgona go ya go bereka kwa mafatsheng a sele. *We should stop being people* ba e leng gore re tsaya gore fa o fetsa *Degree* ya gago, ke gore o bereke mo Botswana. *Encourage them* le toro e ke kileng ka e lora gore jaaka re ba *fund* jaana, gongwe fa madi a ka nna teng, re kgone *to fund them* ba kgone gore ba tsamae, motho a fiwa 6 *months* gore a ye go tshela kwa a yang teng le *return ticket*, e bo e nna *a rotating fund*. A kgone gore a le koo a buse madi ao a thuse ba bangwe. Go ka se ke ga kgonagala fa e le gore melawana e ga e a baakangwa *Mr Speaker*.

Ka jalo, jaaka o bona e bile ke nnile wa ntlha gongwe e bile e ka nna ya re ke fetsa tota ka re a buile, gongwe re bo re fetisa molao o ka gore tota o botlhokwa fela thata. *Mr Speaker, I want to support the Minister of Finance and Economic Development with the Re-enactment of the Financial Bill 24, 2021. I thank you Mr Speaker.*

MR MOATLHODI (TONOTA): Ke tsaya sebaka se motlotlegi Motsamaisa Dipuisanyo tsa Palamente go go lebogela sebaka se o se nkadimileng tshokologo eno go latlhela legonnyana tlhware. *Good afternoon Mr Speaker.*

Ntletla Morena wa me motlotlegi Motsamaisa Dipuisanyo tsa Palamente go leboga le go galeletsa thata Batlotlegi; motlotlegi Mopalamente wa Shoshong *Honourable* Lesaso gammogo le Motlotlegi Mopalamente wa Kgalagadi North, Motho wa mme, Mma Monnakgotla. Ke ba lebogela boikarabelo jo bo kanakana jo botona jo motlotlegi rraarona Motlotlegi Rraetsho Tautona a ba tlhomileng mo go jone.



I further take this time Mr Speaker to congratulate the old and the very tame white horse, very experienced expert on Local Government matters, and he is none other than Kgotla Kenneth Autlwetse who Radio Botswana reported this afternoon that he shall be our new Minister at Local Government and Rural Development, Rraagwe Tirelo. Ke tsee sebaka gape motlotlegi Rraetsho Motsamaisa Dipuisanyo tsa Palamente go leboga le Batlotlegi Matona a masha ba ba tlhomilweng bo Rraetsho Shamukuni fa e le gore ke utlwile radio sentle, mme ke dumela gore ke e utlwile sentle, le botlhe ba ba isitsweng kwa maphateng a Puso a a farologaneng.

Ke batla go tsaya sebaka se go lopa Modimo rara gore kgalalelo e e kileng ya tshishema mo go Moshe a eteletse tšhaba ya Israel e le mo phudugong, mosi wa leokwane o o kileng wa kueletsa mo go Kgosi Solomon go etelelela setšhaba sa nako eo, Modimo rara a di tshololele tsotlhe mo ditlhogong tsa Matona a rona ka ba rwele mathata a lefatshe. Le ene motlotlegi Rraetsho Tautona ke leboegele letsogo la gagwe ene le monnawe, letsogo la gagwe le letona go bo e ne ya re kwa bofelong Modimo wa le kaetsa gore leba fa o se ka wa leba fa. Gangwe le gape ke tshela ke bua motlotlegi Motsamaisa Dipuisanyo tsa Palamente, ka re fa o le mo phathing e e busang, o le mo *backbench*, *all Government backbenchers continue to remain as Ministers in waiting... (silence)...*

Fa ke sena go akgola batsadi ba ba rona Motlotlegi Rraetsho Motsamaisa Dipuisanyo tsa Palamente, ke bo ke lotswe Batlotlegi Mapalamente *across the aisle* gore re tlhotlhome, re tshematsheme kwa morago ga Matona a rona gore re ba thuse go tsamaisa lefatshe, ka le rona ba re seng Matona, *we are charged with responsibility of running this country*. Re tshwere Puso le bone, ba itse gore re a ba thusa. Ke lopele botlhale, *finally* mo ntlheng e, Rraarona motlotlegi Motsamaisa Dipuisanyo tsa Palamente, Mbidzi, a botlhale jo bo neng bo neilwe Kgosi Solomon.

Le wena rraetsho bo tswelele bo le mo go wena le monnao gore Ntlo eno ya tlotla lo e etelele ka botlhale jo bo senang bolekanyetso, ka bopelotelele, bopelotheri le bopelontle jo o ntseng o na najo le bopelonamagadi.

Mme ke leboegele thata le badiredi ba Palamente *for serving this Honourable Parliamentarians so diligently at any time of the year, at any time of the day*. Re a goroga re tswa dikgaolong gompiano, fa ke le kwa kgaolong kwa ke kopa thuso, a ke tshwara ofe mmereki wa Palamente, o tlaabo a re tshwara jalo rra re go batlele thuso, e tlaa re kgantele e bonale. A Modimo o le thuse bana ba rona, le tswelele le tshwara lefatshe leno ka natla.

Coming now to the matter that is before the House, ga re ke a bo ke go akgotse Rra Dineo maloba, o ne o bua botswerere ka ba ka go lopela Modimo gore tswele ... (Inaudible)... ke ba akgola.

HONOURABLE MEMBER: O ne o alela kgang.

MR MOATLHODI: Ke ne ke alela ngwana wa Botate. Fa ke santse ke le mo ditebogong, ke leboege pele, gongwe ke tloga ke felelwa ke nako ke ise ke leboege Tona wa tsa Madi le *Economic Development* go tlhokomela itsholelo, Motlotlegi Mmaetsho Peggy Serame, *and indeed* le babereki kwa lephateng la gagwe ba ba dinatla mo go kanakana. Ba ba tsereng sebaka *to craft this very important, this highly intelligent and easily interpretable Clauses of the new law*. Ke lebogile bongwanaka. Kwa kerekeng e ke e tsenang go na le pina e e reng 'tshwarang thata badumedi, ineeleng go rapela, le bitse leina la ga Jeso ka tumelo.' Ga go motlhofo, lefatshe leno la rona e rile mo malobeng fela jaaka Motsamaisa Dipuisanyo tsa Palamente e kile ya re moso wa gompiano a bua lefoko la botlhokwa a re seriti moriti, lefatshe leno la rona le ntse le wetswe ke moriti o montsho, re tshasitswe. Kana fa o ka re motlotlegi rraetsho, *any of these important Parliamentarians*, ke Rraago Pule, ke ene ke mmonang a apere hempe e tshweu. Wa mo gasa ka boloko, go tswa fa le fa e le mosadi yo o setswerere mmaago Atlega a ka tlhatswa hempe e tshweu e, go tlaa nna go ntse go sala matoditodinyana gore hempe e e ne e gasitswe ka boloko. Lefatshe leno le ne le gasitswe ka boloko ka moriti o o ntseng o re wetse. One moriti o o ntshitse lefatshe la rona seriti.

Gangwe le gape fa ke dira *research* Motsamaisa Dipuisanyo tsa Palamente, mafatshe a e leng gore gangwe le gape a welwa ke moriti o montsho o ke a a senang Puso e ntle. Ke mafatshe a a senang tsamaiso e ntle ya tsa madi le ya itsholelo ya mafatshe a one. Gangwe le gape re a itsege, re tswa kgakala, re tswa goo Lowe re itsege gore lefatshe leno la rona le ntse le tsamaisiwa, re tsamaisa merero ya rona ka botswerere jo bo senang bokankabetso. Lefatshe la rona ke setungwane. Dipampiri tse dingwe fa o di bala Motlotlegi Motsamaisa Dipuisanyo tsa Palamente, tsa re '*the Republic of Botswana remains the jewel of Africa*,' mme ba galaletsa yone tsela e re tshwarang madi le itsholelo ya rona ka yone, *as well as the political stability that has long and continue to reign in this country*. Le fa o bona ke bua Sekgoa jaana Motsamaisa Dipuisanyo tsa Palamente, ke a ikotlhaya e bile ke kopa maitshwarelo. Ke ne ke omangwa kwa kgaolong kwa gatwe ke rata



Sekgoa thata ke bue Setswana. Ke a go leka ka bojoitlhe gore Palamente e ke a go bua Setswana, fa ke palelwa ke lebetse ka Setswana ke tlaa bua ka Sekalaka kana ka Sesarwa, ka tsotlhe ke dipuo tse ke di itseng ka botswerere.

Motlotlegi Mmaetsho Tona, *Clauses*, ditemana, menangwana yotlhe e o tlang ka yone e re simolola go tsholetsa matlho jaanong re leba kwa dithabeng, kwa thuso ya rona e tlaa tswang. Re simolola go tsholetsa matlho gore fa re simolola go apara hempe e tshweu e e iseng e gasiwe ka boloko jaana, re solofela gore babeetsi ba tlaa simolola go kgalhegela go tla go tlhoma madirelo a bone mono mo lefatsheng la rona. Fa go na le selo sengwe se Motlotlegi Rraetsho Motsamaisa Dipuisanyo tsa Palamente le Batlotlegi Mapalamente a tlotla se lefatshe leno le se nyoretsweng, se lefatshe leno le se tlhokang *is creation of employment*. Bana ba rona kwa Shashe Mooke, Mandunyane, Mabesekwa, Loomboko, kwa kgaolong tlhopho ya bothlophi ya Tonota; a ke kwa Ramotlabaki kana kwa kae, ba tlhoka ditiro. Fa re simolola re betla ditsamaiso tse di ntseng jaana, re wela mo lefokong la Setswana le le reng 'sedibeng go iwa ka tsela.' Re solofela gore botlhe ba mafatshe a ba batlang gore ba tle go tlhoma madirelo ba tlaa tla ka pele ka jaanong itsholelo le tsamaiso ya rona le batlathlobo ba ditsamaiso tse ba simolola go re galaletsa. Selo se ka bosone Motlotlegi Mmaetsho Tona, re tshwanetse re kanole sehuba, re kanole phega re ikiteye mo magetleng gore re letleletse batlhalefi ba ba itseng ka ditsamaiso tse gore ba tle go tsena mo lefatsheng la rona gore ba re tlhatlhobe. Ga re a fitlha sepe, ga re lefatshe le le fitlhang sepe, yone tsamaiso e ka jalo e tlaa re dira gore re bonale re le batho ba re direlang dilo mo pontsheng.

Motlotlegi Motsamaisa Dipuisanyo tsa Palamente, motlogolo wa me Motlotlegi Mopalamente wa Tati East yo a bileng a le Tona ya tsa Thuto e Kgolwane, bontsi jwa mafoko ke tshaba go a bua ka gore o ntseetse mafoko a me, ke motlogolo wa me.

Ke batla go tsaya sebaka se Motsamaisa Dipuisanyo tsa Palamente, *once more ke tlhalose my unhidden support on this Bill. My unhidden dedication on the sterling work that the Honourable Minister and her able staff have done. Mr Speaker, I support the Bill.*

MR KEORAPETSE (SELEBI PHIKWE WEST): Ke a leboga Motsamaisa Dipuisanyo tsa Palamente, gore o bo o mphile sebaka le nna ke buise Molao-kakanyetso o wa Financial Intelligence Bill, 2021 (Bill No. 34

of 2021). Motsamaisa Dipuisanyo tsa Palamente, ke simolole fela ka go eleletsa ba toropo ya Selebi Phikwe, bogolo jang Selebi Phikwe o o Bophirima, gammogo le wena Motsamaisa Dipuisanyo tsa Palamente le Mapalamente otlhe a gago le Batswana ka kakaretso, katlego le ngwaga o mosha wa 2022 o o babalesegileng. A Modimo a nne le lefatshe la Botswana, a le nesetse pula, le nne le kagiso le thibibalo go tswa gompiano go ya ka bosayeng kae.

Motsamaisa Dipuisanyo tsa Palamente, ke tlhalose gore re setse re utlwile Tona ka tlhaloso ya gagwe ya gore ke eng fa Melao-kakanyetso e e motseletsele e e tleile mo Palamenteng le gore ke eng re biditswe ka tshoganetso. Maikaelelo ke gore moriti o o neng o buiwa ke *Honourable* Pono Moatlhodi o tswe mo go rona, bogolo jang kang ya *grey listing* e e neng e dirilwe ka ba FATF, e re duleng mo go yone ka di 21 *October* ngwaga o o fetileng. Se se sa ntseng se ntshwenya, *Honourable* Serame o tlaa mpaakanyetsa fa e le gore go nnile le diphetogo. Ke dumela gore ba European Union (EU) *have still blacklisted us as a country at the moment*, ke dumela gore ke *around October 2020*. So re sa ntse re na le one matshwenyego ao.

Motsamaisa Dipuisanyo tsa Palamente, maikaelelo a molao wa *Financial Intelligence* ke gore o thuse melao. O tleile ka ngwaga 2009, maikaelelo a matona e ne e le go lwantsha ka Sekgoa mo gotweng *fiscal and revenue crimes*, ke gore melato e tsamaelanang le madi le itsholelo kana go gopela itsholelo. Re bua ka maikaelelo a go leka go hema melato e e tshwanang le *money laundering* kana go tlhatswa madi a a bonweng ka tsela e e seng yone. Maikaelelo e le gore tse di tshwanang le *fraud and racketeering* di fele. Go utswiwa ga dithoto tsa Puso ke gore, *theft of Government assets, embezzlement and tax evasion*. Melato e e akaretsang ya itsholelo le madi, e ye kwa tlase.

Motsamaisa Dipuisanyo tsa Palamente, a re lebelele gore go simolola molao o nna teng ka 2009 go tla go fitlhelela gompiano, re ntse re le fa kae re le lefatshe? Re ntse re dira jang mo melatong e tshwanang le ya itsholelo kana ya madi. O tlaa gakologelwa Motsamaisa Dipuisanyo tsa Palamente gore dikgang tsa melato ya madi kana e e amang itsholelo e e bothabetsi, e ka diga lefatshe. Ke gore *financial scandals* kana *corporate scandals* ke dilo tse di ka amang itsholelo kwa godimo fa di ka se ka tsa elwa tlhoko. Ke sone se re leng Palamente, re tshwanetseng go tsenya leitlho thata mo dikgannyeng tse di tshwanang le tse. Re a itse kwa mafatsheng a sele dikgang tse di tshwanang le tsa *scandal* sele sa Bernard



Madoff ka 2008. *Scandals* tse di tshwanang le tsa boEnron tsa 2001, Dieselgate kana Emissionsgate tse di neng di akaretsa dikompone tsa Volkswagen (VW). *Scandals* tse di tshwanang le tsa boLehman Brothers ke dingwe tsa dikai tse e leng gore mo mafatshefatsheng re ka di supa gore di ne tsa leswafatsa mafatshe ao. Re a itse gore kwano re ne ra leswefadiwa thata ke National Petroleum Fund (NPF) le Capital Management Botswana (CMB) *scandals* go akarediwa le tse dintsi.

Motsamaisa Dipuisanyo tsa Palamente, lefatshe la Botswana go simolola kwa morago go tla go tsena ka 2009 fa molao o o nna teng, re ne re ntse re le *vulnerable*. Go le bobebe gore re ka nna lefatshe le le tshabelelwang ke *financial and economic crimes*, melato e ya itsholelo. Sengwe se e leng gore se ne se itshupa morago ga molao o o ntse o le teng ke gore, dikotlhao di kwa tlase fela thata tsa melato e e tshwanang le *economic crimes*. *Fiscal and revenue crimes* mo Botswana dikotlhao tsa teng di kwa tlase le gore fa o di tshwantshanya *let say* lefatshe la America; *if you are involved in a financial scandal* e bo o felela o bonwa molato kwa kgotlatshekelo, 30 years o a wela motho a ntse a le kwa kgolegelong. *But* kwano re nna *vulnerable in part because the penalties* kana dikotlhao di kwa tlase fela thata.

Fa o lebelela, go na le diagenteng dingwe tse di kileng tsa lebiswa molato, ba bo ba bonwa molato wa go utswa madi, mme madi ao a ne a le kwa godimo ga *million*. Ga ke gakologelwe go na le ope wa bone yo o kileng a tsena mo kgolegelong *more than six months*, kana fa ke sa fose *more than* ngwaga. Fa o lebelela molato o, o bo o lebelela le yo o utswileng podi kana kgomo, nnyaa oo ke *five years or 10 years* mo kgolegelong. A re baakanyeng dilo tse ka gore Batswana ba a di ngongoregela gore a ba ba utswang *millions* le bone ba ye kwa kgolegelong dingwaga tse di telele. Motsamaisa Dipuisanyo tsa Palamente, go kile ga nna le se sengwe *scandal* sa go utswiwa ga madi kwa Bank of Botswana, ke ne ke santse ke tsena kwa University of Botswana (UB), ke dumela gore ke ne ke dira *second year*. Fa o re o lebelela dikotlhao tsa teng, o re o di tshwantshanya le tsa fa motho a utswile podi kana kgomo, nnyaa o bona gore *fiscal and revenue crimes* batho ba itswela fela. Re le lefatshe, *we continue to be a conduit for illicit financial flows*. Batho ba ba utswileng madi kana ba fetisa madi, ba kgona go a fetisa ka lefatshe la Botswana mme re ntse re nnile le Molao-kakanyetso o. Ga re ise re ye kwa tlase mo dipalong tsa tshenyetso-setšhaba le go gopela itsholelo. Se sengwe se se tlhobaetsang Batswana le go feta ke mo e leng gore ba ba bonweng

molato, bogolo jang ba re tsayang gore re ka re ke *the big fish*, fa ba tsena kwa makgotlatshekelong go lebega ditsheko tsothle di latlhegela Goromente. *Low conviction rate*; ke mathata a matona a Batswana ba a lebeleletseng. Ba ipotsa gore a re tlaa tsamaya re bona *corporate executives*, Permanent Secretaries (PSs) kana batho ba maemo ape fela ba *companies* tse di tonatona, *the Chief Executive Officers (CEOs)* ba ba nnang ba gogagogiwa kwa *courts, big business people*, go nna le *conviction at the end of the day*. Jaanong go na le dipotso tse dintsi gore a go na le mathata a tlhotlhomiso gore *cases* tse dingwe *are politically motivated*? Go na le dipotso tsa gore a ba ba tlhotlhomisang ba itse se ba se dirang, kana ba ba sekisang ba itse se ba se dirang? Ke dipotso tse di tshwanetseng re di arabe Motsamaisa Dipuisanyo tsa Palamente. Se sengwe ke gore, go direla dilo mo pontsheng, re santse re tlhabela re lefatshe la Botswana *notwithstanding enactment of this law in 2009*. Re santse re tlhabela ka go dira dilo mo pontsheng le go arabela se Goromente a paletsweng ke go se dira kana a se dirile.

Motsamaisa Dipuisanyo tsa Palamente, re santse re na le mathata a *wastage and leakages* tse di neng di buiwa ke *Honourable Matsheka, Minister of Finance and Economic Development then*, gore di tsamaela kwa go 37 per cent. Mo e leng gore fa o re o a balela, o fitlhela e le P5 billion o o tsenang *through the cracks* re sa itse gore madi a teng a felela a le kae. Motsamaisa Dipuisanyo tsa Palamente, ke dumela gore fa re lebelela mo Molaokakanyetso o, re tshwanetse *to address* dikgang tse.

Clause 8 e bua gore National Coordinating Committee on Financial Intelligence (NCCFI) yo o tlaabong a e eteletse pele, e tlaabo e le Permanent Secretary to the President (PSP). *My considered view* ke gore, tota fa o lebelela PSP, re bua ka motho yo o arabelang kwa ofising ya ga Tautona. *Let us try to address independence* ya makgotla a a tshwanang le a. Re nna re lela ka Directorate on Corruption and Economic Crime (DCEC), *Ombudsman and Auditor General* gore ke makgotla a a sa ikemelang ka nosi. Financial Intelligence Agency (FIA) e ntse ke makgotla a a tshwanetseng go thusa a a ikemetseng ka nosi a a bonang gore dilo di dirwa ka tshiamo *including even* bagolo ba ba tshwanang le *the President, Vice President (VP), Ministers, Members of Parliament (MPs) and the society at large*. Jaanong fa o tsaya yo e tlaabong e le *Chair* e nna PSP, yo e leng gore *is appointed at the helm and ... (inaudible) ... of the President*, nnyaa, re na le mathata a matona.



Tona, moeteledipele wa FIA, tota o kare o ka bo a tlhomiwa ka tsela nngwe e e faphegileng e go tlaa sekeng go nne bonolo gore re bo re bona se se neng se diragala jaaka kwa DCEC. Mo dingwageng tse tharo, re setse na le *Director Generals* tse tharo e le gore *President can fire and hire* jaaka a batla. Re kile ra bona Office of the President (OP) gape e leka go sutisa *staff* kwa DCEC. *These are the things* tse e leng gore FIA *will remain vulnerable to*, fa e le gore ga re e dire *completely independent*. E tshwanetse e nne *independent* le fa e le gore ga e ka ke ya nna *completely independent but* e nne *independent*. E bo *mandate* wa bone ba o dira ka tshosologo ba sa boife gore motho o ka kojwa kana konteraka ya gagwe ka emisiwa.

Mo *Clause 17* o bua ka *anonymous accounts*; *I think* ya *anonymous* e tshwanetse e lebelelwe thata. Re dumela gore fa go ka nna le kgang, bogolo jang re itse gore bangwe ba tla kgang ya *anonymous* kana *there are some countries* tse di nang le *anonymous*, ba bangwe tota *they are complete, absolute tax havens*. Batho ba kgone ba ise madi gone koo. Fa gongwe re tshwanetse re lebelele gore *what sort of penalties can be meted on those people* ba e leng gore *they are citizens of this country* mme ba felela ba siisa, ba a isa kwa makgotleng a a tshwanang le ao.

Clause 44 e bua ka *reporting obligations*; mo go yone fa ke lebeletse dikgang tsa *reporting of suspicious transactions*, e siame. *Honourable Minister*, at *implementation* se re se kopang ke gore, ga re batle go bona dilo tse e leng gore *reporting obligation* jaanong e fetoga e nna *politically motivated*. Fa e le gore ke *account* ya ga *Honourable Saleshando*, gongwe mongwe a tsenya *donation* ya Botswana Congress Party (BCP), gore tsaya madi ke a o ise kwa BCP, e bo e le gore *is a red flag*. Fa e leng gore gongwe ke *Honourable Segokgo*, *million* a tsena *in his account*, nnyaa ga go na mathata. E kile ya re Tona yo mongwe ka Palamente ya bo 11 ka mo raya fela ke re, “ga ke itse gore babegadikgang ba ne ba go tshaba eng ka go ne ga nna le *whistleblowing* ya gore go na le madi mangwe a a neng a tsena mo *account* ya gago ka nako ya fa re ntse re lebeletse *primaries* le ditlhopho tse dingwe.”

Jaanong dikgang tse di tshwanang le tsone tse, o bona fela gore motho o *receive* madi a a kalo, nnyaa, ga go *raise red flag*, ga go na le fa e le mathata. Ke a itse, fa e ne e le wa kganetso, o ka bo a kile a salwa morago, ga batlwa go itsiwe gore madi a a kanakana a a tsenang mo *account* e ke a eng. So, a re se ka ra bona *politically motivated* e le gore jaanong batho ba setswe morago, mme e le gore ga go na lepele le morago.

Mr Speaker, ke tshwennngwa ke gore, jaaka ke ne ke bua ka kgang ya *independence*, gore *we need to adequately address independence* ya makgotla a a tshwanang le one a. Se sengwe se re tshwanetseng gore re se *address* ke *oversight because in my view, reading through the Bill*, ga ke bone *oversight* e le gore *it is well spelt out*. *I know*, FIA *appears before Statutory Bodies Committee*, ya ga Dr Never Tshabang. *Able-bodied hands* tsa ga Dr Tshabang, ke dumela gore o ka tlhodumela, a bona gore ke eng se se sa tsamayang sentle, ke eng se se tsamaileng sentle. Ke mo tshepha thata fa go tla mo dikgannyeng tsone tseo. *I think he is adequately trained. He has Master of Business Administration (MBA) and three other Degrees* tsa *Chemistry and experience* ya board *memberships*. Ke dumela gore *he is capable*.

My problem ke gore, *oversight* e, *it is not well spelt out* because kana fa o lebelela *mandate* wa komiti ya ga *Honourable Tshabang*, kana *it is to look* gore *budget* e ba e neetsweng a ba e dirisitse sentle. *In terms of delving into the mandate deeper*, re tshwanetse gore bagaetsho gone fa, Palamente re e fe dithata tsa *oversight*. Tota e bile e ka bo re e fa yone Palamente thata ya gore e *recommend* for *appointment*, fa e le gore gongwe *an independent body like the Judicial Commission (JC) cannot appoint the head* wa FIA. Re *enhance Parliamentary oversight*, le *tabling of the report*, e ka bo e dirwa fa pele ga komiti ya Palamente, *to account fully for its mandate*. FIA *should be able to account for its mandate and execution of its mandate, implementation of this Act*, e bo e le gore jaanong ba *appear before a Committee of Parliament, not to just scrutinise or examine the books of accounts as it is the case with the Statutory Bodies Committee* ya ga *Honourable Dr Tshabang*. So that is my submission *Honourable Speaker* with respect to *oversight and accountability* to yone ya Palamente.

Ga ke bone gope fa go buang gore ba ba ka se keng ba dirise maemo a bone sentle a ba a fiwang ke Lekgotla la FIA kana ke molao *which establishes* FIA, gone go raya gore ba ka tselwa dikgato tse di ntseng jalo. *I am not able to see this* go bona gore... *because you see, when you lead or* o le *part of institution* e e tshwanang le yone ya FIA, ke gore kana o a bo o neetswe *power* e tona. E re bonang e le gore *currently power* e, *it is misused* ke lekgotla le tshwana le la Directorate of Intelligence and Security (DIS). Ga re batle a *replica* ya se se diragalang kwa Lekgotlaneng la DIS, *where power and position of responsibility is misused. Misused targeting political opponents* le batho, e le gore lekgotla la DIS le nna le *lose cases* kwa *court*, le nna le sekisiwa



(sued), go na le mathata a mangwe a one a ne a buiwa ke *Honourable Dow*, a re sa bolong go a bua re le ba kganetso, go simolola fela fa lekgotla le le simolola. Jaanong, Motsamaisa Dipuisanyo tsa Palamente, *when we re-enact FIA, we ought to have had in mind* gore ba tlaabo ba tshwere *power* kana ba ntse ba tshwere *power* e tona, e e leng gore fa e le gore ga go na *accountability mechanism and punitive measures* tsa *misuse* ya ofisi, *consequences* tse di ka nnang teng ke eng.

Re bone go begilwe gompieno mongwe wa badirelapuso gore *he lied under oath*, ke gore a *forger affidavit*, a bo a e *submit* a supa gore, ga a re ba re, o *sure* gore go dirilwe *acts of financing of terrorism*, a bo a ntsha *affidavit*. Re bua jaana e le gore ke kgetsi e e kwa mapodiseng, e e isitseng ke General Khama gore motho ke yo o akile mo *affidavit*. Fa o akile mo *affidavit*, o bonwe molato, lekgotla le go atlhotse katlholo e e kwa godimo, ke dingwaga tsona tsa bo *seven years* mo kgolegolong. Re bua jaana e le gore nnyaa, ga go na le fa e le epe kgato e e tserweng. Jaanong *fear* ya rona ke gore, fa o tsaya lekgotla le le tshwanang le la FIA o le *empower*, e le gore *it is a financial intelligence*, a bo e le gore gongwe ba bopela motho kgomo ya mmopa, namane ya yone a bo a e kotelwa, nnyaa, go tshwanetse gore go nne le dikgato fela tse di gagametseng, di tsewe, e bile di *appear* mo Molao-kakanyetsong o. *To fabricate* melato fela gotwe motho *is a terrorist*, go bo go tlholwa go tabogilwe ka ditlholobolo *dramatising* kwa *court*, ke tsona dikgang tse fa go buiwa ka makgotla a a tshwanang le one a bo FIA, re tsenwa ke tsebetsebe ya gore re dira jang. Re ithutile jang mo nakong e e fetileng ka fa melao e e ntseng ka teng.

Motsamaisa Dipuisanyo tsa Palamente, molao wa FIA, ke a bona gore go na le 15 *other pieces of legislation which will augment* kana *their consequential amendments* to yone FIA. Ga re ka ke ra fitlhelela maikaelelo ao, fa re ka se ka ra tlisa Molao-kakanyetso o o tllabololang Corruption and Economic Crime Act *because* bontsi jwa melato yone ya *fiscal and revenue crimes*, kana fa gotwe *economic crime*, e le *mandate* wa DCEC, re a itse gore *mandate* one o, *is captured under the* Corruption and Economic Crime Act. Fa re ka se ka ra nna le lekgotla le le ikemetseng ka nosi la DCEC, le le nonotshitsweng, le na le batlholhomisi ba tlhwatlhwa, le ikemetse ka nosi, le seyo mo Pusong, le na le meno, le sa bogole fela, nnyaa, go tllile go nna thata gore Lekgotla la FIA le fitlhelele *mandate* wa lone. Kana go supa gore *mandate* ya yone e bile e a tsamaelana, ke dumela gore mongwe wa basimolodisi ba lekgotla lone le, o ne a tsewa kwa DCEC, mme gompieno o kare o bereka golo gongwe kwa mafatsheng.

Fa re ka se ka ra nna le melao e e gagametseng, e e lebaganeng le yone kgang ya *fiscal and revenue crimes*, nnyaa, re tllile go tsewelela re lela senajwa, re tllaa lela se bo se kgala. Mme sone se se re tlhobaetsang ke gore tshenyetso-setshaba le go gopela itsholelo di ntse di a gola, di kwa godimo. Ba maemo a a kwa godimo, *conviction rates are very low, such institutions are not independent, they are not accountable to Parliament. Oversight of these institutions is still very low.* Jaanong fa re ka *deal* le tsona dikgang tse, ke tlaabo ke sena mathata a gore Molao-kakanyetso o o tshwanang le one o, re ka o ema nokeng. Ke a leboga Motsamaisa Dipuisanyo tsa Palamente.

MINISTER OF TRANSPORT AND COMMUNICATIONS (MR SEGOKGO): Ke a leboga Motsamaisa Dipuisanyo tsa Palamente. Ke simolola ka go go dumedisa ke re *dumilani* Mbizi. Ke bo ke dumedise le Batlotlegi Mapalamente, ka e bile ke gone re kopanang mo ngwageng o mosha wa 2022. Ke ba eleletsa ngwaga o o nang le katlego, o o tletseng boitumelo. Ke bo ke boe gape ke galaletse *Honourable* Keorapetse, le fa a ntirisa ke le sekai ka tsela e ke sa tlhaloganyeng gore ke eng a dira jalo. Ke mo akgole gore mo bosheng, o okeditse lelwapa la gagwe ka lesea le ke solofelang gore gongwe le na le kgwedi fela kana gongwe go tllola kgwedi.

Motsamaisa Dipuisanyo tsa Palamente, ke dumedise gape ba Tlokweg, ba ba nthomileng kwano gore ke tle ke nne mo Palamenteng, ke tswe lentswe la bone. Mo bogompionong, re bua ka molao o ke dumelang gore o molemo mo go bone, e bile o molemo mo Batswaneng ka kakaretso. O ke dumelang gore rotlhe re tlaabo re dumalana ka one.

Se sengwe se ke batlang go simolola fela kwa tshimologong ke se dira Motlotlegi Motsamaisa Dipuisanyo tsa Palamente, ke gore ke leboge Mapalamente gore mo leetong le re ntseng re le tsaya, la go dira dipaakanyo tsa molao, gore re kgone go ntsha lefatshe la Botswana mo seemong se le neng le le mo go sone sa *grey listing*, tota re ntse re le seoposengwe. Seoposengwe se re ntseng re le sone, re le ngata e le nngwe, se setse se re file maduo a gore jaaka go setse go boletswe, ka di 21 tsa ga *October* 2021, ke fa re ntshiwa mo *grey listing*.

Se se diragalang jaanong, le kopo e e tllisiwang ke Tona wa madi Mme Serame, ke gore tota re konetelele, re tlhomamisa gore go tswa mo *grey listing* e jaaka re dule mo go yone, ga re kitla re boela kwa go yone. Ke sone



se ke santseng ke tlaa kopa Mapalamente gore re nne seopo sengwe seo gore re fetise molao o. Ka mafoko a a ntseng jalo *Mr Speaker*, ke eme kopo e ya ga Tona nokeng ya gore re fetise Molao o o šafaditsweng o wa Financial Intelligence Act.

Se sengwe gape se ke batlang gore ke se senole ke gore, tota gape selo se ke go diragatsa maitlamo a rona a re neng re a tsentse mo *manifesto* wa rona re le *party Mr Speaker*. Fa o ka ntetla ke ka eletsa gore ke nopole fela ka bokhutshwanyane fa re buang ka sone se re se diragatsang gompieno.

MR SPEAKER: Please do Honourable Member.

MR SEGOKGO: *I quote Mr Speaker, this is on page 33 under the Finance and Banking. Under our promises Mr Speaker re bua jaana and I quote, "strengthen financial eco-systems and to enhance compliance with international obligations and standards."* Go na le tse dingwe *Mr Speaker* tse ke neng ke ka di nankola, mme tota sa konokono ke tsholofetso e e neng re e solofeditse Batswana gore re ya go tswelera re nonotsha tsamaiso tsa rona tsa madi, e bile re bo re dira gore mo go di nonotsheng jalo, re bona gore re tsamaisa sentle jaaka mafatshe a mangwe, ka fa seelo se ba se beileng se tlaabong se ntse ka teng.

Mr Speaker, ga se sone fela se re dirang seo ka sone, gore re a bo re batla go tlhomamisa gore re na le gone go tsamaelana le ka fa ba FATF le ESAAMLG, ba supang gore re tsamaisa tsa merero ya madi ka teng. Batswana ba tshwanetse go tlhaloganya gore molao o ka bo one fela o re siametse re le setšhaba, o siametse itsholelo, le go aga itsholelo ya rona. O tsamaelana le maikaelelo a rona a go tlhabolola itsholelo ya rona. Seo ka bosone fela se raya gore molao o ke o re tshwanetseng *to support it*.

Ke batla ke gakolole jaana, kana se re se buang fa ke gore, re leka go thibela madi a e leng gore yo a tseneng mo go ene, a tsene ka tsela e go neng go na le borukutlhi, molato... ke ntse ke bona *Honourable* Keorapetse a remeletse mo go *financial crimes*, mme tota ke dumela gore go atologile, ka gore mo gongwe e a bo e le gore o ka tswa o dira dingwe tse e leng tsa borukutlhi gape, mme e le gore madi a o a bonang ka borukutlhi jo, o boa o a kopanya le madi a e leng gore gongwe ke a dikgwebo fela a a siameng. Ka tsela e e ntseng jalo o bo o a kopanya otlhe, e bo e nna e kete ke madi a a siameng. So tota fela se re tshwanetseng ra se gakologelwa ke gore, molao o o thusa gore o heme borukutlhi ka bophara. Ke

sone se Batswana ba tshwanetseng gore kwa ntleng ga gore re bo re lebile gore *we comply*, ba tlhaloganye gore molao o o re thusa ka ke molao o o thusang go lwantsha borukutlhi.

Mr Speaker, ke batla gore ke re madi a a bonwang ke batho ka borukutlhi, bogolo jang e le dikgwebo, ke madi a a bayang dikgwebo tse e leng gore ra re *they are legitimate business*, tse di tsamaisiwa ka fa molaong, fa ba phadisana le batho ba ba tsayang madi ka borukutlhi...*(inaudible)*... dikgwebo tseo ka fa mosing. Selo se se borai mo go ageng itsholelo ya rona. Madi a a ntseng jaana ...*(inaudible)*... sentle ka fa molaong. Re tlaa nna le seemo se e leng gore jaanong itsholelo ya rona fela ka bophara e ikaegile ka dikgwebo tse e leng gore ga di tsamaisiwe sentle.

Mr Speaker, ke eletsa go supa gore Tona wa madi o ne a supa ka botlalo gore tota e kete ba FATF ba batla gore e re fa re lwantsha borukutlhi jo bo ntseng jaana, jo bo itebagantseng le go tlhatswa madi a borukutlhi kana gore o tlisa madi a go rotloetsa ba e leng bo ntwadumela kana ba re reng ke *terrorists*, tota ba lebile gore bone ba tlišitse go tlhokisa ledula mo setšhabeng. Re tshwanetse ra lemoga gore go na le metlhalenyana e mentsi e e dirisiwang ke batho ba ba dirisang madi fa go ntseng jaana. Ya ntlha ke e ke neng ke bua ka yone e gotweng *blending*, e madi a borukutlhi le a kgwebo fela e e lebanyeng a kopanngwang. Ka tsela e e ntseng jalo ke batla gore ke gatelele kopo e gone e ntse e ntshiwang mo Palamenteng, e le kopo ya gore tota re tshwanetse jaanong re dire gore dikgwebo, bogolo jang tse di tlaabong di na le letseno le le kwa godimo, le re tlaa bayang tlhwatlhwa ya teng, ke sa eletse gore ke e beye gompieno, mme ke ka a fa sekai gore, fa o na le *turnover of above the million* kana bo *five million*, go tlame dikgwebo tse gore tota fela ba tshwanetse gore dituelo tsa bone e bo di dirisiwa go dirisiwa *digital payment*. Dituelo tsa bone e se ka ya nna gore ba amogele dituelo fela tse e leng gore ga di fe motlhala, ke gore ba amogela madi, ga ba ntshe dilo tse di tshwanang le *receipts* jalojalo. Ka gore fa ke gone fa ke dumelang gore botlhabetsi jo bontsi bo nna teng, ka gore madi a e leng gore ke a borukutlhi le a e leng gore ke a kgwebo e e siameng, a kopakopana ka teng.

Madi a borukutlhi kana fela ka fa go dirwang ka teng go dirwa gore go a bo tilwa dilo tse di tshwanang le lekgetho jalojalo. Selo se ke se kopang fela thata ke gore, re fefoge mo go boneng gore tota re leka gore re dirisa metlhale e e botoka ya gore dikgwebo di amogele dituelo gore re tle re kgone go hema seemo se.



Metlhale e mentsi *Mr Speaker*. Go na le gone go dirisa *accounts* tse di kwa ntle ga lefatshe. Fa gongwe motho a tsaya le madi a, a a tsaya fela ka dipalo tse molao o tlaabong o mo leta a feta a a tsenya kwa *accounting* tsa mafatshe a mangwe, a bo a boa a a busetsa jaanong mo lefatsheng a dirisa borenyane, *transferring* jalo. E ntse e le fela go fitlha motlhala wa gore kwa tshimologong madi a tota ga se a kgwebo fela e e siameng.

Mr Speaker, ga ke eletse gore ke nne moleele mo go emeng Tona nokeng, mme ke tlaa re fela gongwe ke ise ke wele ...

MR KEKGONEGILE: *On a point of clarification.* Tanki Tona. Tona, *on your last statement sa money laundering*, motho o ka botsa gore, ke gore seemo se se tshwanang le moeteledipele a fiwa *shares* ke kompone, a di fiwa mahala a sa di reke, go tswa foo *shares* tseo a bo a di rekisa di mo direla *millions*, gone mo o go *classify* fa ka eng? *Bill* e e tlaa kgona go lebelela diemo tse di ntseng jalo ka gore ke dingwe tsa dilo tse gongwe *international organisations* ba di lebileng, ba bona e le gore *indeed it is part of money laundering?* Tanki.

MRSEGOKGO: Ke a leboga *Honourable Kekgonegile*. Gongwe ga ke na go kgona go go fa karabo e e wetseng.

Se ke se tlhologanyang ke gore kana *Bill* e yone e tlhamaletse. Nnyaa, ga gona fa ke bonang *account* ya me e ka dirisiwang gore ke fetisitse madi *to the party. Party* e na le *account* e bile ga e tsamaise ka tsela e e ntseng jalo. MR SPEAKER: Thank you very much Minister. Honourable Monnakgotla followed by Honourable Ramogapi.

ASSISTANT MINISTER OF LOCAL GOVERNMENT AND RURAL DEVELOPMENT (MS MONNAKGOTLA): *Good afternoon Mr Speaker.* Ke leboge bone ba Kgalagadi North ba ke ntseng ke bereka le bone *Mr Speaker*, ke na le diphuthago le bone. Tshutiso e *Mr Speaker*, ke bona e le botlhokwa fela thata ka gore ke mangwe maiteko a bo Tona ba tshwanetseng go dira dipaakanyo dingwe gore di bonwe ke bone ba FATF. E bile ba FATF ba rotloetsa lefatshe la Botswana gore ba di dire go lwantsha *money laundering le financing of terrorism* jaaka re bona mo mafatsheng a mangwe mo Africa, matshelo a bone a le bokete *Mr Speaker*. Ke leboge le bone ba FATF ga mmogo le ESAAMLG go bo ba ne ba sekaseka molao wa rona wa Financial Intelligence mme e bile ba ne ba re rotloetsa gore re baakanye ditshetlana dingwe mo molaong. Ba di lemogile gore go botlhokwa gore tota re di lebelele re di baakanye. *Mr Speaker*, fa go nang le madi teng go batla go tsennngwa leitlho ka gore boferefere bo bontsi.

Motlotlegi Tautona Masisi, Tona Peggy Serame le ba Lephata la *Finance* ba dirile tiro e tona maloba ka *October 2021* ka go baakanya mengwe melao gore ba FATF ba ntshe Botswana *from the greylisting*. *Mr*



Speaker, ke support this Bill ka gore fa Palamente e ka se ke e dumalane le yone, re ya go boela kwa morago. Go boela kwa morago, re ya go boela gape mo bothokong. Fa re boela mo bothokong, mme dilo tse re itse gore di raya eng, di *implicate* eng in our country's foreign investment environment jaaka cross border transaction, go ya go nna bokete gore foreign businesses di kgone go bereka le dibanka tse di mo Botswana. Ke sone se o bonang ke simolotse ka yone gore a re tsenye leitho, a e re re bua re le Mapalamente re lebelele mme e bile re bue re lebeletse matshelo a Batswana. A o Motswana kana mogwebi, dilo tse di ya go re baya ka fa mosing fa re sa di bue sentle *Mr Speaker*.

Dilo tse fa re sa di dire sentle, di tlaa re baya ka fa mosing. Ke bua jaana le ke Mopalamente wa Kgalagadi North mme e bile maloba ke ne ke biditse ba BITC kwa kgaolong ya Kgalagadi North kwa Zutshwa. E le gore re batla gore ba BITC ba re batlele *investors*. Mma ke supe gore ke itumelela gore Puso ga e ise e diege go baakanya molao wa Financial Intelligence ka gore ba FATF ba ne ba ntshitse *updated guidance on*

virtual assets and virtual service providers ka October 2021. Le rona re le Puso, re ne ra dira maiteko ra sala ditshetlana tse morago go baakanya molao o gore *virtual assets and virtual service providers* di nne in line with the ...*(Inaudible)*... *financial institutions*. Re lebelele sentle batlotlegi.

Ke bo ke supe gone gore, molao o o ka kgona go dira *virtual asset service providers* gore ba tlamege to report suspicious transactions and they keep records, le go dira customers' due diligence go lwantsha elicit financial flows; one madi a a tlhatsiwang ao a re sa a batleng... *(inaudible)*... *should be out of the country*. Dilo tse Batlotlegi fa re ka di tsenya leitho, re ka ya kwa pele.

E bile ke leboege gore Tona Serame o tsisitse Tshutiso e pele ga re dira *budget* e re yang go e lebelela go simolola ka October 1st, gore re tsenye leitho mo teng ga madi fela jalo. *Bill* e fa o ka e lebelele sentle, e ya go tsamaisanya le tsone fela tse dingwe jalo. MR SPEAKER: Thank you madam. Honourable Ramogapi.

MR RAMOGAPI (PALAPYE): Ke a leboga Motlotlegi Motsamaisa Dipuisanyo tsa Palamente, ke re mma ke go eleelele katlego mo ngwageng wa 2022 rraetsho le ba lelwapa la gago.

Motlotlegi Motsamaisa Dipuisanyo tsa Palamente, ga go na ope yo o ka ganang molao o, a ema fela a re ga re o batle. Se re ka reng ga re se battle, ke dilo dingwe tse e leng gore di a fatlha mo Pusong ya mo Africa, mme molao one o phepa. Ka go rialo, ke leka go supa gore melao e e ntseng jaana re etle re e fetise re lebeletse lefatshe, gore lefatshe le tlhoka melao e ntseng jaana, mme ba ba busang bone e bo e re kwa thoko ba bo ba tsaya molao o ba o sokamisa, ba o senya, ba bo ba o isa go sele.

Mma ke simolole ka go tsena mo kgannyeng fela ke re, kana fa re lebelela tiro le maikaelelo a FIA gore e na le dintlha di le nne tse e leng gore tota konokono ya tsone e tshwanetse ya di dira. FIA tiro ya yone e tona ke gore e kope kitso nngwe ya madi mo mafatsheng mangwe fela a re ka tswang re bapile le one. Tiro ya bobedi ke gore e bo e e amogela yone kitso eo ya madi. Tiro ya boraro ke gore e bo e sekaseka kitso yone eo ya madi gore *they analyse, request and receive, analyse information*. Ntlha ya bo four ke gore fa ba sena go nna le yone tshakatsheko eo ya kitso ka madi, ba bo jaanong ba e phatlalatsa ba e isa kwa batlhotlhomising ba boammaaruri ba ba tshwanang ba borre Tymon Katlholo; DCEC, ba sepedise, jalojalo. Ke yone tiro ya bone e tona *Mr Speaker*.

O fitlhele go swabisa, e bile go tlhomola pelo e le gore se re se bonang gompiano mo lefatsheng la Botswana, re tshwanetse gore re ka bo re bona FIA e dira tsone ditiro tse, e bile e bo e nna kwa pele mo ditirong tsone tse, e re fa go ka nna le bothata, e bo e re bagaetsho, *we have requested the information about P100 billion*, re kopile kitso gore madi a P100 billion a kae, a dule jang. Ba tshwanetse gore ba bo ba ema kwa pele ba re bolelela gore nnyaa re utlwa fa e le gore gatwe P100 billion o o dule, re sekasekile, ke boammaaruri, madi ao a tsamaile a le kanakana. Ba bo ba tsaya yone *information* eo ba e neela makgotla a bosekise. Mo lefatsheng la Botswana e le teng yone FIA e, fa o re o a e botsa, ba re ga re itse, o itse gore ke eng re tshaba go ikgolega. O bo o bona gore lefatshe la rona ga le tsamae sentle ka fa tshwanelong. Tshwanelo le tsamaiso ke gore ba bo ba re bolelela ba papametse ba re raya ba re re nnile le *information* e e borai thata go sireletsa lefatshe la rona, mme dilo tse *Mr Speaker*, ga re bone di diragala.

Ke batla gore ke tsene ka bofetshwana mo *clause* e nngwe. Go na le *Clause 10* e e supang gore *Minister can declare* gore motho ke *terrorist*. Hee! *Mr Speaker*, ke gore o neela lepolotiki gore le bue gore Ramogapi ke *terrorist* ke emela le ditlhopho ene, o ithaya o re o ka ntesa? E ya gore fela go ise go ise go ye kae, o bo utlwa gotwe nnyaa Rre Boko, Rre Saleshando kana Rre Ramogapi ke *terrorist*, ka gore re bone dilo tse *Mr Speaker*, mo ditlhophong tse di neng di feta. E ne e re fela fa ba bona Tautona Rre Boko wa UDC a feta, gatwe a a eme re mo sekaseka. Dilo tse ke tsone tse ke di buang ke re molao o ga re ka ke ra gana o o ema nokeng ka gore re rata lefatshe, mme moAfrica fa o mo neela dithata tsone tse, o tlaa utlwa. Fa e ne e le sengwe, ka gore mafatshefatshe kana molao o o tswa gone kwa go bone ba FATF e le *recommendation* gore nnyaa mme Tona *can declare* gore motho ke *terrorist*, jaanong ba ba maAfrica bone ga ba itse go dirisa dithata, ba tloga ba re bitsa *terrorists* fela rotlhe re tlala ka ditoronko. A golo fa go sekasekiwe gore mme fa e le gore Tona o ka go bitsa *terrorist* a go iphetlhela, wena jaanong o itse ke kae. Molao o ga o na tetla yone e. Fa re ka neela maDomkrag *blank cheque* yone e, re mo mathateng. Ka boikokobetso, a re lebelelele *Clause 10* gore a mme tota ga e ka ke ya tloga ya dirisiwa botlhaswa.

Ntlha ya me ya bone *Mr Speaker*, ke batla gore molao o e re fa re o sekaseka jaana, re simolotse re tsenya poo e nngwe mo ntlong, mme kamoso re tlaabo re na le mathata. Ke gore re dira DIS e nngwe gape.

O bona molao o o siame mme ga o na *oversight* gore tota gatwe fa ba ka dira dilo dingwe ka phosego, Batswana ba ikuele kae. Re na le bagwebi ba e leng gore *Mr Speaker*, nna kwa kgaolong ya me bagwebi ba ba tlhwaafetseng *accounts* tsa bone *were once frozen*. E bile ka fa ke itseng ka teng Domkrag, dinako tse dingwe fela ke gore mme ke fe sekai ka nna ke ke le Rre Ramogapi jaana; fa e ne e le gore ke moDomkrag ke bo ke re ke eletsa go emala ditlhopho le Rre Tsogwane tsa bodulasetilo jwa BDP. Intelligence Bill ka gore go ne go tlaa buiwa gore naare dilo tse wa re o di tsaya kwa kae. Jaanong gompiano ga e sa tlhole e le molato *to declare your assets* e bile fa o sa *declare*, ga go re sepe gatwe o tlaa nna o rotloediwa fela. E bile yo o ka buang gore *assets* tsa gago di kana, ke ene yo o molato. Ke gore o kgona go bona gore Domkrag ga e ikaelele go baakanya, e ikaelela go senya fela.

Mr Speaker, fa go na le batho ba ba tlaa re tsenyang mo mathateng mo lefatsheng la Botswana ke bagolo ba lefatsho le. Bagolo ba lefatsho le re a ba rata mme re ba gakolole. Fa o ka utlwa mogolo a ntse a re, “ke filwe mpho, *donation* ya bokana”, kamoso, “ke filwe kwa *donations* ya bokana”, ke gore golo mo fela fa le lebeletse Batswana, a gona le motho yo o ka go fang P2 *million* mahala, a go fa P3 *million* mahala? Ga a yo. Dilo tse ke tsone tse re reng kamoso go tlaa bo gotwe lefatsho la Botswana le na le mathata, madi a ne a tlhatswiwa. Re re a dilo tse di lebelelwe, di sekasekwe, go bo go bonwe gore mme bagolo bone ba gakololwa jang gore mogolo ga go dirwe jaana, re a go thusa. A nne le batho fela ba ba mo gakololang sentle.

Batho ba bangwe ba bobedi *Mr Speaker*, ba ba ka tsenyang lefatsho la Botswana mo diphatseng tse ditona ke bahumi. Bahumi a e ka nna ba Botswana, a e ka nna ba South Africa, bahumi ba dinaledi ba ke bone ba e leng gore ke mathata. Kana go na le selo se sesha malatsi a gatwe *state capture*. Ke gore fela fa a batla gore jaanong ene mo dikgannyeng tsone tse tsa go tlhatswa madi tse, o tlaabo ba tshwara Tautona le Puso e e busang, go bo go raya gore dilo tsa bone di feta fela. Ke gore o kgona go bona e le gore Leburu le tla ka diteraka tse pedi fela, kamoso diteraka tsa gagwe di a gakgamatsa mo lefatsheng la Botswana. O bo o ipotsa gore jaanong motho yo khumo e e kanakana e o e tsere kae. Fa o re o a re, o fitlhela e le gore nnyaa o tshwere Goromente o mo fa sengwe le sengwe, *sponsors* Domkrag sengwe le sengwe mme a bo a felela e le gore motho yo ga a molato. Re re a bahumi ba tsennngwe leitlho, go tlogelwe batho ba ba basetlha. Batho ba ba basetlha ga ba ka ke ba tsaya madi a mantshi ba a isa gope, ba ba tshwanang le bo Ramogapi. Molao o thatathata o dirisiwa ke bahumi ba dinaledi ba e leng gore ke ditsala tsa maDomkrag. A golo mo re go eleng tlhoko. E nne bone fela ba le ba tlhodumelang kgapetsakgapetsa. Jaanong re a bo re itse gore one molao o re o fetisa jaana, o a bo o tsoga e le gore jaanong o kgokgontsha Batswana ba Modimo ba ba senang le fa e le madi, ba ba itshwanelang le bo Ramogapi jaana.

Kgang ya bofelo *Mr Speaker*, ke batla gore ke fetse ka yone. A molao o *Mr Speaker*, re se ka ra ya go o dirisa mo dikgannyeng tse di bitswang gotwe *settling old scores* kana *settling political scores*. Ke gore mo e leng gore fa o sa rate motho fela, o tlaabo o re monna yo ga ke mo rate mme jaanong *I will declare* gore ke *terrorist*. Monna yo ga ke mo rate mme jaanong *I will freeze accounts* tsa gagwe. Go tswa foo kamoso fa gotwe motho yo a ye go ikuela, go bo gotwe ga gona kwa a ka ikuelang teng ka gore motho yo a neng a go sekisa... Ke gore motho a go iphetlhela fela, go sena le fa e le kgang fa e teng, le fa e le motswedilenyana. Kana ra re ene motho yo a a tseelwe dikgato. Fa re re motho yo o simololang dikgang a tseelwe dikgato, gatwe nnyaa a a tlogelwe fela. Motho yo gatwe fa a tlogelwe fela, yo o go senyang leina gatwe nnyaa go tlaa duela Goromente. Gatwe fa o na le tshoko go sekisiwe Goromente. Bagaetsho, re tshwanelwa ke gore re sireletse madi a lefatsho la Botswana. Re tshwanelwa ke gore re sireletse madi a e leng gore a teng a dirwa ke rona, ke madi a rona a makgetho ka gore fa motho a dira bohahalele ka bomo, o tshwanelwa ke gore a di arabele. Go na le gore re bo re re jaanong re tlaa mo isa kwa kae, Goromente ke ene a tlaa mo duelelang ka gore o ne a theogetse. Tsone dilo tsa mofuta o ra re ga di ka ke tsa isa lefatsho la rona gope.

Molao ka boone *Mr Speaker*, ra re re a o amogela, o siame. Mathata go a bo go tlaa tla motsaya-kgamelo. Ba a bo ba tsile go di dira. Ba a bo ba tsile go di dira maDomkrag re a ba itse, ga re ba rutwe *Mr Speaker*. Ka re kamoso o a bo o tlaa utlwa gotwe ke gore ba a re tshwarwa, ba a re kgokgontsha. Fa re re re a re gatwe nnyaa kana ke molao, ke lona le o fetisitseng. Re batla go fetisa molao o re ntse re re bagaetsho, ga re batle go dira DIS e nngwe gape e e leng gore ke *sebona* fela, ke gore ga re itse le gore re ka itheng e le gore go kgokgontshiwa Batswana ka one. E bile Batswana ba ba kgokgontshiwang go sa kgokgontshiwe fa gongwe ba kganetso fela, ke gore go kgokgontshiwa ba kganetso le *section* e nngwe ya Domkrag e e sa batliweng, batho ba Modimo ba bogisiwa go bogisiwa.

Mr Speaker, molao o ga re o gane. Re batla gore re o amogele, re o fetise ka go ba baya thupa re ba raya re re re a itse, le a bo le ya *to abuse it* maDomkrag. Mafoko a rona a gatisitswe, Batswana ba tlaabo ba ntse ba reeditse gore a le ya go dira jaaka le tlwaetse. Ke a leboga *Mr Speaker*. Ke ema nokeng *Bill* e gore e fete.

HIS HONOUR THE VICE PRESIDENT (MR TSOGWANE): *Thank you Mr Speaker.* Tla ke go leboge, ke bo ke go dumedise mo ngwageng o mosha.



Ke dumedise Mapalamente a a tlotlegang. Ke bo ke dumedise bareetsi kwa magaeng. Ke bo ke leboege gore Tona a bo a tsile ka Molao-kakanyetso o o tlaabong o patilwe ke Melao-kakanyetso e mengwe ya Matona a mangwe jaaka ba tlaabo ba ntse ba tla ka yone. Molao o o botlhokwatlhokwa, ga o tlhokane le gore re bue re o ise kgakala jaaka sebui se se sa tswang go bua, se e leng gore sone fela sengwe le sengwe mo go sone ke Domkrag.

Jaanong ke leboege dibui tse dingwe tse di buileng, tse di neng tsa itebaganya thata le molao, le botlhokwa jwa molao o ntlheng tsotlhe tsa Ntlo. A e re pele ke ise ke tswelele, ke lebogise Matona a masha a a sa tswang go tlhotshwa. Ke bo ke leboege *Mr Speaker*, gore Mma Serame a bo a eme ka dinao a tsile ka diamaramara kwa Palamenteng mme e bile re itse sentle gore se se mo tsisang ka diamaramara ke eng. Lefatshe la rona le e leng gore gompiano le santse le duba thankga e e bidiwang *grey listing*. Ke supe jalo *Mr Speaker* gore melao e e ntseng jaana, e rotloetsa Puso mo go se e batlang go se dira. Re itse Puso gore e ntse e bua thata ka dilo tsa go dirisa boranyane jwa segompiano mo go gwebeng. Go gweba go tsamaisa itsholelo e e ikaegileng ka go rekisa dithoto kwa ntle. Dilo tse tsotlhe tse di raya madi a a amogelesegang, ditsamaiso tse di amogelesegang le ba re tlaabong re gwebisana le bone. Fa re ntse re dira jaana, re monela marulana pele. Re leka gore re nne phepa. Re kgone go bereka sentle le mafatshe a mangwe. Tautona wa rona re

bona a leka go re lomaganya le mafatshe a mangwe. Re bona le rona re rwele kwa tlhologong makgotla mangwe a a tshwanang le Southern African Development Community (SADC), Mokwaledimogolo yoo e le ngwana wa rona. Jaanong dilo tse di ntseng jaana, di re dira gore re ikiteye ka thupana re le lefatshe.

Bao botlhe ba ba balolotsweng le *ministries* tseo, ke tse di thusanang le kgang e ya borukutlhi jwa madi. Di ka thusa thata mo ditlhotlhomisong, ba ka nna bagakolodibagolo. Ke amogele komiti eo ya maloko a 19. Ke e amogele jaaka e ntse mo *Part 3* ya *Bill*.

Pele ga ke ya kgakala *Mr Speaker*, jaaka ke bua ke re a re ikiteyeng ka thupana, molao o o dirwa ke rona mapolotiki fano. Ga re o direle ope, re tshwanetse re bo re le mo teng le rona. Jaaka dibui dingwe di ntse di bua, fa ke supa ka botlalo, Motlotlegi Rre Ramogapi o ntse a bua thata ka Domkrag. Nnyaa, a re kgaoganeng le dikgang tsa sepolotiki fa re dira molao o tshwana le o. Mapolotiki re rata go dira melao mme re sa batle gore e re ame rotlhe. Fa go diragala sengwe, o utlwa motho a re, *it was politically motivated*. Ke setswe morago ka sepolotiki, *whether* ke wa kganetso kana wa phathi e e busang. *It is either* a supa gore ke setswe morago ka gore ga ke dumalane le sennanne kana sepolotiki sa me ke sa kganetso. Mokgwa o, ga o ka ke wa re thusa gore re dire melao. Batho ba lemoge gore re a bo re tlhwaafetse fa re dira melao. A re dire melao, fa e le gore go na le sepolotiki, se tlaa supafala. Makgotlatshekelo a teng a ikemetse a tlaa dira ditiro tsa one. Molao o, o na le dikatlaholo tse o di beileng tse ke dumalanang le tsone thata. Fa ke lebile kgang e, e tona, ke boP500 000. Tse dingwe go lebege mo borukutlhing jwa *money laundering* go dirwa madi a mantsi, a e leng gore fa gotwe go atholwa P500 000 mo go bao ga se sepe fela. Ke dingwe tse re tshwanetseng ra di lebelela, re bona gore a mme golo mo, ke mo go ka tshabisang batho gore ba se ka ba dira tiro e ba e dirang.

Madi a re buang ka one, a a tsewa fa e le gore ke a lefatshe le, a isiwa kwa mafatsheng a mangwe. Fa e le gore ke a mafatshe a mangwe, a tlisiwa kwano. Fa go diragala jaana, dirukutlhi di tshabela kwa mafatsheng a mangwe. Ke rata ntlha e e buiwang



gotwe go itlhoganelwe thata. *Bill* e teng ya Extradition Amendment Bill, 2021, e e tlaabong e tla ka Motlotlegi Rre Mmusi *in these Bills*. E lomagana le gore e re fa o batliwa sengwe, kana gore motho a busiwe a tle go sekela melato ya gagwe e e rileng, e bo go dirwa ka bofefo. Ke dikgang tse di botlhokwa. Batho ba a iphitlha ba nna dingwagangwaga kwa mafatsheng fa ba dirile melato mo mafatsheng a bone. Ntlha e ka gore e teng e a buiwa mo dikgannyeng tse, a e tlhwaafalelwe. Mafatshe otlhe a tshwanetse a bone gore ga ba letlelele dirukutlhi gore e re di sentse kwa di sentseng teng, di bo di tla go iphitlha kwa mafatsheng a tsone, ka gore go tlaabo go re imetsa tiro.

Mr Speaker, *Bill* e, e tlhamaletse, ga e na bana ba phefo. Ga re ka ke ra tsaya letsatsi lotlhe re e bua. Re itlhoganelele gore re e fetise le tse dingwe tse di amanang le yone. Re tle re se ka ra bo ra boela gape mo seretseng. *We are not yet out of the woods*, re santse re duba thankga. Go dira ka bofefo le ka manontlhotlho go ka thusa lefatshe la rona gotlhelele, le bo le tswa mo seemong se le leng mo go sone. Gompiano jaaka *Minister* a ne a bua, ga re ise re fitlhelele dintlha tse dingwe tsa botlhokwa mo go sekasekiweng mo. Fa go fitlhelwa re tlhabela, ga re ka ke ra goroga mo go tse re gakolotsweng mo go tsone tse. Re tlaabo re boela gape kwa *grey listing*. Mafatshe a ne a re ja ditshego re le mo *grey listing*, a re ko re lekeng.

Palamente e, ke e leboge gore e faphegile, e tlile go itebaganya le kgang e. Mapalamente ga ba a re re tsoga re bua ka *Budget* kamoso o mongwe, re a go nna le Palamente e telelelele. Le ne la ikitaya ka thupana la bona gore go botlhokwa gore fa go buiwa ka lefatshe, go buiwa ka borukutlhi jwa madi, dikgang tsa go rotloetsa dirukutlhi ka madi, ke selo se se botlhokwa se se le amang. Ke sone se le tsileng fano gore kgang e, re tle re e bue. Re dire melao e ka bofefo. E tle e re ka *September* fa go a go kanokiwa, go fitlhelwe le rona re na le melao. Kgang e tona ke ya gore melao e fa re sena go nna re e dira jaana, e diragadiwe. Ga go e go sekwasekwa fela gore re na le melao, go a go sekwasekwa gape go bona gore a mme melao e re e dirileng e nna mo tirisong, e mo tirisong. E mengwe e tlhokana le dikomiti tse di tshwanetseng di nne teng, diofisi tse di tshwanetseng di nne teng. Fa go fitlhelwa e le gore molao o teng, mme ga go na bodiredi jo bo tshwanetseng go diragatsa molao oo, go tlaabo go supa gore re batho ba ba sa tlhwaafalang.

Ke tsaya gore e tlaare re tswa fela gone fa, Tona ke mo itse ke mo tshepha, o tlaa ema ka dinao a bona gore tsotlhe tse di tlhokagalang di nna teng. Melao eo e re e buisanang, e re e dumalanang gompiano, e bo e ya go

diragadiwa. Ke selo sa botlhokwa se re tshwanetseng re se ele tlhoko. Fa re ntse re tsamaya, re e tlhalose kwa Makgotleng gore batho ba se ka ba tsoga kamoso ba wela mo isong ka go sa itse gore molao o o dirilweng o. Fa ba dira se ba se dirang go tlaabo go le phoso. Ditshetlana tse dingwe di di sha, tse dingwe go a go fetolwa fela tse di ntseng di le teng. Fa gongwe ke melao e mesha gotlhelele, jaaka wa *society* o tlaa tla. Botswana e tsere tshwetso ya gore le yone e inakanye le makgotla a a tlhodumelang, a a bonang gore a dilo di dirwa sentle, ga go na tshenyetso-setšhaba yone e e buiwang ka Sekgoa e, e gotweng *money laundering*, ga go na tse di maswe tse di dirwang tse di ka dirang gore dirukutlhi di tsene mo lefatsheng la rona.

Motsamaisa Dipuisanyo tsa Palamente, mma ke gatelele gore ga se mafatshe otlhe a a inakanyang le ditsamaiso tsone tse. A mangwe mafatshe a salela kwa morago ka gore go a bo go na le tse gongwe ba batlang go di fitlha. Se se gatelela gape thata gore re le Puso, re batla go bona lefatshe le le phepa, tse tsotlhe tse di dirang ka madi kana tse di ka dirang gore go ka nna le tshenyetso-setšhaba, re leke gore di tsamae sentle.

Gongwe Batswana ke ka ba gokolola gore kana molao wa Financial Intelligence Act, re sale re o simolotse ka 2009, ra o sekaseka ka 2019. Fa re sena go nna re o dira, re o baakanya ya re bone ba FATF ba lebelela tse re di dirang, dikgato tse re di tsayang, ba nna ba re bolelela gore re santse re saletse kwa morago ka dilo dingwe, ba tlaa nama ba re sekasekile, ba re beile leitlho-kana *under the radar* ka se se bitswang gotwe *grey listing*, e le gore ba re tlama gore re fitlhelele golo gongwe. Ke gone jaanong gongwe le bonang ka tsone *recommendations* tsa bone, re diramolao o gore re fitlhelele se ba se batlang gore lefatshe la rona le nne phepa.

Bagaetsho, kana tota kwa ntleng ga gore re lebile gore go ka nna le ditsuolodi, ba ba tlhatswang madi ba tswa kwa mafatsheng a mangwe, gongwe madi a tla a feta a tlhatswiwa mo lefatsheng la rona, e le madi a a sa tsewang sentle kwa mafatsheng a mangwe. Kwa ntle ga gone moo fela, le gone mo lefatsheng la rona, molao o o tlaa thusa gore re kgone go disa, re kobakobe tshenyetso-setšhaba. Fa o ka lebelela jaaka Motlotlegi Mothusa Tautona a ne a bua, gone fela go dira molao wa Financial

Intelligence Act, go tsamaelana le gore re baakanye melao mengwe mo lefatsheng la rona. Melao fela e e sa tswang go buiwa ka bontsi gore kwa lephateng le ke neng ke le kwa go lone la Peeletso, Papadi le Madirelo; bo Companies Act, Trust and Property Control Act, Societies Act, Counter Terrorism Act le Extradition Act re a di baakanya. Gore re baakanye jaaka ba FATF ba batla, go tsala gore le yone melao eo, re e baakanye.

Ga ke batle go nna moleele, bakaulengwe ba buile ka bolelele, ke gatelele fela gore go botlhokwa go dira jalo jaaka ke ne ke bua, re le lefatshe le Puso e e batlang gore dilo di dirwe sentle. *Of course* go na le dingwe tse ka boammaaruri di batlang gore di dirwe sentle. Malatsi a re tshela mo matshelong a batho ba kgonang go fitlha dilo ba tswa kwa mafatsheng a mangwe, ba direla dilo mo lefatsheng la rona ka gore lefatshe la rona le bulegile fela. Le mo Botswana gone mo garona, batho ba fitlha dingwe dikhumo e le gore ba di fitlha ka masika, ditsala le batho ba e leng gore ga ba amane gope le maina a bone gotlhelele. madi a isiwa kwa *account* nngwe ya mongwe. Ke sone se re batlang gore dilo tse re di sale morago gore re se ka ra fitlha sepe.

Motsamaisa Dipuisanyo tsa Palamente, Rre Mopalamente yo o tlotlegang Rre Ramogapi, o ne a bua gore kana re a bo re tlaa tla re tsogologelwa ke Tona, jaaka a ne a bua *Clause 10* gore Tona o tlaabo a filwe dithata tsa *he/she declare* motho gore ke *a terrorist*. Nnyaa, ga go a nna jalo, gatwe Tona o dira fela jalo fa a sena go nna le komiti yone e, ba sena go nna ba mo gakolola, e le *process*. Ga se gore Tona fela fa a tsoga fela maphakela, o tlaabo e le gore nnyaa, Rre Saleshando ke *terrorist*. Nnyaa, ga go ka ke ga nna jalo. Go na le *Clauses* tse e leng gore ga o ntse o tswela di supa gore tota gone gore o bo o ...

HONOURABLE MEMBER: Clarification.

MR MOLEBATSI: ...ya di *terrorist*... ke tla go neela... (*inaudible*)... le gone go na le mabaka, mabaka a teng e ka nna e le gore le kwa go ba United Nations Sanction Register, kana *list* ya bone e supagala gore ka tsela nngwe o amana le *groups* kana ditlhopho dingwe tse di dirang molato o wa bo *terrorism*. Mma ke eme gone fa ke go neele.

MR KEKGONEGILE: *Clarification.* Ke ne ke re ke go tlhologanye *Honourable Molebatsi*. Kana motho fa a go reeditse o ipotsa dipotso tse dintsiyana, nngwe ya tsone ke gore, *on the report* ya COVID, ya ga modupa dibuka, go supagetse go nnile le tlhoko tiriso madi sentle. Mme tlhoko tiriso madi e sentle e, go nnile le *millionaires* di le dintsiyana ka go farologana, bangwe ba tsone ba le mo *Cabinet*. Motho o ka ipotsa gore, naare molao fa o sena go nna o saenwa, tsholofelo ya batho ke gore mo lebakeng le le kae ba bo ba bona bahumi ba ba dinaledi ba tshoganetso, ba e leng gore ga ba a fiwa dilo sentle? E bo e le gore ba sekasekwa mo lebakeng le le kae, wena fela fa o tlhologanya? Tanki *Honourable Minister*.

MR MOLEBATSI: Ke a leboga motlotlegi. Sa ntlha fela ke gore ga ke na bosupi ja gore go runtse *millionaires* mo *Cabinet* e tsa COVID. Ga ke itse gore ke bomang. Ga ke itse fa go ntse jalo, ga ke na bosupi, go thata gore ke go arabe. Gongwe ke re, mme ke gatelele gore kana melao e bagaetsho le fa o bona re e ntsha jaana ga e kganele motho go huma. Ga e kganele motho gore a itirele madi a hume, le gone ga e kganele motho gore a hume khumo ya potlako, kana fela e e *spontaneous*. Ga ke bone *deal* golo gongwe, ke e dira, ke dira madi, ga gona molato. Se re se buang ke gore, ra re re dirisa molao o gore re kgone go latedisa dikhumo tse e leng gore ga re tlhologanye gore di tla ka tsela e e ntseng jang. Re bona fela o huma re sa itse gore o huma ka tsela e e ntseng jang. O nna le dipolase le meraka, mme re ntse re itse gore wena o ka fitlhelela fa kae. Molao o ke sone se o se buang, gore re tle re itse fela gore tseo o di tsaya kae. Ke sone se se buiwang gore *records* tse...se sengwe se gongwe ke tshwanetseng go se gatelela ke gore, molao o wa re *beneficial owners*, ke gore fa go dirwa *company* re tshwanetse re itse gore beng ba *company* eo ke bomang. Le fa go na le beng ba *company*, go na le mo gotweng *nominee shareholders*, ba e leng gore gongwe nna ga ke batle gore ke bonale, mme ke ka tsenya ngwanake, ke ka tsenya Theo, go tshwanetse gore go itsiwe, go nne mo mpapananeng gore Theo yo o tse tse ke mang. Gape re direla gore *information* e gape, makgotla a a tshwanetseng a ditlhotlhomiso, go nne motlhofo gore re nne le *records* tse di siameng, tse re tlaa tlang re bua ka tsone fa re bua kwa *Company's Act*, e le yone re e baakanyang. *Records* tse di tlaabong di supa gore go nne motlhofo gore ba ba thotlhomisang ba latlele dikhumo tse kana ba latele gore meamuso e yone e goroga jang kwa mothong ene yoo. Nngwe ya tsone ke *constitution* ya *company*, jaaka re tlaa tla re bona gore *constitution* e supa gore ke mang yo o mo *company*, le kopana jang, *meetings*, *accounts*, e le gore go saenelwa madi a a kana go saenelwa mang, fa a tsamaya ke mang yo o saenang. Ke tsone dilo tse le tlaa tlang le di bona gone moo.

O tsena fela mo mathateng fela a a gakgamatsang. *Company secretaries, company directors, company shareholders*, tse e leng gore ga di kgone go supa gore *ultimately* ke mang *who benefits* mo meamusong ya *company*, le bone ba tsena mo mathateng.

Molao o rra gape o tlile go re thusa fa ba ba tlhotlhomisang ba batla *information*, ka fa molaong jaanong ba tlaabo ba o batla ka bofelo jo bo rileng. Kwa *companies* fa e le gore o batla *information*, ya *to reveal* gore *company* ke ya ga mang, *maximum days* a o tshwanetseng gore o bo o a filwe gore o ntshe *information* eo, ke *three days*. Go nna o siya siya o ya kwa, o bo o bowa o ya kwa gotwe go batliwa *information*, se se diragalang gompiano ka gore ga gona molao, go kgona go batliwa *information*. Kwa lephateng le ke tswang kwa go lone la Papadi le Madirelo, re na le *information* tse re a tleng re di batle ka *companies* dingwe tsa batho, mme go re tseye lebaka, go fitlhelela fa gongwe re dirisa mapodise, kana fa re dirisa mapodise jaanong *following* ya teng ke ya *criminal*. Jaanong gompiano e *administrative*, gore re tlaabo re go raya re re, re go fa *three days* gore re bo re itse gore *company* ya Motheo Construction ke ya ga mang, go tseletswe kwa teng, re bona gore *who are the beneficial owners* tsa *company* e.

Motsamaisa Dipuisanyo tsa Palamente, re santse re tlaa nna le sebaka gore re bue re tseletse segolobogolo mo go tse dingwe ka gore e tsetse gore go baakangwe melao e mengwe, one molao wa go bopa sesha FIA. Ga ke re o a baakangwa, *it is enacted* gape, o a bopiwa sesha. Go setse gore re baakangwe melao e mengwe, tse dintsi tse re tlaa tla re di bua gone kwa melaong ya teng, gore ke re, re tshwanetse go o fetisa ka bofelo jo bo kgonagalang. Kwa ntleng fela ga gore a FATF le ba ESAAMLG ba batla gore re dire jalo, *it is also good for our country*. *It actually answers the question* tse re ntseng re di botsa tsa *corruption and all those things*, gore fa motho re bona a tswa kwa fela a tla e le gore o aba madi kwano, e bo e le gore re...

MINISTER OF BASIC EDUCATION (MR MOLAO): *Clarification.* Ke a leboga *Honourable Speaker*, ke a leboga *honourable* go mpha sebaka. Ke ne ke re kana melao e ya bo *money laundering*, ga ke itse gore molao o o itebaganya jang le kompone e fa gongwe e a bong e le *registered* mo Botswana, mme o bo o fitlhela e le gore *the mother company* gongwe e

kwa lefatsheng le sele. E bo e le gore fa gongwe jaanong madi a tsamaisiwa *through these companies*, madi a a tswa a ya koo, a ya go boa gotwe, nnyaa *we were giving loan to a company* e e mo Botswana, kante ga se *loan*, ke gone go tlhatswa madi kana *money laundering* jaaka re tlwaetse go e bitsa, gore molao o selo o ka se kganela ka tsela e e ntseng jalo ka gore se lebega se bereka *even in areas where* mafatshe a re a bitsang a *tax havens*, gore fa gongwe *we register* dikompone kafa le kafa?

MR MOLEBATSI: Ke a go leboga. Ke potso e e maleba Tona. Se sengwe se gongwe ke tshwanetseng gore ke se gatelele ke gore, molao o jaanong o bulela gore makalana a mangwe a a kwa mafatsheng a mangwe, jaaka o ne o bua ka *tax haven* gongwe kompone e le kwa *islands* tse ke ka sekeng ke di bue ka maina, kwa re ntseng re sa fitlhelele teng, gongwe DIS ya rona go thata gore e fitlhelele teng, *records* tse jaanong molao o o letlelela gore re ka dirisanya le makalana a mo Botswana gore gone koo makalana a mafatshe a mangwe, a re dirisanyang le one bo ESAAMLG le FATF, e bo le bone ba kgona gore ba fiwe *information* ka bofelo fa ba belaela sengwe, gore ba latedise tsone tseo. Go ka re thusa le gore re tlise le jone boitseanape jo bo fetang jo re nang le jone mo lefatsheng la rona, gore dilo tse re di sekaseka, re di kanoke. Re kgone gore re di tlhotlhomise.

Ke sone se ke kopang Bakaulengwe Mapalamente a a tlotlegang gore a re se kang ra dia sebaka, a re fetiseng molao o mo kgweding e gore re se ka ra boela kwa go tshwaiweng ka mebala ya bo *grey* le *black*. Re bo re nna lefatshe le le nang le tlotla, le le tlhatswitsweng, le le phepha, ga go na tshenyetso-setšhaba.

Ka a le kalo Motsamaisa Dipuisanyo tsa Palamente, ke a go leboga.

HONOURABLE MEMBER: Ke eng o sa *move or truncate*?

MR SPEAKER: Ga ke dumalane le mafoko a o a buang Motlotlegi Mopalamente wa Boteti East ka gore Batlotlegi Mapalamente ba batla go bua, wena o tla ka mafoko a ntwa.

MR TSHERE (MAHALAPYE WEST): *Thank you Honourable Speaker of the National Assembly.* Ke go leboge mo tshokologong eno. Le nna ke latilhele mo kgannyeng e. Ke re *happy new year to other Honourable Members here* ba re boileng mo Palamenteng e mo ngwageng o mošha o.



Mr Speaker, le nna ke emelelela *to support* Molao-kakanyetso o. Go na le ditshetlana tse gongwe ke sa dumalaneng le tsone mme ke a o *support in general* because kana fa re bua ka ledi la Pula le Thebe, sepe fela se se ka gomagometsang ledi le, ke mmaba mo go rona, re tshwanetse re se emela ka dinao. Ke tsaya gore Palamente e dirile sentle gore e re fa e bona dilo tse e bo e re bitsa jaaka e re biditse ka tshoganetso gore re tle go sekaseka melao e, re e fetise gore ledi la Pula le somarelesege. Mme jaaka ke kile ka bua mo nakong e e fetileng gore kana dikgang tse di buang ka madi, mafatshe a mangwe fa a re lebeletse, ga se gantsi o ka ba raya o re nna ke dira jaana, ke siame, ke tshwara madi sentle ka gore ba a iponela. Mokgwa wa bone ba dumela mo go iponeleng. Jaanong fa ba iponetse jaaka ba iponetse gompiano ka Pula le Thebe gore go lebega e le gore madi a rona ga re a tshware sentle, ke gone fa o bonang go tla *sanctions* tse. Go be gotwe *blacklisting*, *greylisting*, ga o ka ke wa dirisa madi, ga o ka ke wa romela madi mo Botswana o le kwa bo United Kingdom (UK) le bo America. Ke dikgang tse masisi tseo tse ke tsayang gore go maleba gore Palamente e bo e itlhaganetse gore re leke go di baakanya ka lebelo le re tshwanetseng gore re di baakanya ka lone.

Mr Speaker, kgang e ga se lantlha re e bua ya *financing of terrorism*. Re bua gore kana dilo tse le malawana e mengwe e re e dirang mo Ntlong e, e tshwanetse e lebege e *support* gore go se ka ga nna le *financing of terrorism*. Maloba re ne re fetisa molao, ke e fa sekai, wa motsoko, re tlisa melao e e gatelelang tiriso le thekiso ya motsoko mo lefatsheng la Botswana. Re tlhalosa ka nako eo re re kana fa o dira, *if you overregulate*, jaanong o fa tshono ba ba tlaa kgonang go dira ba sa sale molao ope morago. Sekai e le gore jaanong re tlaabo re kgona go bona metsoko e e tswang kwa ntle e re sa itseng gore e dirilwe jang, *that do not satisfy any international requirements*, e e sa saleng molao ope morago, e bo e le gore e a tsena. Fa o ipotsa gore metsoko e e tswa kae, e lemiwa ke bomang, ke gone fa *financing of terrorism* e tsenang teng. E ka nna motsoko, sengwe fela kana *any commodity* e e rekisegang, e kgona go tsenya madi. *So*, re tshwanetse gore e re fa re dira melao ya rona, re se ka ra e gagamatsa thata gore re se ka ra a fa *terrorists* tshono gore di ka kgona go dira madi ka dilo tseo.

Selo se tshwana le bo *hemp and medical* marijuana, ke dilo tse e leng gore gompiano jaana le di lesitse, re tsentse melao e e thata mo go tsone gore *terrorists* jaanong di kgone go dira madi ka tsone mo lefatsheng la Botswana ka gore e tlaa nna *black market*. *They have created a huge potential for black market*. Ke sone se o bonang *money laundering* e le kana.

Le tiriso ya rona fela ya dibanka, ke leboga thata gore molao o o bo o dule o le phepha, e le molao o e leng gore le nna ke utlwa o tswa o le phepha o itebaganya le dibanka gore ope yo e leng gore o bereka mo bankeng a dira *account*, o tlaa nna molato ka fa tlase ga molao o fa e le gore o iphitlhela e le gore o thusa lekoko la dirukutlhi gore ba ntshe madi mo lefatsheng, ba tsenye madi mo lefatsheng kana ba tlhatswe madi. Selo se ke se lebogela thata ka gore mo nakong e e fetileng *Mr Speaker* o ne o fitlhela ke utlwa botlhoko tota fa ke lebeletse mo lefatsheng la Botswana go na le bo Bank of India le Bank of Baroda. Tsone ee di tswetswe mme gongwe *damage* e di e dirileng ke sone se e leng gore re bona manokonoko a teng e bile ke one a re lekang go a fetola gompiano jaana. Fa e le gore banka e kgona gore e tla fa e le Bank of India, mo go nna ke ne ke tsaya gore go raya gore fa o tshwere madi *and deposit* madi ao, go tshwana fela o a *deposit* kwa India, a tsamaile. *Minister of Finance*, re tshwanetse re ele dilo tse tlhoko, re di lebelele thata ka gore go ne go lebega e le gore madi a rona a a tsamaya ka tsela yone eo.

Tenders di a dirwa mo Botswana, *company* e dira *two billion profit* mme e bo e tswa fela e ntse jaana *by a click of a button*, e tlaabo e tsamaile e dule mo lefatsheng la Botswana. Fa gongwe go itiretsewe *companies* tsa maitirelo tse di *temporary* tse o tlaabong o bona di reka di ba di fetisa madi a a kanakana. Ke re golo ke gone mo go neng go re bolaya *Mr Speaker*. Go ne go re bolaya ka gore le tsone dibanka e ne e se gore di *report these suspicious transactions* mo go kalokalo ka gore ga o ka ke wa itse gore *suspicious transaction* o e bona jang. *Unless* molao o gompiano jaanong o tsepame gore madi a a kana fa a tsamaya fa o tshwanetse gore o bo o *report*, go tswa go le *clear* go ntse jalo. Jaanong dibanka tse di sa direng jalo, tse di sa saleng molao o morago, di tlaa otlhaiwa ka fa tlase ga molao o. Ke sone se ke se lebogelang thata.

Se sengwe *Mr Speaker*, ke *corruption*. Kana fa o ka bona tiriso botlhaswa ya madi mo Botswana, *Honourable Dr Matsheka*, Tona wa pele wa Madi le Ditlhabololo o kile a tlhalosa gore *37 per cent* wa madi a rona a ya kwa *corruption*. Jaanong *37 per cent* yoo, ke tshono *of financing terrorism*, go dira *money laundering* le *all the deeds that you can think of*. Jaanong fa re santse re ise re *address* dikgang tseo tsa *corruption* e e diragalang mo maphateng a Puso, re e bona ka matlho... ke a itse gore o a itse *Mr Speaker* gore gangwe le gape re kgona go bona batho ba isiwa kwa Kgotlatshekelo ba seka. Ke dingwaga tse dintsi re ntse re ba bona *being*



paraded kwa court, ba bangwe ba supiwa go tshotswe ditlhobolo, ba bangwe go supiwa jang kana jang, mme boammaaruri ke gore *cases* tse tsotlhe fa di fela, *there is no conviction*. Ga go na ope yo o kileng a bonwa molao kana ope yo o kileng a seka a ya kgolegelong. Ke dilo fela tsa puo ya molomo *and parading batho kwa court* go lebeqa o kare re dira sengwe mme le sa dire sepe. Madi a jaanong a tlile go tswelera a tsena mo diatleng tse ditsouludi, a tlile go tswelera *financing* ditsouludi fa e le gore ga re ka ke ra tsepamisa matho mo kgannyeng ya *corruption*.

Ke maswabi thata e bile ke utlwa botlhoko gore gompiano jaana *Honourable* Dr Matsheka a bo a ntshitswe kwa *Finance* e bile a ntshitswe gotlhelele *from the Cabinet*. *Honourable* Dr Matsheka ke nkgonne thata kwa Mahalapye, mme ga ke tseye gore ke mafoko a ke neng ke a bua maloba fa ke le fa a a dirileng gore le bo le felela le akanya gore le ntshe *a highly renowned economist* Dr Matsheka yo o neng a ka bo a re thusa dikgang tse gore re di tlhaloganye go ya kwa teng jaaka a ne a tle a re di tlhalosetse go ya kwa teng tota, gore le Motswana kwa gae a kgone a tlhaloganye dikgang tse tsa madi.

MR HIKUAMA: *On a point of clarification*. Dumelang Ra Nkamo. Ke a leboga *Honourable Member*. A mme jaaka fa o bua ka fa Puso e kgwile Dr Matsheka yo o neng a bua dikgang tse di molemo, re nna le tsholofelo mo go reng gongwe dilo tsa rona di tlaabo di babalesegile, ga o belaele gore gongwe dipuo tsa gagwe tse di tlhatswegileng tse, e bile di supa *direction* ya go leka go lwantsha *corruption* mo *system*, ke tsone *that costed him post* e gore a latlhelwe kwa ntle jaaka a latlhetswe kwa ntle jaana?

MR TSHERE: Ke a leboga *Honourable* Hikuama, ngwaga o mosha...

MR SPEAKER: *Honourable Member* for Mahalapye West, ke ne ke re ke go gakolole fela mokaulengwe yo ke mo ratang thata gore kang e, e re o tsena mo go yone, o itse gore ga se yone tota e e mo tafoleng. Ke go gakolole fela ka o motho yo ke mo ratang thata Motlotlegi Mopalamente wa Mahalapye Bophirima.

MR TSHERE: Tanki Motsamaisa Dipuisanyo tsa Palamente. E e neng *Honourable* Hikuama a e bua ke re, ke utlwile botlhoko le nna, kana gakere dilo tse re tshwaraganetse Puso le lona, re a le gakolola. Jaanong kana re ne re utlwa thata Dr Matsheka fa a bua, e bile re bona re ya golo gongwe ka gore dilo tse fa re sa di bue

tse tswela mo pontsheng, ke gone mo di tlaa felelang *financing terrorism*. Di rotloetsa borukutlhi, boferefere le dilo tse dingwe tse e leng gore di a dirwa. Ke ne ke re Dr Matsheka o ne a re thusa thata mo nakong e e fetileng, ke maswabi gore a bo a ntshitswe gotlhelele mo Pusong. Gone moo ka bogone ke bona e le *backwardness*, go re busetsa kwa moragorago, ga go supafale e le gore Puso ya ga Domkraga ya nako ya gompiano e tlhoafetse ka matshelo a batho le dikgang tsone tse di amang madi. Re ne re tshwanetse gore re ka bo re ne re dirisa boitseanape jwa *officers* tse di gone fa gore ba kgone go re thusa go tlhaloganya dikgang tse tsa madi. Le rona re le Mapalamente re kgone go di baya sentle ka gore ga se gore rotlhe re itse ka madi. Nna ga se gore ke itse thata ka madi, ke gore fela mo tirong ya me *I deal* thata ka one. Ke sone se o bonang e le gore re felela re a bona ka tsela e e ntseng jaana.

Mr Speaker, ke ne ke sa batle go tsaya nako e telele, ke bue gore gone *I support* Molao-kakanyetso o o buang ka go thatafatsa tsamaiso ya madi, le ka fa re a tshwarang ka teng mo lefatsheng la Botswana. Ke tsaya gore sengwe le sengwe se se amang go tshwara madi sentle, re a se amogela *Mr Speaker*. Re tlaa tla re lebelela Ditshutiso mo go se se setseng se kwadilwe gore re ka *amend* jang fa re setse re tsena mo legatong le le latelang.

Ka mafoko a le kalo *Mr Speaker*, ke leboga thata, *I support the re-enactment of the Bill* ya *Financial Intelligence*. *Thank you very much Mr Speaker*.

MR KAPINGA (OKAVANGO): *Thank you very much Honourable Deputy Speaker*. Le nna ke latlhelwe mo kgannyeng ya gompiano. *I comment* ke na le *title* ya *comments* tsa me *Mr Speaker*.

Fa ke lebile molao o re lebaganyeng le one o, le se o se buang, ke tletswe ke mogopolo wa gore ke bue gore fa o lebile lefatshe la Botswana, le tshwanelwa ke go tlhalosiwa *as a primitive democracy*. Ke a ipoetsa *Mr Speaker*, ka re fa o lebile melao e re e dirang, le dilo tse re tsweleng re ntse re di tsweledisa fela mme re ntse re lemogile gore ga se dilo tse di siameng, Botswana *qualifies to be called a primitive democracy*; Puso ya batho ka batho e e saletseng kwa morago, e e siilweng ke ditlhabololo, e e sa tlhabologang, e tsamaisana le dinako tse re leng mo go tsone. *Mr Speaker*, molao o wa FIA maikaelelo a one ke go tsaya Botswana e e baya mo seemong se e leng gore e ka lebiwa e *complying with the international financial system regulatory structure or mechanisms*. Tse re di dirang tse ka mokgwa o re di dirang ka teng re le *such a primitive democracy*, ke go



baya mokwalo. Ga re ka ke ra goroga kwa maemong a e leng gore mafatshe a mangwe a Puso ya batho ka batho ya bone e tshabologileng, a gorogileng kwa go one. Ke tlaa simolola go go bontsha gore bokoa ke bo bona fa kae *Mr Speaker*.

Selo sa ntlha; *appointment of the Director General*. Fa ke santse ke le mosimanyana kwa Mahalapye *Mr Speaker* kwa ke neng ke tsena sekole teng, go kile ga tla *magician* yo mongwe yo o neng a bidiwa Muhammed. O ne a tsaya beke e ntshonyana fela jaana a bo a re 'bing, salah bing, abracadabra', a bo a ntsha mmutla mo teng. Ka re ne re le basimanyana re sa akanyetsa dilo thata, re itumela gore *magician* yo o ntshitse mmutla mo bekeng e ntsho. Jaanong *Mr Speaker*, *the same is happening in terms of senior appointments in this Government*. Ke gore ke *bing, salah bing*, leina le a somoga le sa itse gore le somoga fa kae, o kare mmutla o o tswang mo bekeng e ntsho ya ga Muhammed.

Mr Speaker, if we were to qualify to be a sophisticated modern democracy, fa motho a tla go bewa *to such a sensitive position*, go tshwanetse gore go bo go nna le *process* e itsiweng ke mongwe le mongwe, *which can be witnessed that there was a process that happened before such and such a person was appointed Director General of FIA*. Re tsoga re gakgamala kamoso re tshwana le batho ba Tonga ba e rileng ba tsoga ba bo ba iphitlhela ba khurumeditswe ke mesi ya volcano. Re tsoga re gakgamala kamoso re fiwa leina la motho yo re sa itseng gore o somogile fa kae, o kare o somoga mo bekeng ya *magician* gotwe ke ene *Director General* wa FIA. *Mr Speaker*, tsamaiso e e ntseng jalo, *I find it to be backward and primitive. That is why I am saying Botswana remains a primitive democracy*.

Re santse re batla go tswaledisa seemo se e leng gore *President* wa rona ke gore ga a botswe sepe, *he is like an imperial president, a monarch*. Re tsaya gore ke gore bothhale le maikarabelo a gagwe ke a e leng gore a feta motho yo o bopilweng mo setshwanong sa Modimo. *I do not believe in that kind of system Mr Speaker, and I believe ga e ka ke ya re isa gope. E tlike go re dira gore re nne jaaka re ntse jaana mo e leng gore re dikologa golo go le gongwefela, ga go na kwa re go yang. Dithata tse di tshwanang le tse re di neetseng Tautona, ke tsone tse di dirang gore a bo a appoint batho...*

LEADER OF THE HOUSE (MR TSOGWANE): *Procedure*. Ke ne ke utlwa e le gore mokaulengwe o tsena thata a gaketse, mme a bua ka *primitive democracy*. Nnyaa, kana *primitive democracy* ke ya rona rotlhe, a le

mo teng. *Procedure* e ke e kopang ke ya gore, re bua ka efe *Mr Speaker* jaanong? A re santse re le mo go yone e e fa pele ga rona, kana jaanong motlotlegi o ne a batla go feta ka sengwe fela, o santse a tlaa boela mo go e re e buang e e fa pele ga rona? Ke a leboga.

MR SPEAKER: *Order! Order!* Le tlaa lemoga bakaulengwe jaaka ke kile kgantele ka bua le Motlotlegi Mopalamente wa Mahalapye Bophirima, ke mo raya ke re tota le fa re se mo go yone kgang, ke go letla fela ka golo fa re tshwanetse ra leka go jwala tirisanyo mmogo. Ka mo gakolola gore o itse gore ga re mo go yone, mme o ka feta fela. Ke itheile ka re Motlotlegi Mopalamente wa Okavango le ene o ne a nkutlwa, ke motho yo o tsebe ntlha go utlwa. Motlotlegi Mothusi Tautona, o a mo utlwa mokaulengwe wa gago gore a mme re ntse re mo temeng Motlotlegi Mopalamente wa Okavango. Ke e tlogela mo go wena, *I do not want to make any ruling ka kgantele ke kile ka tlogela mo yo mongwe*.

MR KAPINGA: *Ke mo go yone* right on the forehead, I am talking about Clause 5 e e *fang Tautona* the unbridled, unfettered power to appoint the Director General, of FIA. That is what I am labeling as a primitive democracy, it is only a primitive democracy that can continue to confer so much power on a single individual. That is the point that I am making *Mr Speaker*. The end result...

HONOURABLE MEMBER: Replied on unriddled path sir.

MR KAPINGA: *Unriddled*, ke itse Sekgoa thata.

HONOURABLE MEMBER: Nnyaa, *un-riddled*.

MR KAPINGA: The consequence, the unavoidable consequence of that is that you have blind individuals appointed to positions, *ba e leng gore fa ba tewa gotwe dira jaana o a dira* because the process leading to their appointment was covered in darkness. *Le ene ga a itse motho wa Modimo gore tota e rile gotwe ke nna ke fentseng, ke fentse jang position e. Go raya gore ke lerato fela la ga Tautona le le mpeileng fa, jaanong ke tshwanetse gore ke dire sengwe le sengwe se a se batlang mo go nna*.

The second Clause that demonstrates further *gore* we are a very limiting democracy, Clause 7 gives veto power to DIS *gore fa e kare ke ntse ke ntse foo ramogona ke re ke Director General FIA, DIS e bo e ntsha setlankana kwa gore* this guy no longer passes security classification, the post becomes vacant. You are giving veto power to an organisation that the majority of Parliamentarians



in this House *ba setse ba buile gore* that is a rogue organisation.

Still goes back to the appointment process, *fa e ka bo e ne e le gore* appointment *eo e dirwa ke* a team or committee, DIS will not have the power to produce a veto certificate and cause a vacancy in the office immediately. Their report will have to go to some committee, *e bo e lebelela* report *gore gatwe rre yo o sentse eng, e bo e le yone e ka tsayang tshwetso ya gore* this person is no longer fit and proper to continue to occupy office *ya* Director General FIA. That is the reason Your Honour, Leader of the House why I am saying Botswana is a primitive democracy. You cannot give veto power to the DIS *gore e re* once *fela* they issue a certificate, somebody should lose their job and the position becomes vacant. *Ga ke dumalane le kgang eo* Mr Speaker.

The third reason why I am saying Botswana is a primitive democracy, *re santse re dumela mo* positions *tse gotweng di na le* political power...

HONOURABLE MEMBER: Clarification Mr Speaker.

MR SPEAKER: Clarification sought, His Honour the Leader of the House. *Akere o dumetse* Kapinga?

MR KAPINGA: Nnyaa rra ga ke ise ke dumele, *let me solidify my position.*

MR SPEAKER: Sorry sir.

MR KAPINGA: I am going to Clause 8; *gatwe* Permanent Secretary to the President (PSP) *ke ene a yang go tsamaisa* the National Coordinating Committee on Financial Intelligence. What is the reason and the justification of giving that position to the PSP? If it were me, I would go for the Governor of the Bank of Botswana because that is the person who is at the top of our financial system in this country. *Ke ene ke neng ke ka mo tlhopha gore nnyaa re lebelele komiti e rra, o re sekasekele se* Financial Intelligence Agency *e se dirang, o bone gore* are they doing their job to make our financial system as clean and of high integrity as it is required by the international community. *Yo* PSP *le mo tsenya fela ka gore ke morongwana wa lona yo o tlaa dirang dilo tse di sokameng, tse le batlang di dirwa jaaka le mo ntsentse le kwa* Judicial Service Commission (JSC). It is wrong. We should not believe that wisdom presides *only kwa go bo* PSP, Minister, President. It is wrong. I would have at least gone for the Governor of Bank of Botswana, *ke lebile* his specialist expertise when it

comes to financial issues. *PSP ga se gore o itse sengwe le sengwe ka dilo tsa finance, ga a itse sepe.*

The next issue still at Clause 8, *ke gore gatwe* office of General Council shall be the secretariat to the committee. What is the justification? Who is General Council when it comes to Financial Intelligence issues? *O tsenya fa kae* as General Council? *O tsenngwa fela ka gore* he is from the Office of the President (OP)? That is the only thing that I know. You do not even think it is enough *gore le bo le tsentse* PSP *mo teng, le tsentse* Permanent Secretaries (PSs) *tse dingwe mo teng.* You want to even put the General Council *mo teng* to do what? The right people to be the secretariat of this committee is the Financial Intelligence Agency itself, *ke bone ba tshwanetseng gore ba nne bakwaledi ba golo mo* because they are responsible for that portfolio. *Ke itse dilo di tsamaiswa jalo, e seng ga lona mo le batlang go go dira mo.*

Ke ya kwa Clause 10; *ke re* to give such a power to a primitive democracy like ours is very dangerous. *Fa le ka gakologelwa, ka nako ya ditlhopho* the leader of the BDP went public *a supa bangwe a re ba batla go itira ditsuulodi mo lefatsheng la* Botswana *e bile ba na le* information *ya gore batho bao ba na le ditlhobolo,* they want to become insurgents in this country. It is there; the video is there and then you give the power to such people to declare others terrorists. I fully agree with Ramogapi *gore* we will be handing a gun to somebody who is dangerous, *le go iphula a ka nngang a iphula ka yone. E bile nako eo ke yone e neng gape ga tsenngwa* story *mo dipampiring gotwe go na le coup nngwe e e eteletsweng pele ke maIsrael* against the Government of His Excellency the President Eric Masisi, *gotwe go na le thankgolo Mmuso nngwe e tlaa diriwang. Fa e le gore batho ba ba ntseng jaana, ke bone ba ba eteletsweng pele Puso, ga ke ka ke ka tshepha gore ba dirisa thata e* in a responsible manner. I would rather as a lawyer, choose *gore* this power or authority to declare somebody a terrorist should be given to a Judge of the High Court. *Mongwe a tle ka bosupi jwa gore re na le bosupi jwa gore rre yo o ntse a dira 1, 2, 3,4,5,6, re kopa gore Lekgotla la* High Court to declare *gore* he is a terrorist. That one will have credibility, rather than *e dirwang ke* Minister *wa Goromente yo re mo itseng gore ga a tshephege, o itshupile gore ga a tshephege.*

Sa bofelo Mr Speaker, *ke batla go bua ke riana; o bona* organisations *tse di tshwanang le bo* FIA *jaana,* they are dealing with sophisticated issues, *ba dira dikgang tse di maretshwa. Fa ba dira dikgang tse di maretshwa jaana,*



go bothokwa thata gore batho ba ba hirwang teng, e bo e le ba ba rutegileng e bile ba rutetswe tiro, ba sugilwe thata go itebaganya le yone tiro e ya monitoring of money circulating in our country a tsena a tswa, ba rutilwe to a high degree Mr Speaker. E bile ba rutilwe le kwa mafatsheng a sele a re itseng gore ba na le very sophisticated Financial Intelligence systems. *Re se ka ra tsaya mongwe le mongwe fela yo o fetang ka tsela, re mo tsaya fela ka gore yo e kare ke yo tshepgegileng, ke yo re mo tshaphang. Re bo re mo fa maemo gore tsena o bereke mo Financial Intelligence Agency. That is a specialised area Mr Speaker, very specialised area. Ke na le tumelo ya gore fa re simolola re ne re ikgolola fela. Re e dirile fela re ikgolola gore a re direng fela re tle re ba reyeng re re nyaa re dirile Financial Intelligence Agency. I believe that experience, maitemogelo a Goromente a a boneng since this organisation came into existence, ke dumela gore Honourable Tsogwane o lemogile le Goromente wa gagwe gore lephata le ga se sogwasogwane, ga se le o shankodisang fela o bo o re ke dirile Financial Intelligence Agency.*

You need highly capable, highly educated, highly trained and highly exposed individuals, ba e leng gore they will be able to understand what is it that is going on with regard to our financial system in Botswana le mo mafatsheng a mangwe.

Ka mabaka one ao *Mr Speaker*, ka *points* tse ke di ntshitseng tseo, ke gone fa ke sa dumalaneng le molao o. Ga ke na pelaelo gore re le lefatshe la Botswana, go bothokwa gore re bo re na le molao o o tiileng, o o nonneng, o o tlaa tlhomamisang gore madi a rona a lefatshe la Botswana ga a leswefale. E bile ga re supiwwe ke mafatshe a mangwe gore re butse kgoro, go itirelwa fela go rata le go kgona ke bao ba ba nang le madi a re sa itseng gore a tswa kae. Ka mabaka a le kalo *Mr Speaker*, ke ntsha mabaka ao, gore ke one fela a ke sa dumalaneng le one mo molaong o. Fa nako e tlaa jaaka *my colleague Honourable Tshere* a buile, re tlaa tsenya *our proposed amendments* go dira gore molao o e nne wa maemo a a kwa godimo, a a sa supeng fa re santse re le a *primitive democracy*. Ke a leboga *Mr Speaker*.

MR SPEAKER: Thank you very much Honourable Member for Okavango, Honourable Kapinga. You are going to be followed by Honourable Member for Francistown South, Honourable Wynter Boipuso Mmolotsi, *rraagwe* Itu.

MR MMOLOTSI (FRANCISTOWN SOUTH): Ke a leboga *Mr Speaker*. Ke tseye nako e, ke eleletse batlotlegi ngwaga o moshale le Batswana ka kakaretso.

MR TSOGWANE: *Point of procedure Mr Speaker.* Ke a leboga *Mr Speaker*. *Point of procedure* ke gore, gakere re tshwanetse ra bo re beile leitlho ntlha e re e dumalaneng ya gore dibui mo *Bills* tse di nna kae, ba kganetso ba nna kae, ba *ruling party* ba nna kae. Ke yone ntlha e e ka re dirang gore re bo re ye go fitlhelela selekanyo se re se beileng le dinako tse re di beileng, tse re di dumalaneng. Ke tsaya gore e ne e le *procedure* ya gore a le a tlhola gore a dibui tse re di dumalaneng mo kemeding dintlheng tsotlhe di a wela kana ga di a wela? *Thank you sir.*

MR SPEAKER: Give me a second to liaise with my able staff. I will be with yourselves Honourable Members. However, I can confirm thumb suck *gore* the BDP's list is exhausted. We had six speakers from the ruling BDP. So far on the board we have *ba ba iseng ba buie*; Honourable Mmolotsi, Honourable Lucas and Honourable Reatile. *Go buile* Honourable Ramogapi, Honourable Keorapetse, Member for Selebi Phikwe West and Honourable Tshere.

MR MMOLOTSI: *Mr Speaker*, o a bo o tlaa letlelela Mothusa Tautona a re diele nako.

MR SPEAKER: Emang pele batlotlegi. Ke laola Ntlo fela, ga le ka ke la diega batsadi ba me. *I confirm fela. I have to satisfy all of you* Batlotlegi Mapalamente. *Gone in the meantime, I think Honourable Mmolotsi can go on speaking while we check dipalo. It is right gore Honourable Mmolotsi is on the floor...*

MR TSOGWANE: Thank you *Mr Speaker*. *Mr Speaker*, *ke ne ke sa gane gore o ka tswela. Ke batla gore* we must remind ourselves of the agreement. It is supposed to be eight BDP, four from opposition and two from the minority parties.

MR SPEAKER: Sorry Honourable Members. *Gone re mo tseleng.* Honourable Member for Francistown South, please go on.

MR MMOLOTSI: *Thank you Mr Speaker.* Ke simolola ka go supa gore ga go a re siamela re le Palamente ya Botswana gore mo nakong ya gompieno, re bo re santse re taboga re dira dilo ka diamaramara. Ka lebaka la gore re akanya gore go tlaa nna le mathata. *We did not plan*, ga re a ipha nako. Re felela re thulwa ke dikgang *especially* tsone tsa FATF. Di nna di tla kwa go rona o kare di tla ka tshoganetso. O kare ga re na *experts* mo Botswana tse di ka nnang di sekaseka melao nako le nako go bona gore molao wa rona o ka tswa o bo o tlhela eng, jalojalo. Ka tsela e e ntseng jalo, gore



nako le nako dikgang tsa melao ya tsa madi, di dirwa ka diamaramara, ga go a re siamela. Ke gakologelwa gore le mo Palamenteng e fetileng ya Bolesome, re ne re tswa masigo, re tswa phakela, e le gore re dira melao e ka lebaka la gore e re thudile. Re ne re sa itse gore ke melao e e sa lekanang, e e tlhaelang golo gongwe. E bo e le gore fa re setse re tsena mo mathateng re tloga re nna *blacklisted* kana *grey listed*, ke gone re iphitlhelang re le mo nakong e re tshwanelwang ke go taboga.

Ke dumela gore go ya kwa pele *Mr Speaker*, re tlaa tshwanelwa ke go nna le *experts* jaaka re na le tsone, tse di nnang di sekaseka melawana ya rona di e bapisa le ya mafatshe a mangwe. Di e bapisa le *requirements* tsa makgotla a e leng gore *we affiliate* le one gore le rona re nne *in control*. Re se ka ra nna re tabogile ka dinako tsotlhe. E re fa o santse o re o buisa phuthago ya Kgotla, go bo gotwe o a batliwa kwa Palamenteng go na le Palamente ya *Emergency*. Ga re a tshwanela go bereka ka *emergency*. Golo mo *Mr Speaker*, ke dumela gore go tlhoka *to plan*, go ipaakanyetsa diemo, ke go palelwa ke go busa. Nngwe ya *ingredients* tsa go busa mo go siameng ke gore e bo e le gore *we plan for* dilo tsotlhe *and we are always ready* go dira dilo sentle.

Having said that Mr Speaker, ke ne ke utlwa Mapalamente bangwe ba supa gore ba leboga Tautona Rre Masisi le Mma Serame gore ba bo ba ne ba baakanya molao gore re tswe mo thulaganyong ya *blacklisting* e re neng re le mo go yone. Ke supe gore gone golo mo, ke gone mo go kopakopanyang dilo. Mapalamente ba a itse gore Tautona le *Minister of Finance* ga se bone ba ba baakanyang molao. Molao o baakannwa ke Palamente. Ba bo ba ema fa pele ga *television* ya setšhaba ba re ba lebogela Tautona le *Minister of Finance* gore ba bo ba baakantse molao, mme ba ntse ba itse gore ga se Tautona le *Minister of Finance*. Paakanyo ya molao e dirwa ke Palamente. Gone golo mo, ga se go supa gore re tlhologanya se re se dirang re le Mapalamente. Ke go supa fela gore re akantse go bua ka tsela e e ntseng jaana, gongwe go ka go thusa gore o bone maemo a a botoka mme o sa rute setšhaba boammaaruri. Setšhaba se tshwanelwa ke go rutwa boammaaruri, se bolelelwe gore Palamente ke yone e e dirang molao mo lefatsheng la Botswana. Molao ga o dirwe ke Tautona le Tona a le nosi.

ASSISTANT MINISTER OF LOCAL GOVERNMENT AND RURAL DEVELOPMENT (MS MONNAKGOTLA): *On a point of clarification Mr Speaker*. Ke a leboga *Mr Speaker*. Ke utlwa motlotlegi a bua gore batlotlegi bangwe ba ne ba leboga Tona, e

bile ba ne ba leboga Tautona. Ke botse motlotlegi gore a mme o utlwile sentle kgotsa o tlhologanya sentle gore, molao gore o tle kwa Palamenteng, o a bo o tswa go dirwa pele kwa lephateng lone leo, a bo e le gone re tlang go o *debate* mo Palamenteng? Tanki *Mr Speaker*.

MR MMOLOTSI: Nnyaa *Mr Speaker*, ke dumela gore gongwe ke tswelile pele fela *as if* ga go a diragala sepe. Ke tsene fela mo kgannyeng ya gore ke rata go dumalana le bakaulengwe ba babedi ba ba buileng, Motlotlegi Ramogapi le *Honourable* Kapinga. Ba ba neng ba bua ka kgang ya gore *Clause 10*, jaaka e setse e supile, gatwe *Minister can declare* motho gore e nne *a terrorist*. *It does not matter* gore go na le *process* e e ntseng jang. Re a tlhologanya gore mo Pusong ya BDP, bo *Minister* ba kgona gore ba dirise *technocrats* dilo fela tse di duleng mo tseleng. Re a itse gore bo *Ministers are capable* go dira dilo fela tse di gakgamatsang. Ke sone se ke leng motho wa bofelo go ka dumalana le *...(Interruptions)...* gore gatwe *Minister* o ka neelwa dithata tsa *to declare* mongwe gore e nne *terrorist* ka gore ke a itse gore *they are capable of anything*. Ke batho ba go tlaabong go tswa fela mo go reng ka nako eo, ba teilwe gotwe ke mang yo o tshwanelwang ke go dirwa eng. Ka tsela e e ntseng jalo, fa ke lebile le ka fa Puso ya gompiano e tletseng boswele ka teng, go nna bokete go dumela gore ke ka neela Tona wa Puso ya Domkrag dithata tsa *to declare* mongwe gore e nne *terrorist*, ke ntse ke itse gore ba ka kgona gore ba dire sengwe le sengwe. O tlaa gakologelwa gore ngwana mongwe o ntse a taboga kwa *court*, gotwe *is charged* ka *terrorism* mme e le gore kwa bofelong jwa letsatsi, re lemoga fa e le gore ke fa ba boetse *charges* tseo kwa morago, mme kana *terrorism, punishment* ya teng *is capital*. Ke gore fa o bonwe molato wa gore o *terrorist*, o a bolawa. *So* ka tsela e e ntseng jalo, gore ke letlelele gore molao o o fete, o bua dikgang tse di ntseng jaana, o a ntshosa ka gore ka fa ke bonang Goromente yo, Puso e e le swele ka teng, Batswana ba le ba ntsi ba ka nna *declared terrorists*. E bile re a bona gore go na le ba ba alotsweng, ba e leng gore Goromente yo ga a ba batle, o lwa le bone. Gongwe e bile maikaelelo a molao o, fa gongwe ga se sepe se se kalokalo, ke go sala bangwe morago gore go tle go dirisiwe molao o gore jaanong ba kgone go tshwarwa ka gore ke lebaka le le leele Goromente wa Domkrag a ntse a batla go ba dira *terrorists*, mme go sa kgonagale ka gore *they are not ... (Interruptions)...* *So* ka tsela e e ntseng jalo, *I will not agree* gore ke fetise molao o o rialong.



MINISTER OF FINANCE AND ECONOMIC DEVELOPMENT (MS SERAME): *Clarification.* Thank you Mr Speaker. Tota ke ne ke rile ke tlaa itshwara, ke tlaa e araba kwa bofelong, jaanong ke bona o kare e a kekela ka segarona le Motlotlegi Wynter Mmolotsi. Batlotlegi, ke a le utlwa kgang e le e buang e Honourable Mmolotsi ya gore *Minister declares* gore motho ke *terrorist*, mme o bo o boa gape e le wena wa re *it does not matter* gore go na le *process*. Jaanong ga ke itse gore fa go na le *process*, o bo o re ga o na sepe gore go na le *process*, tota eo ga ke e tlhaloganye.

Potso e ke batlang go e botsa ke gore, a o a tlhaloganyane gore tota golo mo ga se gore go go sha? Go ntse go na le molao o o reng, *Minister can declare* motho gore ke *terrorist*, ke gore fela o ne o le ka kwa go ya *Counter-Terrorism*, now that the committee e sutela ka fa, ke sone se *Clause* eo jaanong le yone e sutelang ka kwa. Jaanong ke leka go go raya ke re, molao o kana o ntse o le teng, mme go ntse go na le *process*. Le ene ngwana yo o buang ka ene yo, ga a a ka a nna *declared terrorist*, go ne ga tsamaiwa ka *process* fela gore a seke. Jaanong ke ne ke batla go botsa fela gore a o a itse gore gone mo re go dirang mo, mo re go fetisetsang ka fa, go ntse go le teng *since 2014*? Thank you.

MR MMOLOTSI: Ke a itse gore go ntse go le teng, mme ke lebogela gore gompiano go bo go tsile mo *Bill* e, gore re tle re kgone go bua ka ga gone go le mo *Bill*. Ke na le tumelo e e seng kana ka sepe ya gore mabaka a teng a matona a a dirang gore le bo le go *transfer* go tswa ka kwa, go tla go tsena mo *Bill* e, mme e bile go na le thulaganyo ya gone e lona le e itseng ba e leng gore le a *transfer*. Gape le jaaka ke ne ke bua ka *process*, ke santse ke ipoeletsa ke re, fa mapolotiki a batla go dira se ba se dirang, ga o ka ke wa ba kganela, le *technocrats* ga di ka ke tsa ba kganela go dira se ba batlang go se dira, le fa di ka gakolola jang. Fa Puso e batla go dira se e batlang go se dira, e a se dira. Re a itse re ka a fa dikai tsa *maladministration* e e tswang kgakala e dirwa ke Puso ya Domkrag, go ntse go na le tsamaiso. Ka tsela e e ntseng jalo, ke sone se *Honourable Minister*; ke bonang go le bokete gore ke dumalane le gore thulaganyo e e tswelole ka gore *I know what you are capable of*.

Ke tswelole gape ke re, ke a tshwenyega tota ka fa dikomiti tsa rona re di dirang ka teng, jaaka dikomiti le *sub-committees* tse di dirwang mo go Goromente, *including this one*. Re tlaabo re na le thulaganyo e e tsepameng, e re itseng gore gatwe go tlhokiwa batho ba mofuta o o ntseng jaana le jaana. A bo e le gore

jaanong fa re ntse re itse gore go tlhokiwa batho ba ba ntseng jaana, ba ba ka dirang tiro ka botswerere, ba ba tseneng sekole *having specialised* mo *areas* tsa gore, re a e flogela re le Goromente, re bo re dira mo gotweng *tailored deployment*, a bo e le gore re tsaya bagarona ba mapolotiki, re ba tsenya mo maemong, re ba neela maemo a a sa ba lekanang. Ke ka a fa sekai fela gompiano jaana, gone mo Francistown, maloba fela *Deputy Court Presidents were appointed*. A bo e le gore fa go hirwa *Deputy Court Presidents*, mo Kgaolong ya Francistown South, go hirwa *former Councillor* wa BDP gatwe e nne *Deputy Court President*. Ke ipotsa gore *qualifications* tsa motho ene yoo, *that qualify him* gore e nne *Deputy Court President*, ke tse gotweng mang, ka gore ke Mokhanselara fela yo e leng gore ga re tlhaloganyane mo go kalokalo gore kwa ntle ga bokhanselara, *background* ya gagwe ke eng. Kwa kgaolong ya ga *Honourable Moswaane* yone *tailored deployment* e jaaka le bua ka *sub-committees that are going to be established*, le a itse gore le ya go dira eng. Kwa go *Honourable Moswaane*, go hirilwe *former Member of Parliament (MP)* yo e leng gore ga go na sepe se re ka reng se mmapisitse le tiro ya bo *Deputy Court President*. Ke gore le *assign* ditiro ka maemo a ga Goromente ...*(Interruptions)*... gore motho o dirile eng, *is qualified for* eng.

MR KEORAPETSE: *Elucidation Mr Speaker.* Ke ne ke re kana gone go *shoma* maemo mo, a *shomiwa* o kare go *shomiwa* kgwathe wa tlala kana go *shomiwa* kgori e *shomelwa* Kgosi, kana le kwa Selebi Phikwe ...*(Interruptions)*...kobo ka letshoba ka gore *former Councillor* wa Domkrag le gone koo o dirilwe *Court President*. A o a itse mokaulengwe gore go *shoma* moo le rona go re apesitse kobo ka letshoba kwa toropong ya Selebi Phikwe?

MR MMOLOTSI: Ee rra, gakere ke gore kwa bofelong jwa letsatsi, tiro ya ga Goromente ga e diragale sentle ka lebaka la gore *we are not deploying the right people at the right places*, re dira fela mo gotweng nnyaa, mme tlaa re direle bagaetsho ditiro ka lebaka la gore ke ba ba jelwe ke ditlhopho. Ka tsela e e ntseng jalo, ke a bona gore maikaelelo ke gore re ya *to establish a sub-committee to enable performance of its functions*. *Sub-committee* yone e, mo go nna, ke bona o kare ke go tshamekisa batho fela. Ke go tshamekisa setšhaba ka lebaka la gore bone ba ba yang go hirwa mo dikomiting tsone tse, ga se gore ba ya go hirwa ka lebaka la gore ba ka thusa ka sepe, ba itse tiro, ba na le *background* ya sone se ba se hirelwang, ba ya go hirelwa fela gore e rile fa gotwe, re a tsamaya Masisi o a re bitsa, le bone ba



bo ba tla ba tabogile. Dilo tse di a gaggamatsa, ke gore fa o bona le kgona gore le tseye motho fela le bo le mo neela bo *Court President* kana *Deputy Court President* fa re itseng gore *justice* e tshwanelwa ke go dirwa teng, go sekisiwa batho go lebilwe melao, mme a bo e le gore le tsenya mongwe le mongwe fela, o kgona go bona gore ga go na sepe se re ka tlholang re se kgona re le lefatshe la Botswana. Fa e le gore re palelwa ke go itse gore, gore motho a ye go nna *Court President* go tlhoka motho yo o nang le *exposure*-nyana ya molao, gongwe a kile a nna leporidise kana a dira molao golo gongwe.

Jaanong ga re tlhabiwe ke ditlhong gore re bo re iphitlhela re le Goromente re zamelana ditiro tsa setšhaba, re sa sale tsamaiso morago. Ka tsela e e ntseng jalo ke sone se ke neng ke re ke batla go dumalana le bakaulengwe ba ba reng, e-e molao o tota e re ntswa re o tlhoka gore o tshwanelwa ke gore o baakanngwe o nne sentle, mme re tshwanelwa ke gore re itise. Thatathata lona babusi, le itise go bona gore ga le dirise melao e ditiro tse e leng gore kwa bofelong jwa letsatsi re tlaa di itsholela, e le gore ditiro tsa rona tsa ga Goromente ga di diriwe sentle. Re a palelwa ka lebaka la gore batho ba re ba tsentseng mo go tsone ke ba ba neng ba sa di kgone, ba tsenyeditse fela gore ke batho ba e leng gore ke maDomkrag jaaka rona.

Gape ke batla go dumalana le *Honourable Kapinga* gore, *I would have preferred somebody else, and not that Honourable Kapinga has suggested* Central Bank Governor, *I think* ke *suggestion* e gongwe ke ka tsamaya le yone ya gore, tota fela *we know* gore the Central Bank Manager or Governor ke ene yo e leng gore ditiro tse, o dira tiro e *on daily basis*, o tlhologanya *financial matters*. O tlhologanya tse tsotlhe tse di tsamaelanang le madi, *and therefore that particular person will probably be the right person* gore re mo tsenye koo ka gore bo Permanent Secretary (PS) *are administrative*, ba neelwa maemo fa gongwe gotwe bo PS bo *administrative* fela *they can run*, mme ba sena *understandings* ya *those particular areas*. *In this particular case we are dealing with a highly specialised area*, e e leng gore fa re batla gore tiro e e dirwe sentle re tshwanelwa ke gore re senke yo o tlaa yang go e tlhologanya sentle ka botswere, e se wa nkgosa kgoa. Kwa bofelong jwa letsatsi re batla go direla lefatshe la Botswana tshiamo, mme fa re batla go direla Botswana tshiamo *we need to engage the best and the brightest*, gore ba kgone go tsamaisa itsholelo e, ba kgone go tsamaisa lefatshe le. Fa re sa dire jalo re tlile go felela re ipona jaaka o bona gompiano jaana, e le gore ga go na se se tsamayang sentle, Goromente ke

mokang a le *collapsed*. Gompiano jaana le ba re neng re ka baya mo go bone bo Motlotlegi Dr Matsheka re re gongwe ba ka thusa ke ba ba dule, ba re neng re ka baya mo go bone re re ba ka thusa bo Motlotlegi Rre Balopi, ke bao le bone ba dule. O kgona go bona gore jaanong Goromente *who is presiding over this country* re mo mathateng a a gaggamatsang, a o tlaa ipotsang gore a go a itsiwe gore go iwa kae, go a go buiwa leng, kana batho ba mo lefifing fela. Tota re na le mathata a matona mo lefatsheng la Botswana, ke sone se o bonang jaanong malatsing a sengwe le sengwe se itsamaisa sesole.

HONOURABLE MEMBER: Point of order Mr Speaker.

MR MMOLOTSI: Sengwe le sengwe se itsamaisa sesole...

MR SPEAKER : Point of order, Honourable Mmolotsi, point of order supersedes all other points.

LEADER OF THE HOUSE (MR TSOGWANE): Mr Speaker, we agreed at the General Assembly after long struggle that we must manage our debate in such a manner that we are going to use option number three. Now I can see that we are not even following what we have agreed upon. If I may remind you Mr Speaker option three states that, there will be 14 speakers- ruling party nine, opposition four, minority one, speaking for 20 minutes. That is option three that we have agreed with. So with ruling party only six so far, but if we decide to save time as ruling party we can forego our three members. So we are completely out of order. We are completely out of order, if the list has been exhausted by the other parties then we must stop. Mr Speaker, let us follow what we have agreed on. That is my point of order. Thank you.

HONOURABLE MEMBER: Letsatsi leno go ne gotwe *we should not debate*, o se ka wa lebala, o di bue tsotlhe. Go ne gotwe re simolola *debate* kamoso. E re o ntse o kotela *Speaker* jaana o ...

MR TSOGWANE: Jaanong *what are you debating*, fa e le gore go ne go tilwe le se ka la *debate*? Re ka bo re nnile le *free day*. Ga o na...

HONOURABLE MEMBER: *Le wena* you have debated.

MR TSOGWANE: Wena kana motho wa Mahalapye ga o ke o batla go bua sepe se se tsamaelanang le batho ba bangwe.



HONOURABLE MEMBER: ...*(Laughter!)*... O teng mogolole?

HONOURABLE MEMBER: Mahalapye o mo tsenya fa kae, VP dumela!

MR TSOGWANE: Re teng re go nyoretsewe. Re ne re nyoretse go utlwa lentswe la gago.

HONOURABLE MEMBER: Mme o ne o re tshwere sentle maloba VP!

MR TSOGWANE: Kae?

HONOURABLE MEMBER: O ne o re tshwere sentle maloba o eteletse lefatshe VP!

MR SPEAKER: May we have order please! May we have order please Honourable Members! *Nnyaa, mme re tlhamaletse bakaulengwe*, the ruling party *e tlisitse* six. So far *mo go wa* opposition *re mo go wa bo* five, *go santse go setse* two.

MR TSOGWANE: *Nnyaa Mr Speaker*, go setse *two* jang ka gore *option* ...

MR SPEAKER: Hang on a second, *go raya gore* Opposition drew...

HONOURABLE MEMBER: ...*(Inaudible)*...

MR SPEAKER: *May we have order please!* BDP e tlhabela ka *three*, jaanong fa lona le re file *six* fela, ga re ka ke ra tsamaya ra botsa gore le tsamaya fa kae.

MR TSOGWANE: *Mr Speaker, let us correct this*, kana *slots* tse go tilwe fa re batla *to save* nako, batho ba ka nna ba seke ba bue. *So let us stick to the numbers*, not gore ba ba BDP ba buile. Mo BDP re ka nna ra bua re le babedi *to save time*. *So they do not pass onto the opposition* bone ba tsaya tsa bone *slots*, *that is the principle*.

HONOURABLE MEMBER: le nna ke tlogetse nako e ntsi, *eight minutes saving* nako. Re ja nako jaanong fa re riana

HONOURABLE MEMBER: Gakere fa o buile VP o a bo o ba bueletse, kana ba utlwa ka wena fela.

HONOURABLE MEMBERS: ...*(Murmurs)*...

MR TSOGWANE: Nna ke bua ka se re se dumalaneng, *I am not instructing* ope.

HONOURABLE MEMBER: A VP o fetogile go nna *Speaker* jaanong?

HONOURABLE MEMBER: O a tshosetsa. ...*(Laughter!)*...

MR TSOGWANE: *Nnyaa*, ke bua ka se re se dumalaneng, re tshwanetse gore re sale se re se dumalaneng morago.

HONOURABLE MEMBER: Jaanong ke eng mme o ntsha *directives*?

HONOURABLE MEMBER: *No* ga se *directive*, tumalano.

HONOURABLE MEMBER: O gakolotse go utlwilwe, ba tlaa e diragatsa ba tsaya ditshwetso, gakere ga se ene a tsayang tshwetso.

MR TSOGWANE: ...*(Inaudible)*...

HONOURABLE MEMBER: Ka re maloba o ne o re tshwere sentle VP, o palame sefofane o re tsholeletsa lebogo!

HONOURABLE MEMBERS: ... *(Laughter!)*...

HONOURABLE MEMBER: A tsena go sele. O ne a timela akere, le lebetse?

MR TSOGWANE: O *lucky* ka gore motho fa a *act* ga a na dithata tsa go atholela lesa, o ka bo...*(inaudible)*...

HONOURABLE MEMBERS: ... *(Laughter!)*...

HONOURABLE MEMBERS: ...*(Murmurs)*...

MR SPEAKER: May we have order please! May we have order Honourable Members! I have indeed verified our figures and the agreement as stated by His Honour the VP. *Mmang ke le tlhalosetse fela jaana bakaulengwe*, *go ne go tilwe* the ruling BDP *e tlise* nine, on their own accord *ba bo ba felela ba le* six, *e le* gore nine ke ya BDP, opposition *ga bo gotwe e tlise* five, altogether makes 14. *Go raya gore* BDP *ka gore* you decided *gore le tlisa six le feletse gone foo*. The Opposition *go dumalanwe* five, so indeed Honourable Mmolotsi is the fifth Member of the Opposition. *Re tlaabo re ema ka* Honourable Mmolotsi. *Ba bangwe ba ba kwadileng kwa morago ga ga* Honourable Mmolotsi *go raya gore ga ba yo mo palong*. *Re ne re sa lebelela* the slot until His Honour the VP queried. *So re ya go ema ka* Honourable Mmolotsi and then we will call upon the Honourable Minister responsible for the chapter to respond to the debate.



MR MMOLOTSI: Thank you very much. O a bona Honourable Minister Serame *gore Matona a puso fa ba batla selo...*

HONOURABLE MEMBER: Procedure Mr Speaker!

MR MMOLOTSI: Ke gore le *Speaker* o ka kgokgontshiwa ...

MR SPEAKER: Go na le mongwe yo o batlang *procedure*, ga ke a utlwa. *There is somebody calling, is that Honourable Member for Bobonong?*

MR LUCAS: Ee rra. Ke ne ke re *Mr Speaker* kana fa o bua ka dipalo tse o di buang tseo ke tsaya gore o di amanya gape le nako. Jaanong fa ba BDP ba rile ga ba na kgalhego ya go bua ke tsaya gore nako e e neng e beetswe *Bill* eo e santse e le teng, ka jalo o ka re letlelela gore re e buisane ka gore ke tsaya gore *Bill* e e bothokwa fela thata.

HONOURABLE MEMBER: Procedure Mr Speaker.

HONOURABLE MEMBER: Procedure Mr Speaker.

MR SPEAKER: Bagaetsho, emang pele, ba bangwe ba bua fela ke sa ba utlwe. *The last Honourable Member of Parliament that we are responding to o ne a eme ka procedure, which I think we have cleared and then we called Honourable Mmolotsi to resume his position. Ga ke itse gore jaanong mathata a fa kae? Re dumalane, ke ne ke bala tumalano ya rona ya General Assembly bakaulengwe. Five from the opposition and nine from BDP. BDP decided gore ba tlaa bua ba le six, so they have exhausted their slot. Opposition.*

HONOURABLE MEMBER: Procedure Mr Speaker, Boko.

MR SPEAKER: Honourable Boko, what is your procedure *mokaulengwe*?

MR BOKO: *Procedure. Thank you Mr Speaker. Ke ne ke re gongwe re thusaneng fa because kgantele re ya go fitlhela e le gore mo Bill e nngwe e e latelang, Domkrag e ntsha motho a le mongwefela go tla go bua, maikaelelo e le go somarela nako, UDC ba bo ba exhaust slots tsoitlhe tse ba di neetsweng. I do not think go tidy Mr Speaker gore jaanong le rona e nne e kete re gaisana ka go leka go ka somarela nako. The intention is not to save time but to fully engage on the Bills which are before us.*

This is Parliament Mr Speaker and we are talking about most important Bills tse di yang go dirisiwa ke kokomane e e tlang and ga re ka ke ra dumalana mo

goreng... ke dumalana le Mapalamente ba ba reng fa e le gore Domkrag e tliša six instead of nine, then it means there is extra 30 or 40 minutes which can be taken by the opposition so that we can fully engage and come up something se se nonofileng Mr Speaker. Ga ke itse gore re ka e leba ka tsela e e ntseng jang. Ke ne ke kopa ke ikokobetsa ka botho jo bo kalokalo. Thank you Mr Speaker.

HONOURABLE MEMBER: O ne o seyo kwa *General Assembly*?

MR BOKO: Nnyaa, ga ke bue dikgang tsa *General Assembly. In as much as...(Inaudible)... it does not make sense for me to say nnyaa re batla Honourable Slumber Tsogwane e nne ene fela yo o buang, ba bangwe ba se ka ba bua because re alotse nako. No, we cannot do things like that. We need to be smart about this Mr Speaker.*

HONOURABLE MEMBER: Boko, kante o bua o le kae monna? Fa o kare o kgakala jaana.

MR BOKO: Ke mo Gaborone.

HONOURABLE MEMBER: Procedure Mr Speaker.

HONOURABLE MEMBERS: ... (Murmurs)...

HONOURABLE MEMBER: Re eme fela, ga gona se se tswelelang.

MR SPEAKER: I will respond to you just now Honourable Boko. *Ke leba ditumalano tsa rona.*

...Silence...

HONOURABLE MEMBER: Procedure Mr Speaker.

MR SPEAKER: Nnyaa, ke lebeletse ditumalano tsa phakela bakaulengwe. Re dumalane ka bakaulengwe ba le 14, go tlaa bua batlotlegi ba le 14; *nine* ya BDP, *five* ya *opposition*, mme botlhe ba ya go tshwara *five hours*. BDP *decided to go to six, opposition* e ya kwa *five*, mme tse tsoitlhe di tshwanetse tsa dirwa *in five hours. Five hours* ga a ise a wele, *so* re a tswelela bakaulengwe. Honourable Mmolotsi.

MR MMOLOTSI: Ke a leboga *Mr Speaker*. Ke ne ke santse ke re ke a re Honourable Peggy Serame o bona le ene fa ke ne ke...

MR TSOGWANE: *Procedure Mr Speaker. If we go against what we have agreed, then we will decide to get our three slots. Go tlaabo go bua rona fela because re ne re ithaya re re the essence of this Meeting was to save*



time so that re fetse Bills tse ka nako e bo e le gore last week ga re e fetse, gongwe re fetse ka Labobedi re bo re neela Private Members gore ba botse dipotso, ba tle ka Motions. If we now say we stick to time, not to the numbers, then it is a different agreement. It is a different agreement because we have stuck to numbers. So, if we go by number, we will get our three slots. Our Members are ... (Interruptions)... bone ba feditse tsa bone, ba bararo ba ba setseng ke BDP, re tsholetsa matsogo. Thank you.

HONOURABLE MEMBER: Fa go ntse jalo, go raya gore re tsene mo laeneng.

HONOURABLE MEMBER: VP o tlhakathakanya Palamente.

MR TSOGWANE: Ke lona le tlhakathakanyang, *we cannot agree on something* re bo re ya go dira se sele.

HONOURABLE MEMBER: Ke wena le *Speaker* gakere.

MR TSOGWANE: *The issue of hours* ke gore ga le ka ke la feta *hours* tsa gore. *It is not that you must exactly get those hours.* Ke gore ga le ka ke la feta *five hours.* *That is the essence of the hours.* Ga se mo gotweng nnyaa, ga le ka ke la goroga kwa go *five hours* re a tshaisa.

HONOURABLE MEMBER: Point of order.

MR TSOGWANE: *These are our three slots,* tsholetsang diatla bakaulengwe maDomkrag, *slots* tse tharo tse ke tsa lona. Tsholetsang diatla.

HONOURABLE MEMBER: Point of order Mr Speaker!

HONOURABLE MEMBER: Procedure!

HONOURABLE MEMBER: Point of order.

MR SPEAKER: May we have order please! You have made your point.

HONOURABLE MEMBERS: ... (Murmurs)...

MR SPEAKER: Emang pele bagaetsho!

HONOURABLE MEMBER: Point of order.

MR SPEAKER: VP o ne a eme ka *point of order.* *We have to respond to him and then we go to another one.* Jaanong go mo go lona kana *Your Honour.* Fa e le gore le ikotlhaela gore batho ba lona ba bararo ga ba a bua,

le batla gore ba bue, go mo go lona le ka dira jalo. Mme kana le itse gore re wela ka tumalano ... (*Interruption*)... ka tumalano ya lona ya *nine*, e le e boneng go sa tshwanela.

HONOURABLE MEMBERS: ... (Murmurs)...

MR MMOLOTSI: Ke a leboga *Mr Speaker.* Ke tsaya gore *Honourable* Peggy Serame o bona *point* e ke neng ke bua ka ga yone gore ...

MR SPEAKER: *Honourable* Mmolotsi, ema pele.

HONOURABLE MEMBER: Procedure.

MR SPEAKER: *Honourable* Kablay, what is your procedure?

HONOURABLE MEMBER: Nnyaa, ke sale ke kopile *point of order* *Mr Speaker.*

MR SPEAKER: Ke tla kwa go wena mokaulengwe, ke ne ke sa go utlwa. *Honourable* Kablay, what is your procedure?

GOVERNMENT WHIP (MR KABLAY): *Mr Speaker, my procedure* e ne e le gore jaanong le dira tiro ya rona bokete *sir.* Re ne re dumalane gore go ya go bua Mapalamente a Domkrag a le kana, a *opposition* a le kana. Jaanong rona *to save time, that is why* go buile ba le *six.* Jaanong *slots* tse di setseng, ke tsa rona jaaka VP a bua *Mr Speaker.* Jaanong *slots* tse, go ya go bua *Honourable* Morwaeng, *Honourable* Mthimkhulu le *Honourable* Leuwe, fa e le gore o batla gore di tsamaye jalo. Rona re ne re leka *to save* nako. Fa e le gore ga le batle *to save nako,* go raya gore re tlaa tswelera re *debate.*

Honourable Saleshando le *Honourable* Motsamai, re tswa go dumalana kwa *Advisory Committee* gore re tllile go dira jang. Tshwetso ya rona ra e isa kwa *General Assembly,* ra feta ra dumalana koo. Jaanong ga ke itse gore *Mr Speaker* fa o ganana le ditshwetso tse di dirilweng kwa *Advisory Committee,* mosola wa teng ke eng gore le dumalane dilo koo, e re le tsena mo Palamenteng le bo le tla le fetola se re se dumalaneng? *It is not fair* *Mr Speaker.* As *Chief Whip,* le dira tiro ya me bokete *to my colleagues* ba Domkrag.

Rraetsho, jaaka Mothusa Tautona a bua, re sale re feditse kgang bogologolo. Jaanong fa o simolola o e busa o re nnyaa wena o batla *five hours, no, this is not fair* *Mr Speaker.* Thank you.

HONOURABLE MEMBER: ... (Murmurs)...



MR SPEAKER: Iketleng bagaetsho. Ke lona le ntlhakatlhakanyetsang. Ke le reile ka re *opposition* ba mo mothong wa bone wa bofelo wa bo *five*, BDP e feditse batho ba bone ba ba *six*. Ke lona jaanong le batlang go tsenya *three*, ke lona le tlhakatlhakanyang. *According to* tiro yame fa, e ne e le gore *Honourable* Mmolotsi ke ene wa bofelo ke bo ke bitsa *Minister*. Jaanong lona le a ntlhakatlhakanyetsa la re le kopa ba bangwe ba bararo. Yo o tlhakatlhakanyang ke mang?

HONOURABLE MEMBERS: ... (Murmurs)...

HONOURABLE MEMBER: *Mr Speaker, you changed*, la bofelo o bo o re jaanong *let us continue*, nako ke *five hours*. Ke gone fa re tlleng ra fetoga teng. Fa e le gore re go utlwa jaaka o bua ...

MR SPEAKER: Ke ne ke bala se se kwadilweng ke lona. *Your Honour, please*, re tlogeleng bagaetsho re tsamaisa Palamente.

HONOURABLE MEMBER: Ba buile ba le *six*...

MR SPEAKER: Ba buile ba le *six* ba feletse, go tshwanetse go tsene *Honourable* Mmolotsi.

MR MMOLOTSI: Ke tsaya gore *Honourable* Serame o bona kgang e ke ntseng ke e bua gore, fa Matona kana Mothusa Tautona ba batla gore sengwe se dirwe ka fa ba batlang ka teng, go ya go felela se dirilwe ka fa ba batlang ka teng. Jaaka o bona Mothusa Tautona jaanong a tsere Palamente a batla gore a e dire bana ba gagwe, a go dire ngwana wa gagwe, go bereke ditshwetso tsa gagwe fela. Tsone dilo tse, di dira gore ke nne le mathata a go dumalana le gore *Minister can declare* motho gore e nne *terrorist*.

Kwa bofelong *Mr Speaker*, ke dumalana le gore re tshwanelwa ke gore fa re sena go nna re ntsha dilabe tsone tse, molao o re o fetise ka gore *it is undesirable for a country to be black listed or grey listed*. E bile ke le rotloetse gore *going forward Minister*, dilo tse a e se ka ya nna *emergency*. A re nne re ntse re le baleba *and compare* le gore mafatshe a mangwe a dira eng, *compare* gore le tsone *organisations* tsone tse gore ba batla eng jalojalo gore re se ka ra iphitlhela re le mo mathateng.

Kwa bofelong, ke leboge Rre Balopi le Dr Matsheka gore go ntse jalo, fa o bona seemo e le gore go mathata, ga re o tswe mo seretseng, o se ka wa tla wa maramariwa ka sone. Jaanong ke rotloetsa gore gongwe *Honourable* Mmusi le bo *Honourable* Moagi le bone ba letlelele bo Healy ba tsene kwa, bone ba tswela kwa ntle, re tle re ...

HONOURABLE MEMBER: You are out of order.

HONOURABLE MEMBER: O a bo o ka simolola Wynter.

MR SPEAKER: Order please. Honourable Mmolotsi, please confine yourself to the Bill.

MR MMOLOTSI: Ke ne ke digela jalo ka gore bo *Honourable* Mmusi le *Honourable* Lefoko ga ba a tshwanelwa ke go nna mo nthagarageng eo. Le nna fa ke ne ke le Rre Balopi kana Dr Matsheka, ke ka bo ke sa bolo go sia ka gore tota o a bona gore golo kwa seemo se dule mo tseleng, mo e leng gore ope yo o nang le serite sa gagwe go ya kwa pele...

HONOURABLE MEMBER: Nna o ntsenyetsang mo teng jaanong?

HONOURABLE MEMBER: Ke wena o tshwanelwang ke nthagaraga eo.

HONOURABLE MEMBER: Lefoko o gogobisa seriti.

MR SPEAKER: Order please. Are you done Honourable Mmolotsi?

MR MMOLOTSI: Ke ne ke re *Mr Speaker, Honourable* Lefoko le Rre Mmusi le bone ba tswe ba se ka ba tla ba ...

MR SPEAKER: *Confine yourself to the Bill Honourable* Mmolotsi, ao batho ba Modimo.

MR MMOLOTSI: Ke a leboga *Mr Speaker*. Mafoko ame a gorogile.

MR SPEAKER: Thank you very much. Your time is up. *Re digetse dipalo tse re neng re di dumalane*. Honourable Minister Serame, please respond to the debate.

HONOURABLE MEMBER: Ya *five hours* o e fetogetse?

MINISTER OF FINANCE AND ECONOMIC DEVELOPMENT (MS SERAME): Thank you Mr Speaker and good afternoon.

HONOURABLE MEMBER: Procedure Mr Speaker.

MS SERAME: Batlotlegi Mapalamente a a tlotlegang, ke kopa gore re tlotlaneng, re reetsaneng tlheng bagaetsho. Ke kopa go simolola fela ...



HONOURABLE MEMBER: Ke a go tlotla Motlotlegi Serame, ke kopa *procedure*.

MS SERAME: A ko o didimale Boko.

HONOURABLE MEMBER: *Ke kopa procedure from the Speaker Honourable Serame.*

MR SPEAKER: What is your procedure Honourable Boko?

MR BOKO: On a point of procedure. Thank you Mr Speaker. Mr Speaker, two thing, and *ke kopa gore le ntheetse* this time around.

Ya ntlha Mr Speaker, you have made a ruling *ya gore* we need to exhaust the five hours, you will tell us *gore jaanong o e boela morago*, it is not a problem.

Number two Mr Speaker, tell us, in the event that in the next Bill Domkrag *e ntsa motho a le mongwefela* to debate *kana ba le babedi*, opposition *le yone e bo e ntsha ba ba dumalanweng kwa* General Assembly, *a re ya go tswelela e le gore jaanong maikaelelo a rona ke go alola nako fela kana ka tsela e e ntseng jang* Mr Speaker? We need to be very clear along these things; clear it now. That is the procedure *e ke batlang gore re tsene mo go yone*. If we are left with 20 minutes Mr Speaker, we need to use those 20 minutes to debate this. This is not a marathon. We need to deal with the substantive issues. *Ga ke itse gore a ke a utlwala* Mr Speaker.

HONOURABLE MEMBER: Mr Speaker, let us not waste time *ka batho ba ba sekeng ba attend* General Assembly or whatever *sa Palamente* please. *Motho yo o re diela nako*. Can we proceed?

HONOURABLE MEMBER: O supilwe ke mang? O a bo one o ntse o didimetse fela fa.

HONOURABLE MEMBER: O *Speaker-nyana*.

HONOURABLE MEMBER: *Mr Speaker*, ga ke na nako le batho ba ba senang mosola mme e le *Ministers*. A tsentswe fela ka lenngobe.

HONOURABLE MEMBER: Ba batla go shankodisa maDomkrag *as usual*. Le shankodisa fela le apaya dibese ka bomo.

HONOURABLE MEMBER: O tlaa dija dibese tsa teng.

HONOURABLE MEMBER: Batho fa ba palelwa o ba bona fela jalo.

MR SPEAKER: Bagaetsho, re dumelane gore go ya go bua batho ba le 14; 14 e buile, *five hours was just an estimate* e ke e bonang e kwadilwe fa gore fa mongwe le mongwe a bua 20 *minutes*, mme 20 *minutes* yoo *times* 14 ga a dire *that five hours. This is just a rough estimate. So re dumelana* bagaetsho, ke ngwaga o mosha ...

HONOURABLE MEMBER: O tsere *instruction* mo go *Vice President* gakere.

MR SPEAKER: Order! Order! Honourable Minister, please respond to the debate.

HONOURABLE MEMBER: ... we are a progressive democracy.

MS SERAME: *Thank you Mr Speaker*, ke kopa go tswelela Batlotlegi.

Tlaa ke simolole ka go leboga batlotlegi botlhe ba ba nnileng le sebaka sa go akgela mo Molao-kakanyetsong o. Bontsi jwa bone ba ne ba lemoga le botlhokwa jwa gore re bo re fetisa molao o. Ke kopa gore rotlhe jaaka re o beilwe pele, ga se wa ga Peggy Serame, ga se wa *party* e e busang, ke molao wa Botswana. Ke o re tshwanetseng gore fa re o sekaseka, re o lebelele gore re le lefatshe fa re ka se ka ra o fetisa, go ka re baya mo seemong se se ntseng jang. Ke leboge Mapalamente otlhe a a tlotlegang ka gore tota fela ka bongwe jwa pelo, *safe for a few*, rotlhe ra re nnyaa molao o botlhokwa re lebeletse dintlha tsotlhe tse re neng re di bewa pele tsa gore ke eng re le fa re leng teng, re tshwanetse gore re o fetise re le Mapalamente.

Batlotlegi ba bangwe ke ntse ke utlwa ba umaka gore kgotsa ba ka nna le keletso ya gore go ka dirwa dingwe Ditshutiso mo Molao-kakanyetsong o. Jaanong ke a le kopa, molao o o dirwa ke batla ba le bantsi, ba o ba latolang *Honourable* Mmolotsi o re ga o itse gore ba teng, e le baitsaanape ba ba farologanyeng, ba mehama e e farologanyeng. Ba nna fa fatshe, ba thulanya ditlhogo gore kwa bofelong o bo o na le *Bill* e e leng fa pele ga gago. Gore re fetole *clause* epe fela *or even a sub-clause* mo teng, *it also takes me going back to get advice from the expert* ba *Honourable* Mmolotsi a sa itseng gore ba teng mo Botswana, mo ga Goramente. mongwe o re o dirang fa, le sepe fela se re se fetolang, re tshwanetse gore re bo re ya go lebelela melao e mengwe yotlhe e mentsintsi tota gore fa re fetola seo, go ya go ama jang melao e mengwe eo yotlhe. Jaanong ke a le kopa gore re ka berekela mo nakong.

Ntlha e nngwe ke gore *Honourable* Mmolotsi a re dilo di nna di le lepotlapotla ga a itse gore batho ba ntse ba dira eng. Ke ne ke itheile ka re fa re simolola Palamente e, ke ne ke go bone ke tsaya gore ka ke buile ka bolelee ke tlhalosa *process* yotlhe ya gore go diragetse eng *from* 2017 le maiteko a rona otlhe, le gore re ntse re dira eng *up to this point*, o ne o le teng, o reeditse. Fa o ne o ntheeditse, o ka bo o sa bue mafoko a a reng batho ga ba *plan*, ba tla ka lepotlapotla ka gore o ka bo o tlhalogantse gore go na le *process*. Gompiano re fa Palamenteng e gore re fetise melao, re bo re ipha sebaka sa *six months* gore re tle go sekasekwa gape. E re ngwaga wa 2024 fa o ya go goroga re tla go dira tshekatsheko e e tseneletseng, re bo re le mo maemong a mantle a gore re fetisitse melao e bile e diragaditswe, re na le se se ka bonagalang *on the ground* gore nnyaa maduo ke a a gore molao o teng e bile o a diragadiwa. Ke sone se re leng fano gompiano. Fa e le gore ga se gone mo go bidiwang *planning*, ga ke itse gore jaanong moo re tlaa go bitsa re reng.
