- 1. MR. C. K. HIKUAMA, MP. (MAUN WEST):** To ask the Minister of Labour and Home Affairs to apprise this Honourable House on the benefits and resourcefulness of migrants to the Botswana economy; and to further: **(483)**

 - (i) provide a detailed report on the total tax revenue and Foreign Direct Investment (FDI) contributed by migrant-owned businesses over the last three (3) financial years;
 - (ii) state the extent to which the Ministry has assessed the impact of migrant entrepreneurs in diversifying the economy away from diamonds, particularly in sectors such as manufacturing, retail and agribusiness; and
 - (iii) explain the extent to which progress has been made in the development and implementation of the National Migration Policy to ensure that the entry and stay of migrants are orderly, legal, and aligned with Botswana's national security interests.

- 2. MR. G. DISHO, MP. (OKAVANGO EAST):** To ask the Minister for State President, Defence and Security to apprise this Honourable House on Botswana's long and porous International Border Line (IBL) considering that every year, countless incidents and reports are made on cross-border vices such as poaching, wildlife smuggling, cattle rustling, illegal mining, smuggling of goods and persons as well as murders among others; he should further state: **(488)**

 - (i) steps his Ministry intends to take to address cross-border crime in the absence of a fully functioning border patrol management authority;
 - (ii) the reasons why the border patrol management authority has not yet been set up; and
 - (iii) when he intends to set it up or a similar agency in that respect.

3. **MR. T. B. LUCAS, MP. (BOBIRWA):** To ask the Minister of Health to apprise this Honourable House on how the shortage of medicines in the country has affected mortality numbers in the referral and main hospitals. (489)
4. **MR. K. S. GARE, MP. (MOSHUPA-MANYANA):** To ask the Minister for State President, Defence and Security to update this Honourable House on the following matters: (490)
 - (i) progress to date regarding Political Party Funding;
 - (ii) what steps Government has taken since the last update to regulate, disclose, and administer funding of political parties;
 - (iii) what challenges the Ministry has encountered in ensuring transparency in political party donations, and what measures are being implemented to address them;
 - (iv) what laws and policies are in place to monitor and enforce accountability of donations to political parties and politicians;
 - (v) which specific Acts, regulations, or policies currently govern donations to political parties and individual politicians;
 - (vi) which institution(s) are mandated to monitor, audit and enforce compliance, and the powers they have to investigate breaches;
 - (vii) what mechanisms exist for public disclosure of donations above, and how often such disclosures are made to Parliament and the public; and
 - (viii) what penalties are prescribed for non-compliance, late disclosure, or anonymous donations beyond what the law allows.
5. **MR. K. NKAWANA, MP. (SELEBI PHIKWE EAST):** To ask the Minister of Water and Human Settlement to state the number of: (500)
 - (i) houses which were built under the Bonno National Housing Programme and allocated for subsequent occupation in the Selebi Phikwe East Constituency since the inception of the programme;
 - (ii) partnership companies involved; and
 - (iii) tenants who have occupied the houses.
6. **MR. O. KEDIKILWE, MP. (SEROWE WEST):** To ask the Minister of Health to update this Honourable House on mortality rates within the Serowe District Council area; and to specifically state: (512)

- (i) whether the Ministry is aware of the high number of deaths reported under the Serowe District Council;
 - (ii) clinical or environmental factors that have been identified as the primary cause of these deaths;
 - (iii) whether the ongoing shortage of essential medicines and medical supplies is a direct contributing factor to this spike in mortality; and
 - (iv) immediate corrective measures and assurances that can be offered to Batswana, if shortage of medicine is indeed the cause of death.
7. **MR. A. K. KHAN, MP. (MOLEPOLOLE NORTH):** To ask the Minister of Water and Human Settlement to state: (520)
- (i) the names of all companies that submitted proposals for the infrastructure development component of the Bonno Housing Project;
 - (ii) the procurement process followed in identifying these companies and whether that process complied with the Botswana Housing Corporation (BHC) Procurement Policy and the Public Procurement Act;
 - (iii) whether the BHC Board of Directors approved the infrastructure business case before its dissolution; and
 - (iv) whether the Minister of Finance approved the proposed financing arrangements, including any advance payments and sovereign guarantees requested by the contractors.
8. **MR. M. MOALOSI, MP. (NKANGE):** To ask the Minister of Local Government and Traditional Affairs: (4)
- (i) to confirm whether farmers in Bobirwa who lost their cattle due to cross border cattle rustling were compensated by the Government;
 - (ii) if *mephato* in Bobirwa are being paid through Ipelegeng to help patrol the area to curb stock theft;
 - (iii) why has this compensation programme not been extended to the people of Tutume District particularly in Maitengwe and Sepako;
 - (iv) if he does not see the need to treat all Batswana equally and apply similar compensation measures to all similarly affected farmers; and
 - (v) what is the new Government's long-term plan to help farmers to better secure their livestock from cattle rustlers.

9. **MR. P. K. MOTAOSANE, MP. (THAMAGA-KUMAKWANE):** To ask the Minister of Finance to update this Honourable House on the main reason behind the Government's decision not to pursue the De Beers tax debt that was alleged to be in the region of P14 billion. (411)
10. **MR. M. BAGAISAMANG, MP. (SHOSHONG):** To ask the Minister of Trade and Entrepreneurship to update this Honourable House on the Letsema Horticulture Market; and to state:
 - (i) whether Government acknowledges that its initial design was based on an outdated supply driven model with limited market integration;
 - (ii) the current operational strategy, including governance, market access, pricing, and farmer participation;
 - (iii) the key challenges affecting performance, particularly competitiveness, coordination, and sustainability;
 - (iv) the future development strategy to reposition the Market as a demand driven, export oriented horticulture hub; and
 - (v) what informed the shift in Government's approach, including lessons learned and private sector input.
11. **MR. D. SALESHANDO, MP. (MAUN NORTH):** To ask the Minister of Lands and Agriculture to state if:
 - (i) Botswana Agricultural Marketing Board (BAMB) was operating profitably as at the end of December 2025 as announced by the President to the nation; and
 - (ii) there had been any organisational strategic plan adopted by the Board pointing to possible profitability by December 2025, if the organisation remains loss making.
12. **MR. L. BARONGWANG, MP. (MOGODITSHANE EAST):** To ask the Minister of Child Welfare and Basic Education: (471)
 - (i) to state the difference in the general job descriptions, scope of work and remuneration between Teacher Aides and Care Takers;
 - (ii) if there is a difference in remuneration and conditions of service between those employed directly by the Ministry of Child Welfare and Basic Education and those employed under the Ministry of Local Government and Traditional Affairs;
 - (iii) whether her Ministry provides any form of assistance to these cadres, such as training opportunities, housing, or allowances, in recognition of their work demands and specialised roles; if so, what specific programmes or benefits are currently in place;

- (iv) what provisions exist for career progression from initial employment to promotion, including recognition of length of service; and
- (v) how her Ministry ensures that these positions offer a clear pathway for professional growth and retention.

"That this Honourable House resolves that Government establish and implement a Formal Documentation and Registration of all Immigrants including illegal or undocumented immigrants with a view to establish their number and their socio and economic impacts on local citizen and community resources and services."

"That this Honourable House requests Government to consider exempting registered non-operating businesses or shelf companies from filing fees or paying annual returns as well as to reduce filing fees for annual returns of operating business entities, restoration fees for businesses and companies deactivated and removed from the CIPA register."

ESTABLISHMENT OF A SPECIAL PARLIAMENTARY SELECT COMMITTEE TO INVESTIGATE THE GOVERNMENT PROCUREMENT OF BULLS AND HEIFERS AS WELL AS DAIRY GOATS

8. "That this Honourable House resolves to establish a Special Parliamentary Select Committee to investigate the Government procurement of bulls and heifers from Texas in the United States of America as well as heifers and dairy goats from Australia."

REINSTATEMENT OF CORPORAL PUNISHMENT IN SCHOOLS AS A REGULATED DISCIPLINARY MEASURE

9. "That this Honourable House requests Government to reinstate corporal punishment in schools as a regulated disciplinary measure to strengthen discipline, promote respect for authority, and create a safe and conducive learning environment."

**REVIEW OF THE PUBLIC PROCUREMENT ACT FRAMEWORK TO STRENGTHEN
AND INSTITUTIONALISE A HYBRID FORCE ACCOUNT MODEL FOR PUBLIC
INFRASTRUCTURE DELIVERY**

10. "That this Honourable House requests Government to review the Public Procurement Act and related regulatory frameworks with a view to strengthening and institutionalising a Hybrid Force Account Model for public infrastructure delivery, under which Government shall strategically utilise its existing internal engineering personnel, plant and equipment for the execution of routine road construction, rehabilitation, emergency works and maintenance; and further that the model shall prioritise the optimal use of existing State capacity in order to improve efficiency, reduce infrastructure delivery costs, enhance responsiveness to service delivery needs and contribute to fiscal consolidation, while reserving competitive tendering for highly specialised, complex and large-scale components of public infrastructure projects that require private sector expertise."

**REVIEW AND UPWARD ADJUSTMENT OF THE COMPENSATION RATES
FOR LOSS OF LIFE, INJURY, LIVESTOCK AND CROPS**

11. "That this Honourable House resolves that Government immediately reviews and upwardly adjust the compensation rates which no longer reflect the true market value for loss of life, injury, livestock and crops, for the purposes of aligning them, with current market prices and inflation in order to promote the coexistence between the people of Botswana and wildlife."

AMENDMENT OF THE PUBLIC HOLIDAYS ACT

12. "That this Honourable House requests Government to consider amending the Public Holidays Act so that it reads, "if a public holiday falls on a Saturday or Sunday, the Monday becomes a public holiday" as opposed to reading, "if the public holidays listed fall on a Sunday then the Monday shall be a public holiday" as it has now become common that if a holiday falls on a Saturday then the next Monday is declared a public holiday at short notice and this disrupts planning and is bad for business."

CREATION OF SPECIAL ECONOMIC ZONES IN THE GREATER GABORONE AREA

13. "That this Honourable House requests Government to expand the creation of special economic zones in the greater Gaborone area and other areas such as Molepolole to create an entrepreneurial ecosystem through supporting and developing small, medium enterprises to manufacture and market natural resources in their areas for export as finished products to create employment opportunities and ensure inter-generational skills transfer."

**ESTABLISHMENT OF A STATUTORY FUND FOR NATIONAL ECO-TOURISM
AND LOCAL ECONOMIC DEVELOPMENT (LED) FUND**

14. "That this Honourable House requests Government to urgently establish a dedicated, Ring Fenced Statutory Fund for National Eco-Tourism and Local Economic Development (LED) called the Eco-Tourism and Local Economic Development Fund to automatically finance community-led projects, heritage exhibitions and regional agri-tourism initiatives such as the Dinokeng Fish Festival thereby systematically shifting these vital rural economic engines away from a state of structural insecurity and unreliable, ad-hoc annual ministerial handout."

DECRIMINALISATION OF SEX WORK

15. "That this Honourable House resolves to request Government to decriminalise sex work by repealing section 155 (Living on the earnings of prostitution) and Section 156 (Keeping a brothel) of the Penal Code (Cap 08:01) in order to protect human rights, curb gender-based violence, and strengthen public health interventions."
