THEME: PRESIDENTIAL COMMISSION OF INQUIRY ON BCL CLOSURE

To ask the Minister of Minerals and Energy to state:

- (i) the criteria used to select the commissioners;
- (ii) how the commission will ensure transparency and independence in its investigations;
- (iii) the terms of reference, and whether those terms were subjected to any stakeholder input or expert review;
- (iv) how Government will guarantee operational independence of the commission from political influence, particularly given that it will investigate actions of former leaders;
- (v) the total budget allocated for the commission's operation; and
- (vi) arrangements that have been made to ensure witness protection and prevent intimidation or interference during testimony.

QUESTIONS

1. **MR. G. DISHO, MP. (OKAVANGO EAST):** To ask the Minister of Lands and Agriculture to state: (292)
 - (i) when Government intends to give back the underlisted concessions to the following community trusts and villages;
 - (a) NG 14 and 16 to Gudigwa community;
 - (b) NG 11 for Mogotho, Ngarange and Sekondomboro (Itekeng Community Trust); and

- (ii) whether the leases are still valid with other operators and to further state when they will expire and how long they have been holding on to these leases.
- 2. **MR. M. MOALOSI, MP. (NKANGE):** To ask the Minister of Lands and Agriculture if he is aware that karakul sheep were illegally imported into the country; and if so, to state: (187)
 - (i) where the sheep are currently located;
 - (ii) whether they were quarantined to ensure that they do not bring diseases into the country; and
 - (iii) whether any laws have been violated and what actions are being taken against the perpetrators.
- 3. **MR. O. KWAPA, MP. (JWANENG-MABUTSANE):** To ask the Minister of Trade and Entrepreneurship whether: (375)
 - (i) there was any consultation with Business Botswana regarding adjustments for trading hours for alcohol during the 2025 festive season;
 - (ii) this will happen annually in the years to come;
 - (iii) there has been an improvement in the country's economy during the 2025 festive season;
 - (iv) his Ministry is aware that the bars were given times which are specifically reserved for night clubs and to state the basis for such a decision; and
 - (v) he is aware that as a result, night clubs have suffered profit loss.
- 4. **MR. J. T. MODISE, MP. (KGALAGADI SOUTH):** To ask the Minister of Local Government and Traditional Affairs when the *Dikgotla* in the small villages such as Kolonkwaneng, Khawa, Struizendam and others will be upgraded to have Kgosi and Deputy Dikgosi positions as they have grown in population sizes. (376)
- 5. **MR. T. B. LUCAS, MP. (BOBIRWA):** To ask the Minister of Water and Human Settlement to apprise this Honourable House on the project that seeks to connect Thune Dam to the villages of Lepokole, Gobojango, Semolale, Mabolwe and Mothabaneng for water, clearly stating past challenges and future plans to actualise the project. (379)

6. **MR. M. M. PULE, MP. (KGATLENG EAST):** To ask the Minister for State President, Defence and Security to apprise this Honourable House on the current framework governing the benefits and entitlements accorded to former Presidents; and to further state: **(380)**

- (i) the specific benefits currently provided to former Presidents, including but not limited to financial allowances, security detail, housing, medical care, and staff support;
- (ii) whether the Ministry considers these benefits to be commensurate with the former Presidents' past service to the nation, or if they are deemed excessive or inadequate in light of the country's current economic realities;
- (iii) if the Ministry intends to undertake a review of the existing benefits package with a view to either reducing, maintaining, or increasing such benefits; and
- (iv) whether the Ministry intends to conduct any benchmarking exercise against other countries in the region to assess the appropriateness and sustainability of Botswana's benefits framework for former Heads of State.

7. **MR. D. SALESHANDO, MP. (MAUN NORTH):** To ask the Minister of Water and Human Settlement if he is aware that non-clearance/removal of aquatic river blockages in the lower Okavango river channels has affected water flow patterns, which adversely affects some communities whose livelihoods are anchored on economic activity along the river; if so, to state the total funds availed in the last five (5) financial years for this activity and how much will be availed in the next financial year. **(377)**

12. 13. "That this Honourable House resolves to introduce and adopt sign language as an official language in Botswana."

AMENDMENT OF BUSINESS REGULATIONS AND COMPLIANCE AT COMPANIES AND INTELLECTUAL PROPERTY AUTHORITY (CIPA)

14. "That this Honourable House requests Government to consider exempting registered non-operating businesses or shelf companies from filing fees or paying annual returns as well as to reduce filing fees for annual returns of operating business entities, restoration fees for businesses and companies deactivated and removed from the CIPA register."

GOVERNMENT TO REVIEW THE POLICY OF DISPOSSESSING LAND-HOLDERS

15. "That this Honourable House requests Government to review the policy of dispossessing land-holders to give way to village expansions, with a view to allowing the existence of small farms within towns and villages."

REVIEW AND UPWARD ADJUSTMENT OF THE COMPENSATION RATES FOR LOSS OF LIFE, INJURY, LIVESTOCK AND CROPS

16. "That this Honourable House resolves that Government immediately reviews and upwardly adjust the compensation rates which no longer reflect the true market value for loss of life, injury, livestock and crops, for the purposes of aligning them, with current market prices and inflation in order to promote the coexistence between the people of Botswana and wildlife."

CITIZEN ENTREPRENEURIAL DEVELOPMENT AGENCY (CEDA)
TO DISCONTINUE THE ISSUANCE OF LOANS

17. "That this Honourable House requests Government to discontinue the issuance of loans by the Citizen Entrepreneurial Development Agency (CEDA) and instead partner with commercial banks for all credit facilities by providing surety."

AMENDMENT OF THE PUBLIC HOLIDAYS ACT

18. "That this Honourable House requests Government to consider amending the Public Holidays Act so that it reads, "if a public holiday falls on a Saturday or Sunday, the Monday becomes a public holiday" as opposed to reading, "if the public holidays listed fall on a Sunday then the Monday shall be a public holiday" as it has now become common that if a holiday falls on a Saturday then the next Monday is declared a public holiday at short notice and this disrupts planning and is bad for business."

ESTABLISHMENT OF A SPECIAL FUND FOR GENDER BASED VIOLENCE (GBV)

19. "That this Honourable House requests Government to strengthen Botswana's commitment to gender equality and the protection of its citizens by establishing a Special Fund for Gender Based Violence (GBV) to provide immediate, targeted financial resources for prevention, survivor support and legal redress."
