THEME: DETAILS ON THE FORENSIC AUDIT

- To ask the Leader of the House to give details on progress made to date to undertake a forensic audit and further provide specifics on the following:
 - (i) the company that has been engaged to undertake the audit;
 - (ii) how the company was identified and if other equally qualified companies were given the opportunity to offer their services;
 - (iii) if the company was engaged through direct appointment, does he consider this sufficiently transparent and credible given the sensitivity of the matter as well as the amount involved;
 - (iv) if the company is a foreign company, will any aspects of the audit be undertaken by qualified Botswana forensic auditors;
 - (v) the total cost for the audit;
 - (vi) the scope and terms of reference for the audit;
 - (vii) when the audit exercise will be concluded; and
 - (viii) if the audit report will be made public.
